- 12Obtaining and Maintaining a Job allows students to perfect their written and oral communication skills and learn the professionalism needed to acquire and keep a job.
- ¹³Life Skills/Job Skills is designed to improve interpersonal skills, explore occupational options and build skills needed to obtain and maintain employment.
- ¹⁴Study Skills teaches useful study tips and techniques.
- ¹⁵Orientation provides an introduction to the LSRC program and focuses on goal development.
- ¹⁶Practical Math I examines practical, everyday uses of Mathematics, with each level concentrating on different concepts and skills.
- ¹⁷Practical Math II examines practical, everyday uses of Mathematics, with each level concentrating on different concepts and skills.
- 18Reading for Entertainment focuses on the entertainment value of reading various genres in print. Recreational reading is shown as a positive use of leisure time.
- ¹⁹Reading for information focuses on the informational value of reading various print. Informational reading is shown as a useful and productive tool.
- ²⁰Financial Literacy I, II, & III provides participants with the basics on financial practices and literacy. Topics such as goal setting, money management, insurance policies and consumer rights are coupled with projects that allow the participant to display real life investigation and insight into financial management. The participants use mathematical operations and skills to solve problems involving interest, investment, and sound financial planning.
- ²¹Rules of the Road is a refresher program and update of Illinois driving laws and regulations, and driver's license requirements. It covers the information one must know to pass the written test of traffic laws and signs. It includes information on driver's license, driver license laws, traffic safety issues and general information regarding Illinois traffic laws and ordinances.
- ²²Current Events instruction allows students to stay informed of current trends in various aspects of culture and foreign/domestic issues that affect all of the population they will soon return to.
- ²³Physical/Life Science is a remedial biology and Earth science course that serves as a supplement to GED Science and assists current students with more detailed background science knowledge.

 College Vocational completer is a student who has earned a certificate in the vocational course.
- ²⁴Civics course will review Constitutional premises, rights and responsibilities of law abiding citizens and give students a chance to personalize their understanding of these concepts.
- ²⁵PU.S. History emphasizes important conceptual information regarding different eras in our nation and examines the long term significance of important documents and events-supplements GED soc.
- ²⁶Intro. To Business introduces students to key concepts and vocabulary related to capital building and loan projects, finances, personnel, codes, insurance and other related corporate concepts.
- ²⁷American Literature allows students to analyze and interpret literature from various eras in American life and describe the impact the writers' works had and the influences of historical contexts
- ²⁸Program Completer is a student who completes or demonstrates mastery through previous coursework or life experience of the following mandatory courses: Orientation, Communications 1, Life Skills/Job Skills & Computers.
- ²⁹Participant numbers are cumulative totals of all offenders that spent time in the course.
- ³⁰Course completer is a student who demonstrates mastery of 75% or more of all skill, knowledge, and objectives presented in the course.
