On behalf of the Illinois Department of Central Management Services (CMS) and the Business Enterprise Program (BEP), I am pleased to present to you the Fiscal Year 2020 Annual Report for the Business Enterprise Program for Females, Minorities and Persons with Disabilities.

This report provides a diligent review of the accomplishments made by the Business Enterprise Program during Fiscal Year 2020, in addition to the performance of State agencies and institutions of higher education that are subject to the BEP Act (30 ILCS 575).

During Fiscal Year 2020, the State of Illinois spent \$723,913,024 in eligible contract dollars with BEP certified vendors. The 2020 spend is continuing the trend of growth experienced in recent years and is at a record contracting total since program creation.

The CMS BEP quickly made a pivot during the challenges presented with COVID-19. We quickly began virtual events and adjusted processes to ensure that businesses owned and operated by Women, Minorities and Persons with Disabilities still had an opportunity to participate in State procurement. While we value the growth seen in 2020, we are focused on making significant improvements through strategic outreach and capacity building initiatives. We will establish new partnerships and expand on existing relationships with the business community.

The Business Enterprise Program is poised to create amazing opportunities for disenfranchised and underrepresented businesses, as we ensure equitable processes and review compliance practices. We are motivated to increase intentional collaboration with agencies, stakeholders and partners, while executing a robust strategic plan. We value our significant role in nurturing an inclusive and equitable State.

Executive Summary

This report is submitted by the Department of Central Management Services (CMS) Business Enterprise Program for Minorities, Females, and Persons with Disabilities (BEP), and outlines the qualified State dollars spent with BEP certified vendors.

Created in 1984 pursuant to the Business Enterprise for Minorities, Females, and Persons with Disabilities Program Act (30 ILCS 5757), the BEP continues its efforts to increase procurement access and opportunities for disadvantaged entrepreneurs. Through engagement and collaboration with State Agencies and institutions of higher education, the BEP vendor community, and other stakeholders, the State of Illinois seeks to expand the Program's impact through increased participation in State contracting opportunities.

Fiscal & Program Accomplishments

The State delivered record results in Fiscal Year 2020 with \$723,913,024 of spending going to certified Business Enterprise Program vendors, a total that represents a 15 percent increase compared to the spend in Fiscal Year 2019.

The increase in spending with BEP vendors is not new for the program, this follows a 20-percent increase in Fiscal Year 2019. The spend is the highest seen by the Business Enterprise Program since it's inception. The 2020 spend also represents the largest number of BEP certified vendors involved in State contracts, with a total of 1,122 BEP vendors participating in the State's procurement process for Fiscal Year 2020.

CMS has revised several important policies, procedures, and procurement documentation protocols to further streamline the contracting and review process. Changes for Fiscal Year 2021 include a new goal setting methodology by using data selection that will positively impact goals and increase opportunity for BEP vendors. The new formula changes make contracting goals more representative of the overall vendor pool. The formula divides the number of BEP certified vendors registered under the relevant scopes of work by the overall number vendors registered under the relevant scopes of work, to determine the percentage of BEP vendor availability (BEP Vendors / All Vendors). In addition, the Bureau of Strategic Sourcing and BEP issued a "Buying Guide" that will forecast State contracting opportunities to help vendors plan and prepare for a bid.

Operational Accomplishments & COVID-19

The Business Enterprise Program team effectively adjusted to the challenges presented as a result of COVID-19. Working remotely, the Certification team altered their processes to ensure continued accuracy and to combat a delay for new BEP vendors. The BEP Outreach team planned virtual events and launched new digital communication efforts to actively promote the program and its benefits to qualified businesses around the state.

Compliance

The Compliance Division has provided a new goal setting manual and started trainings that explain the updated goal setting formula. The goal setting methodology for BEP has never been changed before and is expected to facilitate an increase in goals and opportunities for BEP vendors.

Outreach

The BEP Outreach Division hosted several virtual events in 2020 that connected businesses to resources that would, under normal circumstances be challenging to connect with. Events included introduction sessions to large corporate businesses that could assist BEP vendors with capacity building and exposure to other supplier diversity programs. Information was sent weekly to BEP vendors with details on upcoming events and program updates.

Certification

The Certification team at BEP launched a major initiative Fiscal Year 2020 with the FastTrack certification. The FastTrack certification recognizes certifications from both the City of Chicago and Cook County in compliance with Public Act 101-601 in an effort to expand opportunities for prospective State of Illinois (State) vendors. Since the launch of the FastTrack certification BEP has 698 new vendors and partners are being added every day which will result in a significantly larger vendor pool.

Outlook for Fiscal Year 2021

The Business Enterprise Program is aggressively moving towards growth in 2021 with new programming and processes for effective outreach. The new Outreach team will work closely with the Mentor Protégé Program as they connect with new partners and deliver resources and opportunity to BEP vendors. The Certification team will continue their work toward a larger vendor pool by identifying ways to infuse equity into certification processes.

The Business Enterprise Program is committed to providing quality programs and service with excellence. BEP is promoting economic advancement for Minorities, Women and Persons with Disabilities and values how significant our work is for the success of communities in the state of Illinois.
