On behalf of the Department of Central Management Services (CMS) and the Business Enterprise Council, we present you with the Business Enterprise Program for Women, Minorities, and Persons with Disabilities (BEP), Fiscal Year 2018 Annual Report. During Fiscal Year 2018, the State of Illinois spent \$607,504,306 in contract dollars with BEP-certified businesses. This is the highest spend with BEP-certified businesses since the program's inception.

While we are proud of this achievement, we realize that there is still work to be done. CMS is committed to increasing contracts awarded to BEP vendors, and further eliminating disparities in contracting with the State that still exist.

This report details the achievements and reforms of the Business Enterprise Program during Fiscal Year 2018, as well as the performance of state agencies and institutions of higher education that are subject to the BEP Act (30 ILCS 575).

CMS looks forward to working with other agencies, stakeholders and partners to implement the strategic goals detailed in this report. Together, we can continue to support businesses owned by minorities, women, and persons with disabilities, and ensure that these businesses are afforded a fair and equitable opportunity to do business with the State of Illinois.

## **BEP Annual Report FY2018 Executive Summary**

This report is submitted by the Department of Central Management Services (CMS) Business Enterprise Program for Minorities, Females, and Persons with Disabilities (BEP), and outlines the qualified State dollars spent with BEP certified vendors. It also provides an overview of the State's ongoing efforts to improve equity in State contracting as well as fair access to State contracting opportunities for businesses owned by members of the program's target communities.

Created in 1984 pursuant to the Business Enterprise for Minorities, Females, and Persons with Disabilities Program Act (30 ILCS 5757), the BEP continues its efforts to drive procurement access and opportunities for disadvantaged entrepreneurs. Through engagement and collaboration with State agencies and institutions of higher education, the BEP vendor community, and other stakeholders, the State of Illinois continues to push for new ways to expand the program's impact.

### **Fiscal and Legislative Accomplishments**

In fiscal year 2018 the BEP delivered record results with the State of Illinois spending \$607,504,306 with BEP certified vendors, the highest BEP spend ever since the program's inception, and a 23 percent increase over the spend in Fiscal Year 2017. Over half of all BEP certified vendors participated in State contracts, totaling over 3,200 contracts, in Fiscal Year 2018.

CMS also successfully proposed new administrative rules to govern the process of identifying and declaring Sheltered Markets which were approved and adopted by the Joint Committee on Administrative Rules. These new administrative rules provide greater clarity for how and when the BEP Council may choose to declare a Sheltered Market. Additionally, the new administrative rules facilitated the passage of the State's second Sheltered Market which was declared by the Business Enterprise Council in August of 2018.

The BEP also realized increased effectiveness thanks to Executive Order 2018-07, which:

- decreased the threshold for solicitations subject to the BEP from \$250,000 to \$100,000 and mandated that all solicitations subject to the BEP be submitted to the BEP for goal setting;
- required that agencies utilize the goal set by the BEP; and
- gave broad powers to the Director of CMS and the Secretary of the BEP Council to cancel contracts when prime contractors fail to meet the requirements of the BEP.

### **Operational Accomplishments**

To support the mandates of Executive Order 2018-07, the BEP Compliance Division did an effective job of managing the increase in goal setting submissions, providing additional training and guidance to State procurement professionals, participating in additional pre-bid conferences, and preparing for the launch of a new Compliance Monitoring System.

At the same time, the BEP Certification Division made process improvements that resulted in a decrease in median application processing time from 21 days to just six days.

Finally, the BEP Outreach Division developed a partnership with the Department of Commerce and Economic Opportunity that allowed BEP staff to participate in educational and outreach events throughout the State, significantly expanding the program's reach beyond the Chicagoland area to include multiple events in Central and Southern Illinois.

### **Outlook for Fiscal Year 2019**

The BEP is excited to continue expanding its program in fiscal year 2019. The Outreach Division has added an additional, bilingual staff member to enhance its ability to serve the program's target communities across the State and is developing a series of webinars that vendors may access for information about the program and the application process, twenty-four hours per day, seven days per week.

The Certification Division filled two personnel vacancies and continues to make strides in improving application processing time. In addition, we are scheduled to work with the BEP Certification Portal's optimization consultant to further streamline the online application process before the close of the fiscal year.

The Compliance Division launched a limited version of its Compliance Monitoring System in the first quarter of 2019 and expects to have the fully automated version operational before the close of the fiscal year. Once fully up and running, the Compliance Monitoring System will automatically update with newly-issued contracts containing BEP goals and will allow for near real-time monitoring of payments from the Illinois Office of the Comptroller to prime vendors, and from prime vendors to BEP-certified sub-contractors.

Lastly, the BEP expects to bring a new Mentor Protégé Program Coordinator onboard to launch the Mentor Protégé Program by the close of the fiscal year. The Mentor Protégé Program will allow continued relationship building and professional development that will benefit both prime contractors and BEP-certified sub-contractors by increasing BEP-certified vendors' capacity to perform on contracts. It will also increase opportunities for those sub-contractors to both serve as prime contractors themselves and to partner effectively with larger prime contractors.

The Business Enterprise Program looks forward to yet another successful fiscal year in 2019, with a redoubled focus on vendor engagement, process improvement, compliance optimization, and increased procurement opportunities.
