Offered by Representative West:

WHEREAS, Election judges and poll workers provide an invaluable function for our State and are one of this nation's most valuable resources; and

WHEREAS, Election judges and poll workers are truly the unsung heroes of our democracy; and

WHEREAS, Election judges and poll workers, with their training, dedication, and professionalism, play a vital role in ensuring safe, fair, and free elections; and

WHEREAS, Election judges and poll workers uphold election laws with integrity and accuracy, thereby maintaining public trust and confidence in elections; and

WHEREAS, Election judges and poll workers have met the challenges presented by a global pandemic during a presidential election, shifting expectations, and ever-evolving demands; and

WHEREAS, Tens of thousands of election judges and poll workers serve on Election Day to ensure that Illinois elections are conducted according to the principles of freedom and liberty upon which our nation and State were founded; and

WHEREAS, National Poll Worker Recruitment Day is a national day of action occurring in August and was established by the U.S. Election Assistance Commission to encourage people to help America vote by signing up to be a poll worker; this year, it will occur on August 1, 2024; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDRED THIRD GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we declare the week of August 1 through August 7, 2024 as Illinois Election Judge and Poll Worker Appreciation Week in the State of Illinois; and be it further

RESOLVED, That we express our appreciation and admiration for the election judges and poll workers of Illinois and the vital role they perform in our elections, our democracy, and our State.

## **HOUSE RESOLUTION 664**

Offered by Representative Davidsmeyer:

WHEREAS, A trisomy is a type of polysomy in which there are three instances of a particular chromosome, instead of the normal two; a trisomy is a type of aneuploidy, an abnormal number of chromosomes; and

WHEREAS, Most organisms have pairs of chromosomes in each cell, with one chromosome inherited from each parent; in such organisms, a process called meiosis creates cells called gametes that have only one set of chromosomes; and

WHEREAS, The number of chromosomes is different for different species; humans have 46 chromosomes, or 23 pairs of chromosomes, and human gametes have only 23 chromosomes; and

WHEREAS, If the chromosome pairs fail to separate properly during cell division, the egg or sperm may end up with a second copy of one of the chromosomes; if such a gamete results in fertilization and an embryo, the resulting embryo may also have an entire copy of the extra chromosome; and

WHEREAS, Full trisomy, also called primary trisomy, means that an entire extra chromosome has been copied; partial trisomy means that there is an extra copy of part of a chromosome; secondary trisomy means the extra chromosome has quadruplicated arms; tertiary trisomy means the extra chromosome is made up of copies of arms from two other chromosomes; and

WHEREAS, Trisomies can occur with any chromosome but often result in a miscarriage, rather than a live birth; and

WHEREAS, Trisomy 16 is the most common trisomy in human pregnancies, occurring in more than one percent of pregnancies; and

WHEREAS, Pregnancies in which some normal cells occur in addition to the trisomic cells, or mosaic trisomy 16, survive; this condition, however, usually results in a spontaneous miscarriage in the first trimester; and

WHEREAS, The most common types of autosomal trisomy that survive to birth in humans are Trisomy 21 (Down syndrome), Trisomy 18 (Edwards syndrome), Trisomy 13 (Patau syndrome), and Trisomy 8 (Warkany syndrome 2); therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDRED THIRD GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we declare the month of March 2024 as Trisomy Awareness Month in the State of Illinois, and we urge all citizens of this State to become aware of the different types of trisomy; and be it further

RESOLVED, That a suitable copy of this resolution be presented to SOFT (Support Organization For Trisomy) as a symbol of our respect and esteem.

## **HOUSE JOINT RESOLUTION 63**

Offered by Representative Mussman:

WHEREAS, Adoption has a lifelong impact on individuals and families; and

WHEREAS, There are more than 2 million adopted children in the United States and more than 60,000 adopted children living in Illinois; and

WHEREAS, Adopted children deserve support to thrive; and

WHEREAS, Illinois seeks to be a welcoming home for adopted children; and

WHEREAS, Children, including those who are adopted, spend much of their time at school and school-related events; and

WHEREAS, School mental health professionals, including school social workers, school counselors, and school psychologists, provide support to all students and may provide mental health care to students with identified need; and

WHEREAS, Being adopted approximately doubles the odds of having contact with a mental health professional; and

WHEREAS, Specialized training about the unique experiences of adopted children and families impacted by adoption enhances best practice mental health services in a school setting; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDRED THIRD GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE SENATE CONCURRING HEREIN, that we encourage all members of the General Assembly and their staff to learn more about and have a greater awareness of the issues impacting adopted children, including the impact adoption can have on one's mental health; and be it further

RESOLVED, That we encourage all employees of the State of Illinois, including but not limited to employees of the State Board of Education, the Department of Children and Family Services, the Department of Human Services, the Department of Juvenile Justice, and the Department of Healthcare and Family Services as well as employees of school districts and nonpublic schools, to learn more about and have a greater awareness of the issues impacting adopted children, including information about adoption-competent mental health services to help adopted children living in Illinois to thrive.
