Because what we have been doing is not working, and that's evidenced by the WalletHub study that's contained in that op-ed that shows Illinois is worst in the nation in economic racial equality. But there's one thing that we need to do before we leave Veto Session that we... that cannot wait, changing the sunset on the Invest in Kids Act. We still have time. We're about to go to our separate caucuses. You, as Democrats, are the Super Majority. You have control, as do your counterparts in the Senate. You get to determine whether or not we will pass some type of legislation that will remove this sunset. You already know you have Republican Members' full caucuses, both chambers willing to support legislation that removes the sunset. You control the House and the Senate. You determine what Bills get called. We have a Democrat Governor who said

Speaker Evans: "Heading to the Calendar. Under the Order of Amendatory Vetoes on page 2, we have House Bill 2878, Leader Hoffman. Leader Hoffman is recognized."

Hoffman: "Thank you, Mr. Speaker, Ladies and Gentlemen of the House. I move that we accept the Governor's Amendatory Veto to House Bill 2878. This underlying Bill has to deal with the issue of procurement. There were 19 Bills that were contained in the underlying Bill, which was contained in Senate Floor Amendment #2. We ultimately concurred to that Amendment. They included issues such as House Bill 2878 concerning giving preference for former coal mine employees preference. It talked about additional ideas regarding ensuring that Illinois bid preference is given to Illinois companies. It would award not-for-profit agencies, persons, and significant disabilities, would give them... that was a Costa Howard Bill, would give them preference. It provided for additional veterans' preference, which was Representative Rosenthal's Bill. It provide also Representative Smith's Reimagining Hotel Florence Act. Representative Tarver's request for waiver... concerning waiver of aspirational goals and tightening that up as well as public institutions of higher education. The only thing that the Governor took issue with was a sentence concerning the issue of private-public partnerships. And that sentence, I believe, was inadvertently added in which it would've allowed these private-public partnerships, not only for the tollway and IDOT, but also for county and municipal governments. The Governor indicated in his Amendatory Veto that he wished to remove local

governments. And if we remove them, he would be good with the Bill. I ask for a favorable roll call."

Speaker Evans: "Leader Windhorst is recognized."

Windhorst: "Thank you, Mr. Speaker. Will the Sponsor yield?"

Speaker Evans: "He indicates he will."

Windhorst: "Thank you. Leader, in our analysis, we have that Local 150 has been working with the Governor's Office to find P3 language that will be agreeable to all parties. Are you aware of what the status of those discussions are?"

Hoffman: "This... this would be... this would contain the status of those discussions."

Windhorst: "So, we should anticipate, on this issue, nothing further than what is in this Bill?"

Hoffman: "Yes."

Windhorst: "Our analysis also shows proponents and opponents on the original Bill. Did the Amendatory Veto affect the proponents and opponents to your knowledge?"

Hoffman: "The proponents still remain. I'm not sure about the opponents. However, it did address some of the concerns that they had with having the... the public-private partnerships on local governments as well as counties and townships and municipalities."

Windhorst: "And as you specified, the underlying Bill had many subparts. The Amendatory Veto affected just one of those. Is that accurate?"

Hoffman: "Yes. It was... it had... 19 Bills were contained in the omnibus Bill. They were both Republican and Democrat ideas. And the only issue that the Governor took issue with was the

issue of the private-public partnerships in local governments."

Windhorst: "And when it first passed the House, it was 107 to 5 on Concurrence. After the changes in the Senate, the vote was 77-9-1. Does that sound accurate to you?"

Hoffman: "Yes."

Windhorst: "All right. Thank you."

Speaker Evans: "Seeing no further discussion, Leader Hoffman to close."

Hoffman: "I would ask that we accept the Governor's Amendatory Veto. I think that is... it is... was well-intentioned, was well-placed, and it makes a better Bill."

Speaker Evans: "Leader Hoffman moves to accept the specific recommendation of the Governor to House Bill 2878. All those in favor vote 'aye'; all those opposed vote 'nay'. The voting is open. Have all voted who wish? Have all voted who wish? Have all voted who wish? Mr. Clerk, please take the record. On this question, there are 109 voting in 'favor', 4 voting 'against', and 0 voting 'present'. And this Motion, having received the Constitutional Majority, the specific recommendation of the Governor as to House Bill 2878 are accepted. Leader Mah is recognized for an announcement."

Mah: "Speaker, Democrats would request a caucus immediately in Room 114."
