**KENDALL COUNTY REPORT TO GENERAL ASSEMBLY REGARDING OVERHEARS  
CONDUCTED PURSUANT TO 720 ILCS 5/14-3(q) FOR MARCH 1<sup>ST</sup>, 2018 TO MARCH 1<sup>ST</sup>,  
2019.**

Pursuant to 720 ILCS 5/14-3(q), I, Eric Weis, Kendall County State's Attorney, report the following.

- (A) There have been one-hundred and sixty one (161) requests to my office for approval of a 24 hour overhear, pursuant to 720 ILCS 5/14-3(q), between March 1<sup>st</sup>, 2018 and March 1<sup>st</sup>, 2019. All of these requests were for the qualified offenses listed under 720 ILCS 5/14-3(q)(7)(A), which are violations of the Cannabis Control Act, the Illinois Controlled Substances Act, or the Methamphetamine Control and Community Act.
- (B) There have been one-hundred and sixty one (161) approvals by my office for law enforcement personnel to use the 24 hour overhear, pursuant to 720 ILCS 5/14-3(q), between March 1<sup>st</sup>, 2018 and March 1<sup>st</sup>, 2019. All of these approvals were for the qualified offenses listed under 720 ILCS 5/14-3(q)(7)(A), which are violations of the Cannabis Control Act, the Illinois Controlled Substances Act, or the Methamphetamine Control and Community Act.
