- Merit Commission, Secretary of State – appointed by the Secretary of State;
- Plumbing Examiners, Illinois State Board of, and Poison Prevention Packaging, Technical Advisory Committee on – appointed by the Director of the Department of Public Health;
- Veterinarian Licensing and Disciplinary Board – appointed by the Secretary of the Department of Financial and Professional Regulation.
