HOUSE RESOLUTION 603

Offered by Representative Haas:

WHEREAS, The federal government enacted the Inflation Reduction Act of 2022, which will make historic investments in clean energy manufacturing by providing \$369 billion in energy security and climate change programs to increase domestic manufacturing capacity for wind turbines, solar panels, batteries, electric vehicles, and other essential components of clean energy production and storage; and

WHEREAS, The State of Illinois has created law, including the Reimagining Electric Vehicles Act (REV) and the Invest in Illinois Act (Closing Fund), that is targeted towards investing State funds into clean energy manufacturing; and

WHEREAS, United States-based companies are currently at a competitive disadvantage when it comes to renewable energy manufacturing, with 10 of the world's largest electric battery makers being located outside of the United States, according to Automotive News; and

WHEREAS, The Committee on Foreign Investment in the United States (CFIUS) is an interagency committee authorized to review certain transactions involving foreign investment in the United States and certain real estate transactions by foreign persons, in order to determine the effect of such transactions on the national security of the United States; and

WHEREAS, CFIUS's jurisdiction over real estate transactions is limited to acquisitions or leases of sites near certain military installations and other sensitive government locations; and

WHEREAS, CFIUS also has the authority to scrutinize foreign investment transactions where a foreign person will gain or potentially gain control over, or make certain other types of investment in, a U.S. business; and

WHEREAS, CFIUS has found that recent land acquisitions by some foreign-based renewable energy manufacturers satisfied neither requirement that would prompt a review by the committee; and

WHEREAS, It is of the utmost importance that the U.S. protects its national security when dealing with companies based in foreign countries that actively undermine U.S. interests; and

WHEREAS, CFIUS should be empowered to thoroughly review transactions with foreign-based manufacturers to ensure that land acquisitions or other manufacturing incentives are not going to companies who pose a national security risk; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDRED THIRD GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we urge Congress to pass legislation and the President of the United States to sign into law a bill that would expand the jurisdiction of the Committee on Foreign Investment in the United States so that they review proposed land purchases and other incentives given to foreign-based companies to ensure that state and federal funds, as well public and private lands, are not awarded or sold to companies who pose national security risks; and be it further

RESOLVED, That suitable copies of this resolution be presented to the U.S. House Speaker Mike Johnson, U.S. House Minority Leader Hakeem Jeffries, U.S. Senate Majority Leader Chuck Schumer, U.S. Senate Minority Leader Mitch McConnell, and President Joe Biden.

HOUSE RESOLUTION 606

Offered by Representative Moeller:

WHEREAS, The future of our nation's productivity and competitiveness in the global marketplace depends on the success of all men and women; and

WHEREAS, Women have been discriminated against in education, the workplace, and society as a whole; and

WHEREAS, Equal Pay Day, representing all women, is celebrated this year on March 12; this date is based on U.S. Census figures showing that the average woman who works full-time is paid on average just 84% of the typical man's pay; started by the National Committee on Pay Equity (NCPE) in 1996, the goal of Equal Pay Day is to raise awareness about the gender wage gap; and

WHEREAS, In 2022, changes were made to the methodology, and The Equal Pay Day Calendar now encompasses a broader cross-section of women, including those who work part-time or seasonally, to represent a more accurate picture of how the gender pay gap impacts diverse communities; the COVID-19

pandemic pushed many women, especially women of color, into part-time or seasonal work or out of the workforce all together; because of this, past methods of calculating the wage gap fell short of accurately capturing the full picture; with the new inclusive methodology, we can advocate on behalf of all women in the workforce; and

WHEREAS, Because the pay gap varies significantly among different communities, other Equal Pay Days have been added to the calendar over the years to reflect the fact that many women must work far longer into the year to catch up to men; and

WHEREAS, LGBTQIA+ Equal Pay Awareness Day is June 15; this day raises awareness about the wage gap experienced by the LGBTQIA+ community; and

WHEREAS, Black Women's Equal Pay Day is July 27; Black women working full-time and year-round are paid 69 cents, and all earners (including part-time and seasonal) are paid 66 cents for every dollar paid to non-Hispanic white men; and

WHEREAS, Moms' Equal Pay Day is August 15; moms working full-time and year-round are paid 74 cents, and all earners (including part-time and seasonal) are paid 62 cents for every dollar paid to dads; and

WHEREAS, Latina's Equal Pay Day is October 5; Latina women working full-time and year-round are paid 57 cents, and all earners (including part-time and seasonal) are paid 52 cents for every dollar paid to non-Hispanic white men; and

WHEREAS, Native Women's Equal Pay Day is November 30; Native women working full-time and year-round are paid 59 cents, and all earners (including part-time and seasonal) are paid 55 cents for every dollar paid to non-Hispanic white men; and

WHEREAS, Asian American, Native Hawaiian and Pacific Islander Women's Equal Pay Day is also held each year on April 5; Asian American women working full-time and year-round are paid 99 cents, and all earners (including part-time and seasonal) are paid 89 cents for every dollar paid to non-Hispanic white men; Native Hawaiian and Pacific Islander women working full-time and year-round are paid 65 cents, and all earners (including part-time and seasonal) are paid 61 cents for ever dollar paid to non-Hispanic white men; and

WHEREAS, The pay gap has been shown to start as soon as one year after college; this inequality affects not only women but also their families and society as a whole; and

WHEREAS, The pay gap between women and men has long-term effects on women's economic security; such a gap affects women's Social Security earnings, their ability to save for retirement, and their children's education; and

WHEREAS, Pay equity is closely linked to the eradication of poverty and is essential to having a highly-motivated workforce; and

WHEREAS, Equal pay is a priority for all women and for our society at large; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDRED THIRD GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we declare March 12, 2024 as "Equal Pay Day" in the State of Illinois; and be it further

RESOLVED, That we encourage the citizens of this State to learn about the pay gap that women experience in society and to learn about these various dates that bring attention to the pay gap that specific groups experience.

HOUSE RESOLUTION 610

Offered by Representative Meier:

WHEREAS, The members of the Illinois House of Representatives wish to congratulate the publication FarmWeek on the occasion of its 50th anniversary; and

WHEREAS, FarmWeek was founded as a weekly service of the Illinois Farm Bureau at the bureau's home office in Bloomington on June 10, 1974, with the publication consequently being printed at P&P Press in Peoria each Friday for circulation the following Monday; and

WHEREAS, FarmWeek was created as a weekly publication designed to inform Illinois farmers and agricultural enthusiasts alike of the current issues and policies facing agriculture in Illinois and therefore to help readers make well-informed decisions in regards to their respective farms; and

WHEREAS, Covering commodity markets and weather reports, FarmWeek has continued to provide accurate and up-to-date information through an ever-changing information landscape by offering print as well as online services along with RFD Radio Network reports; and

WHEREAS, Agriculture has a special place in the Illinois economy, accounting for roughly \$51.1 billion annually and employing nearly 1 million workers while producing a wide range of products from food for consumption to biofuels; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDRED THIRD GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we declare June 10, 2024 as FarmWeek Appreciation Day in the State of Illinois; and be it further

RESOLVED, That we congratulate FarmWeek on its 50th anniversary, and we wish the publication continued success; and be it further

RESOLVED, That a suitable copy of this resolution be presented to the staff of FarmWeek as an expression of our esteem and respect.

HOUSE RESOLUTION 611

Offered by Representative Ozinga:

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDRED THIRD GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that the Rules of the House of Representatives of the 103rd General Assembly are amended by changing Rule 37 as follows:

(House Rule 37)

37. Bills.

(a) A bill may be introduced in the House by sponsorship of one or more members of the House, whose names shall be on the reproduced copies of the bills, in the House Journal, and in the Legislative Digest. The Principal Sponsor shall be the first name to appear on the bill and may be joined by no more than 4 chief co-sponsors with the approval of the Principal Sponsor; other co-sponsors shall be separated from the Principal Sponsor and any chief co-sponsors by a comma. The Principal Sponsor may change the sponsorship of a bill to that of one or more other Representatives, or to that of the standing committee or special committee to which the bill was referred or from which the bill was reported. Such change may be made at any time the bill is pending before the House or any of its committees by filing a notice with the Clerk, provided that the addition of any member as a Principal Sponsor, chief co-sponsor, or co-sponsor must be with that member's consent. When the Principal Sponsor ceases to be a Representative during the term, the chief sponsorship of any of his or her pending legislative measures may be changed to another Representative upon approval by the Speaker or Minority Leader, whichever served as the Representative's caucus leader. This subsection may not be suspended.

(b) The Principal Sponsor of a bill controls that bill. A committee-sponsored bill is controlled by the Chairperson, or if Co-Chairpersons have been appointed, by the Co-Chairperson from the majority caucus, who for purposes of these Rules is deemed the Principal Sponsor. Committee-sponsored bills may not have individual co-sponsors.

(c) The Senate sponsor of a bill originating in the Senate may request substitute House sponsorship of that bill by filing a notice with the Clerk. Such notice is automatically referred to the Rules Committee. The notice shall include the bill number, signature of the Senate sponsor, signature of the substitute House sponsor, and a statement that the original House sponsor was provided with notice of intent to request a substitute House sponsor. A notice that satisfies the requirements of this subsection shall be approved by the Rules Committee. If the Rules Committee does not act on a notice that satisfies the requirements of this subsection within 3 legislative days after its referral, then the notice is deemed approved and the Clerk shall substitute sponsorship. This subsection shall be in effect if, and only for so long as, the Rules of the Senate include a reciprocal privilege for House sponsors and the Senate complies with the rule. This subsection may not be suspended.

(d) All bills introduced in the House shall be read by title a first time and automatically referred to the Rules Committee in accordance with Rule 18. After a Senate Bill is received and a House member has submitted notification to the Clerk of sponsorship of that bill, it shall be read by title and automatically referred to the Rules Committee in accordance with Rule 18.

(e) All bills introduced into the House shall be accompanied by 1 copy. Any bill that amends a statute shall indicate the particular changes in the following manner:

(1) All new matter shall be underscored.

(2) All matter that is to be omitted or superseded shall be shown crossed with a line.

(f) No bill shall be passed by the House except on a record vote of a majority of those elected, subject to Rule 69. A bill that has lost on Third Reading and has not been reconsidered may not thereafter be revived. If a motion for the adoption of a first conference committee report fails and the motion is not reconsidered, then a second conference committee may be appointed as provided in Rule 76(c). If a motion for the adoption of a second conference committee report fails and is not reconsidered, then the bill may not thereafter be revived.

(g) Notwithstanding any other provision of these Rules, no member of the House, other than the Speaker or the Minority Leader, may introduce in the House more than 5 bills during the period from the second Wednesday of January in any year to the second Wednesday in January of the following year. This subsection (g) may not be suspended.

HOUSE RESOLUTION 613

Offered by Representative Lilly:

WHEREAS, Adult vaccines reduce the burden of widespread disease and enable individuals to live longer, healthier, and more productive lives; and

WHEREAS, Despite vaccine recommendations made by the United States Centers for Disease Control and Prevention (CDC) and the Advisory Committee on Immunization Practices (ACIP), many adults do not receive all recommended vaccines; and

WHEREAS, Vaccine-preventable diseases cause long-term illness, hospitalization, and death; the CDC estimates that, since 2010, influenza-related hospitalizations in the U.S. have ranged from 140,000 to 710,000 and influenza-related deaths have ranged from 12,000 to 56,000; further, roughly 150,000 people are hospitalized with pneumococcal pneumonia, and 5 to 7% of those individuals die each year; for individuals 65 years of age and older, respiratory syncytial virus (RSV) can lead to as many as 160,000 hospitalizations and 10,000 deaths in the U.S. each year; an estimated 880,000 to 1.89 million people in the U.S. have chronic hepatitis B, which can cause serious health problems, including liver damage, cirrhosis, liver cancer, and death; finally, human papillomavirus (HPV) causes over 37,000 cancers in women and men each year, and approximately 4,000 women die each year from cervical cancer; and

WHEREAS, The U.S. annually spends more than \$21 billion treating adults 50 years of age and older for influenza and pneumococcal disease, both of which are vaccine-preventable; and

WHEREAS, Influenza, like many vaccine-preventable diseases, also contributes to workplace productivity loss; a typical, full-time employee may lose up to 3.5 workdays due to absenteeism and presenteeism from an influenza infection; and

WHEREAS, Despite the burden and consequences of vaccine-preventable diseases, adult vaccination rates remain low in the U.S. and far below national targets; in 2021, pneumococcal vaccine coverage among adults 65 years of age and older was 65.8%; similar trends were seen with hepatitis B vaccination coverage, with only 34.2% of adults 19 years of age and older receiving a hepatitis B vaccine; and

WHEREAS, As a result of low vaccination rates, adults experience higher rates of morbidity and mortality from vaccine-preventable diseases; and

WHEREAS, Furthermore, racial and ethnic minority populations report consistently lower rates of immunization than white individuals; for example, in the U.S., the shingles vaccination rate was 35.5% among non-Hispanic white adults and 19.9% among non-Hispanic Black/African American adults; additionally, less than 43% of Black/African American, Hispanic, and American Indian/Alaska Native adults received an influenza vaccine for the 2021-2022 season compared to 54% of white adults; this is attributable in part to decreased vaccine awareness and suboptimal knowledge of vaccination schedules; and

WHEREAS, Reported adult vaccination rates are often lower in rural communities than in urban settings; for example, the CDC reports rural counties had first-dose COVID-19 vaccination coverage of 58.5% compared to 75.4% in urban counties between December 2020 and January 2022; and

WHEREAS, Providing targeted education and awareness of adult vaccinations among racial and ethnic minority populations in the State through evidence-based strategies can increase uptake; and

WHEREAS, Supporting access to vaccines is a necessary public health tool that will protect individuals from vaccine-preventable diseases; and

WHEREAS, Provisions of the federal Inflation Reduction Act expanded access to vaccine coverage without cost-sharing; the law removed cost-sharing for vaccines covered under Medicare Part D in January 2023 and mandated coverage for all ACIP-recommended vaccines administered to adults covered by traditional Medicaid in October 2023; and

WHEREAS, Developing a state immunization strategy focused on adults may assist in reducing the impact of disruptions to adult routine vaccines, decreasing preventable healthcare utilization and burden, reducing absenteeism due to illness, and helping protect populations from vaccine-preventable diseases; therefore, be it

WHEREAS, SFC Katsoolias went missing at some point during the withdrawal to Kujang; he was never reported as a prisoner of war, and his remains have not been recovered; and

WHEREAS, SFC Katsoolias is memorialized on the Courts of the Missing at the National Memorial Cemetery of the Pacific; therefore, be it
