**HOUSE JOINT RESOLUTIONS
CONSTITUTIONAL AMENDMENTS
FIRST READING**

Representative Boland introduced the following:

**HOUSE JOINT RESOLUTION
CONSTITUTIONAL AMENDMENT 18**

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-THIRD GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE SENATE CONCURRING HEREIN, that there shall be submitted to the electors of the State for adoption or rejection at the general election next occurring at least 6 months after the adoption of this resolution a proposition to add Section 25 to Article I of the Illinois Constitution as follows:

ARTICLE I
BILL OF RIGHTS

SECTION 25. UNIVERSAL HEALTH CARE COVERAGE

Health care is an essential safeguard of human life and dignity, and there is an obligation for the State of Illinois to ensure that every person is able to realize this fundamental right. On or before May 31, 2006, the General Assembly by law shall enact a plan for universal health care coverage that permits everyone in Illinois to obtain decent health care on a regular basis.

SCHEDULE

This Constitutional Amendment takes effect upon being declared adopted in accordance with Section 7 of the Illinois Constitutional Amendment Act.

The foregoing HOUSE JOINT RESOLUTION CONSTITUTIONAL AMENDMENT 18 was taken up, read in full a first time, ordered printed and placed in the Committee on Rules.

Representative Boland introduced the following:

**HOUSE JOINT RESOLUTION
CONSTITUTIONAL AMENDMENT 19**

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-THIRD GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE SENATE CONCURRING HEREIN, that there shall be submitted to the electors of the State for adoption or rejection at the general election next occurring at least 6 months after the adoption of this resolution a proposition to amend Section 3 of Article VII of the Illinois Constitution as follows:

ARTICLE VII
LOCAL GOVERNMENT

(ILCON Art. VII, Sec. 3)

SECTION 3. COUNTY BOARDS

(a) A county board shall be elected in each county. The number of members of the county board shall be fixed by county-wide referendum or ordinance in each county within limitations provided by law.

(b) The General Assembly by law shall provide methods available to all counties for the election of county board members. No county, other than Cook County, may change its method of electing board members except as approved by county-wide referendum.

(c) Members of the Cook County Board shall be elected from two districts, Chicago and that part of Cook County outside Chicago, unless (1) a different method of election is approved by a majority of votes cast in each of the two districts in a county-wide referendum or (2) the Cook County Board by ordinance

divides the county into single member districts from which members of the County Board resident in each district are elected. If a different method of election is adopted pursuant to option (1) the method of election may thereafter be altered only pursuant to option (2) or by county-wide referendum. A different method of election may be adopted pursuant to option (2) only once and the method of election may thereafter be altered only by county-wide referendum. (Source: Illinois Constitution.)

Representative Hultgren introduced the following:

**HOUSE JOINT RESOLUTION
CONSTITUTIONAL AMENDMENT 20**

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-THIRD GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE SENATE CONCURRING HEREIN, that there shall be submitted to the electors of the State for adoption or rejection at the general election next occurring at least 6 months after the adoption of this resolution a proposition to add Section 11 of Article IX to the Illinois Constitution as follows:

ARTICLE IX
REVENUE

SECTION 11. TAXPAYER'S BILL OF RIGHTS

(a) General provisions. The preferred interpretation of this Section shall reasonably restrain most of the growth of government. All provisions are self-executing and severable and supersede conflicting State Constitutional, State statutory, or other State or local provisions. Other limits on taxing district revenue, spending, and debt may be weakened only by future voter approval.

Individual or class action enforcement suits may be filed and shall have the highest civil priority of resolution. Successful plaintiffs are allowed costs and reasonable attorney fees, but a taxing district is not unless a suit against it is ruled frivolous. Revenue collected, kept, or spent illegally beginning 4 full fiscal years before a suit is filed shall be refunded with 10% annual simple interest from the initial conduct. Subject to judicial review, taxing districts may use any reasonable method for refunds under this Section, including temporary tax credits or rate reductions. Refunds need not be proportional when prior payments are impractical to identify or return. When annual taxing district revenue is less than annual payments on general obligation bonds, pensions, and final court judgments, subdivision (d)(1) and subsection (g) shall be suspended to provide for the deficiency.

(b) Definitions. As used in this Section:

"Emergency" excludes economic conditions, revenue shortfalls, or taxing district salary or fringe benefit increases.

"Fiscal year spending" means all taxing district expenditures and reserve increases except, as to both, those for refunds made in the current or next fiscal year or those from gifts, federal funds, collections for another government, pension contributions by employees and pension fund earnings, reserve transfers or expenditures, damage awards, or property sales.

"Inflation" means the percentage change in the United States Bureau of Labor Statistics Consumer Price Index for all items, all urban consumers, or its successor index.

"Local growth" for a non-school district means a net percentage change in actual value of all real property in a taxing district from construction of taxable real property improvements, minus destruction of similar improvements, and additions to, minus deletions from, taxable real property. For a school district, "local growth" means the percentage change in its student enrollment.

"Public question" means any question, proposition, or measure submitted to the voters at an election dealing with subject matter other than the nomination or election of candidates and shall include, but is not limited to, any bond or tax referendum, and questions relating to the Constitution.

"Taxing district" means the State or any unit of local government.

"Unit of local government" means a county, municipality, township, special district, school district, and a unit designated as a unit of local government by law, which exercises limited governmental power or powers in respect to limited governmental subjects.

(c) Election provisions.

(1) Public questions shall be decided at the general election, general primary election, consolidated election, or consolidated primary election. Except for petitions, bonded debt, or constitutional provisions, taxing districts may consolidate public questions and voters may approve a delay of up to 4 years in voting on public questions. Taxing district actions taken during the delay shall not extend beyond that period.

(2) At least 30 days before a public question election, taxing districts shall mail at the least cost, and as a package where taxing districts with public questions overlap, a titled notice or set of notices addressed to "All Registered Voters" at each address of one or more active registered electors. Titles shall have this order of preference: "NOTICE OF ELECTION TO INCREASE TAXES/TO INCREASE DEBT/ON A PETITION/ON A RESOLUTION OR ORDINANCE." Except for taxing district voter-approved additions, notices shall include only:

(A) The election date, hours, ballot title, text, and local election office address and telephone number.

(B) For proposed taxing district tax or bonded debt increases, the estimated or actual total of taxing district fiscal year spending for the current year and each of the past 4 years, and the overall percentage and dollar change.

(C) For the first full fiscal year of each proposed taxing district tax increase, taxing district estimates of the maximum dollar amount of each increase and of taxing district fiscal year spending without the increase.

(D) For proposed taxing district bonded debt, its principal amount and maximum annual and total taxing district repayment cost, and the principal balance of total current taxing district bonded debt and its maximum annual and remaining total taxing district repayment cost.

(E) Two summaries, up to 500 words each, one for and one against the proposal, of written comments filed with the election officer on or before 45 days before the election. No summary shall mention names of persons or private groups, nor any endorsements of or resolutions against the proposal. Petition representatives following these rules shall write this summary for their petition. The election authority shall maintain and accurately summarize all other relevant written comments.

(3) Except by later voter approval, if a tax increase or fiscal year spending exceeds any estimate in subdivision (c)(2)(C) for the same fiscal year, the tax increase is thereafter reduced up to 100% in proportion to the combined dollar excess, and the combined excess revenue refunded in the next fiscal year. Taxing district bonded debt shall not issue on terms that could exceed its share of its maximum repayment costs in subdivision (c)(2)(D). Ballot titles for tax or bonded debt increases shall begin, "SHALL (TAXING DISTRICT) TAXES BE INCREASED (first, or if phased in, final, full fiscal year dollar increase) ANNUALLY...?" or "SHALL (TAXING DISTRICT) DEBT BE INCREASED (principal amount), WITH A REPAYMENT COST OF (maximum total taxing district cost), ...?"

(d) Required elections. Starting at the consolidated primary election in 2005, taxing districts must have voter approval in advance for:

(1) Unless subsection (a) or (f) applies, a new tax, a tax rate increase, a levy increase above that for the prior year, an equalized assessed value ratio increase for a property class, the extension of an expiring tax, or a tax policy change directly causing a net tax revenue gain to any taxing district.

(2) Except for refinancing taxing district bonded debt at a lower interest rate or adding new employees to existing taxing district pension plans, creation of any multiple-fiscal year direct or indirect taxing district debt or other financial obligation whatsoever without adequate present cash reserves pledged irrevocably and held for payments in all future fiscal years.

(e) Emergency reserves. To use for declared emergencies only, each taxing district shall reserve for 2005 1% or more, for 2006 2% or more, and for all later years 3% or more of its fiscal year spending excluding bonded debt service. Unused reserves apply to the next year's reserve.

(f) Emergency taxes. This subsection (f) grants no new taxing power. Emergency property taxes are prohibited. Emergency tax revenue is excluded for purposes of subsections (c)(3) and (g), even if later ratified by voters. Emergency taxes shall also meet all of the following conditions:

(1) A two-thirds majority of the members of each house of the General Assembly or of a local taxing district's governing authority declares the emergency and imposes the tax by separate recorded roll call votes.

(2) Emergency tax revenue shall be spent only after emergency reserves are depleted, and shall be refunded within 180 days after the emergency ends if not spent on the emergency.

(3) A tax not approved on the next election date 60 days or more after the declaration shall end with that election month.

(g) Spending limits.

(1) The maximum annual percentage change in State fiscal year spending equals inflation plus the percentage change in State population in the prior calendar year, adjusted for revenue changes approved by voters after 2003. Population shall be determined by annual federal census estimates and the number shall be adjusted every decade to match the federal census.

(2) The maximum annual percentage change in each local taxing district's fiscal year spending equals inflation in the prior calendar year plus annual local growth, adjusted for revenue changes approved by voters after 2003 and subdivision (h)(2) and subsection (i) reductions.

(3) The maximum annual percentage change in each taxing district's property tax revenue equals inflation in the prior calendar year plus annual local growth, adjusted for property tax revenue changes approved by voters after 2003 and subdivision (h)(2) and subsection (i) reductions.

(4) If revenue from sources not excluded from fiscal year spending exceeds these limits in dollars for that fiscal year, the excess shall be refunded in the next fiscal year unless voters approve a revenue change as an offset. Initial taxing district bases are current fiscal year spending and 2003 property tax collected in 2004. Future creation of taxing district bonded debt shall increase, and retiring or refinancing taxing district bonded debt shall lower, fiscal year spending and property tax revenue by the annual debt service so funded. Debt service changes, reductions, refunds under subsection (a) or subdivision (c)(3), and voter-approved revenue changes are dollar amounts that are exceptions to, and not part of, any taxing district base. Voter-approved revenue changes do not require a tax rate change.

(h) Revenue limits.

(1) New or increased transfer tax rates on real property are prohibited. No new State real property tax or local taxing district income tax shall be imposed. Neither an income tax rate increase nor a new State definition of taxable income shall apply before the next tax year. Any income tax law change after July 1, 2004 shall also require all taxable net income to be taxed at one rate, excluding refund tax credits or voter-approved tax credits, with no added tax or surcharge.

(2) Regardless of reassessment frequency, valuation notices shall be mailed annually and may be appealed annually, with no presumption in favor of any pending valuation. Past or future sales by a lender or government shall also be considered as comparable market sales and their sales prices kept as public records. Actual value shall be stated on all property tax bills and valuation notices and, for residential real property, determined solely by the market approach to appraisal.

(i) State mandates. Except for public education through grade 12 or as required of a local taxing district by federal law, a local taxing district may reduce or end its subsidy to any program delegated to it by the General Assembly for administration. For current programs, the State may require 90 days' notice and that the adjustment occur in a maximum of 3 equal annual installments.

SCHEDULE

This Constitutional Amendment takes effect upon being declared adopted in accordance with Section 7 of the Illinois Constitutional Amendment Act.

RESOLUTIONS

The following resolutions were offered and placed in the Committee on Rules.

HOUSE RESOLUTION 85

Offered by Representative Soto:

WHEREAS, Cinco de Mayo is a date of great importance for the Mexican and Chicano communities in the United States; and

WHEREAS, In 1862, the French army, led by Napoleon III, began its advance into Mexico to claim

territory leading to a ferocious battle known as the "Batalla de Puebla"; the French army met resistance from 5,000 ill-equipped Mestizo and Zapotec Indians under the command of General Ignacio Zaragoza; the battle, which occurred on May 5, marks the victory of the Mexican Army over the French, who were forced to retreat; and

WHEREAS, Although the Mexican army was eventually defeated, the "Batalla de Puebla" now represents a symbol of Mexican unity and patriotism; and

WHEREAS, As a result of this victory, Mexico demonstrated to the world that Mexico and Latin America are willing to defend themselves of any foreign intervention, especially those from imperialist states; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-THIRD GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we recognize "Cinco de Mayo", and join with those who celebrate May 5 as a day of remembrance for all the patriots of Mexico and Latin America who fought for independence from France in 1862.

HOUSE RESOLUTION 87

Offered by Representative Churchill:

WHEREAS, The Federal Aviation Administration Great Lakes Region will participate in Aviation Maintenance Technician Day, an event honoring aviation maintenance technicians from all around the world; and

WHEREAS, This event will advance public appreciation for the significant and vital contributions of aviation maintenance technicians; and

WHEREAS, Aviation maintenance technicians are all too often unsung heroes whose achievements are overlooked; and

WHEREAS, One such unsung hero of aviation was Mr. Charles Edward Taylor; and

WHEREAS, On April 30, 1903, at the Wright Brother's Bicycle Shop in Dayton Ohio, Charles Edward Taylor began working on the first engine built for Orville and Wilbur Wright's airplane named The Flyer; and

WHEREAS, This incredible achievement would not have been possible if it were not for Charles Edward Taylor, the first aviation mechanic in powered flight, the man who built and maintained the first aircraft engines; and

WHEREAS, The Federal Aviation Administration Great Lakes Region is working to bring attention to the significance of Charles Edward Taylor's achievements, and to the contributions of the aviation maintenance industry, by recognizing May 24th, Mr. Taylor's birthday, as Aviation Maintenance Technician Day; therefore, be it

RESOLVED BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-THIRD GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we hereby proclaim May 24 as Aviation Maintenance Technician Day in the State of Illinois; and be it further

RESOLVED, That a suitable copy of this resolution be presented to Cecelia L. Hunziker, Regional Administrator for the Great Lakes Region of the Federal Aviation Administration.

HOUSE RESOLUTION 91

Offered by Representative Aguilar:

WHEREAS, The increasing integration of the global economy ensures that the growth in the production of goods and services in any location within the United States benefits the American economy as a whole; and

RESOLVED, That a copy of this resolution be presented to each member of the Illinois congressional delegation.

HOUSE RESOLUTION 92

Offered by Representative McGuire:

WHEREAS, The right to a healthy life is one of the most basic of all rights; and

WHEREAS, One million five hundred thousand Illinoisians are over the age of 65 years; Medicare alone is unable to support the health care needs of such a large population; many seniors have fixed incomes and cannot afford rising health care costs, including the costs of prescription medications and other treatments that are not covered by Medicare; and

WHEREAS, Five million eight hundred thousand people in the United States are in long-term care; long-term care costs approximately \$50,000 per year per patient, and thus seniors in long-term care are often forced to impoverish themselves, losing not only their assets, but also lifetimes of memories; in addition, many seniors are forced to leave their homes prematurely and enter long-term care facilities because they are denied home health care services; and

WHEREAS, Seniors with diminished mental and physical capacities are targets for financial, physical, and emotional elder abuse that negatively affects their health; and

WHEREAS, Seniors are often treated by different doctors who do not know the medical histories of their patients, thus further reducing the continuity and resulting quality of care for seniors; and

WHEREAS, Seniors are presented with a confusing maze of health care laws and regulations, both federal and state, thus making it difficult for them to have access to accurate information relating to their coverage and rights; and

WHEREAS, Many seniors are, therefore, currently not receiving the quality of health care that they deserve as a basic right; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-THIRD GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that it is the goal of the House of Representatives that every senior in Illinois receive the best possible health care and that, in order to achieve this goal, the House of Representatives finds and declares that seniors ought to have all of the following rights with regard to health care: (1) Every senior should be entitled to access affordable, high-quality, and expedient health care, including prescription medication, hospitalization, mental health care, orthotics, dental care, vision care, gender-specific medical care, and long-term care; (2) Every senior should be entitled to continuity with respect to his or her health care; (3) Every senior should be entitled to safe and clean environments in assisted living and long-term health care facilities; (4) Every senior should be entitled to access to home health care. (5) Every senior should be entitled to accessible and legible information about health care and accompanying rights; (6) Every senior should be entitled to information and easy access to a knowledgeable advocate who is capable of assisting seniors who are disabled by illness; and (7) Every senior should be entitled to protection from financial, emotional, and physical elder abuse.

HOUSE RESOLUTION 93

HOUSE JOINT RESOLUTION 17

RESOLVED, That each of the following elected officials appoint to the Task Force 2 members who are elected members of the House of Representatives or the Senate: the Speaker of the House, the Minority Leader of the House, the President of the Senate, and the Minority Leader of the Senate; and be it further

RESOLVED, That the appointed members of the Task Force shall appoint 2 chairpersons, who shall be appointed members of the Task Force; and be it further

RESOLVED, That meetings of the Task Force be convened at the call of either of the 2 chairpersons; and be it further

RESOLVED, That a quorum of the Task Force shall consist of a simple majority of the members of the Task Force and that all actions and recommendations of the committee be approved by a simple majority of the members of the Task Force; and be it further

RESOLVED, That members appointed to the Task Force shall only be compensated for costs that arise out of their official duties with the Task Force and that compensation shall come from the appropriate fund; and be it further

RESOLVED, That the General Assembly and the Task Force shall request and will be thankful for the cooperation of the Governor and all State agencies involved in the implementation and administration of the Illinois Resource Development and Energy Security Act; and be it further

RESOLVED, That a suitable copy of this resolution be delivered to the Governor.

HOUSE JOINT RESOLUTION 18

and first performed as an actor; and

WHEREAS, Ronald Reagan graduated from Eureka College in 1932 with a degree in economics and sociology; and

WHEREAS, From humble beginnings, Ronald Reagan went on to become a sportscaster, actor, Governor of California, and President of the United States; and

WHEREAS, Ronald Reagan was elected President of the United States in 1980; a favorite of the American populace, he was elected to a second term in 1984; and

WHEREAS, Ronald Wilson Reagan, the 40th President of the United States, warrants a public tribute as a son of Illinois; and

WHEREAS, In 1999, portions of Illinois Route 172 and 92 from Tampico to Illinois Route 26 and the portions of Illinois Route 26, Illinois Route 29, and U.S. Route 24 from Dixon to Eureka were designated as the Ronald Reagan Trail by Senate Joint Resolution 3; and

WHEREAS, The cities of Princeton, Galesburg, and Monmouth were essential in the upbringing of Ronald Reagan and should be included in the Ronald Reagan Trail; and

WHEREAS, The members of the House were saddened to learn of the death of Mayor Ken Hayes of Bradley; and

WHEREAS, He was elected mayor in 1981 and was re-elected in 1985, 1989, 1993, and 1997; and

WHEREAS, He was born in Limestone Township on August 30, 1924, the son of Patrick and Catherine Hayes; the family moved to Bradley when he was three months old, and until his death he lived in the house that his father bought; and

WHEREAS, He attended St. Joseph's Grammar School and Bradley-Bourbonnais Community High School; he served in the United States Army's 83rd Division, 331st Infantry, Company L during World War II; he won the Silver Star, the Bronze Star with clusters for meritorious service, a Good Conduct medal, the European Theatre of Operations medal for five campaigns, and the Croix de Guerre for service to France; and

WHEREAS, When he returned from war, Ken Hayes became a precinct captain and then a committeeman; he was elected vice-chairman of the Democratic Central Committee in Kankakee County in 1966 and served in that role until 1972, when he was elected central committee chairman; and

WHEREAS, When he arrived home from the Army, he worked in the pipefitter's union local until he had a heart attack in 1963, which led him to quit his trade; he went to work inspecting seed for the Illinois Department of Agriculture and later worked for then Secretary of State Alan Dixon; and

WHEREAS, He went to work for the Illinois Secretary of State and retired with a disability pension after a heart bypass operation in 1978; and

WHEREAS, He was the founder of the Area Jobs Development Association, active in scouting, golfing, the Bradley Lions, and a life member of the Bradley VFW; and

WHEREAS, Under Mayor Hayes' strong leadership, the Village of Bradley experienced unprecedented commercial and retail growth amounting to large increases in sales tax revenue to Bradley; and

WHEREAS, He was a member of the Loyal Order of the Moose Lodge of Bradley, one of the vice presidents of the Illinois Municipal League, and a member of the Mayors Association; and

WHEREAS, Much of the commercial growth and development that Kenneth P. Hayes worked for occurred along Illinois Route 50; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-THIRD GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE SENATE CONCURRING HEREIN, that the Ronald Reagan Trail is extended to include those portions of U.S. Route 34 from the City of Princeton, through the City of Galesburg, to the City of Monmouth; and be it further

RESOLVED, That the Illinois Department of Transportation, in accordance with applicable State and federal laws and rules and in cooperation with units of local government, be requested to erect appropriate signs, markers, or plaques along the extended portions of the Ronald Reagan Trail in recognition of this designation; and be it further

RESOLVED, That Illinois Route 50 in Bradley, Illinois, from North Street to Larry Power Road, is designated as the Kenneth P. Hayes Memorial Highway; and be it further

HOUSE JOINT RESOLUTION 20

Offered by Representative Bellock:

WHEREAS, The prospective invasion of bighead carp and silver carp has been identified as a major threat to the Great Lakes ecosystem; and

WHEREAS, Bighead carp and silver carp were spotted in the summer of 2002 within 55 miles of Lake Michigan in the Chicago Sanitary and Ship Canal, which connects to the Mississippi River and the Great Lakes systems; and

WHEREAS, It is imperative that aggressive action be taken to safeguard the ecological and economic integrity of the Great Lakes from this threat; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-THIRD GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE SENATE CONCURRING HEREIN, that the members of the Illinois General Assembly acknowledge the significance of the ecological and economic damage associated with the prospective invasion and spread of bighead and silver carp; and be it further

RESOLVED, That the Illinois General Assembly urges the United States Department of the Interior, U.S. Fish and Wildlife Service, to add bighead carp and silver carp to the list of injurious wildlife under the Lacey Act, thereby prohibiting the importation and interstate transportation of live specimens or viable eggs of these two species; and be it further

RESOLVED, That copies of this resolution be delivered to Gale Norton, United States Secretary of the Interior, and to each member of the Illinois congressional delegation.

HOUSE JOINT RESOLUTION 21

Offered by Representative Osterman:

WHEREAS, Illinois has always been a State that has received and benefited from a large, diverse immigrant population; and

WHEREAS, That population now represents close to 13% of Illinois' total population, and families with an immigrant member now represent some 20% of the State's population; and

WHEREAS, Illinois has been a national leader in immigrant and refugee integration efforts, and has offered support for citizenship, healthcare, outreach, and interpretation through the Immigrant Services Line Item; and

WHEREAS, Immigrants are moving to new communities across the State, with 60% of the State's immigrants living outside the City of Chicago; and

WHEREAS, Immigrants play a vital role in many sectors of our economy, including agriculture, education, hotels and restaurants, tourism, manufacturing, healthcare, pharmaceuticals, high tech, and other industries; and

WHEREAS, It is important for immigrant workers to be able to learn English, acquire useful employment, and gain the skills necessary to move up the employment ladder; and

WHEREAS, It is in the best interest of the State and the immigrants that they move quickly from being newcomers to being fully integrated into the economic, civic, and cultural life of the State; and

WHEREAS, The Illinois Immigrant Policy Project and the Illinois Coalition for Immigrant and Refugee Rights have conducted a series of reports on the challenges facing immigrant newcomers to Illinois, including education, workplace challenges, entrepreneurship, health, and human services; and

WHEREAS, It is important for the State of Illinois to develop an immigrant policy for dealing successfully with our newcomers; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-THIRD GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE SENATE CONCURRING HEREIN, that there is created a Joint Task Force on Illinois Immigrants and Refugees for the purpose of examining their special needs and making recommendations to the General Assembly concerning those needs as they relate to health, human services, education, employment opportunities, and economic development; and be it further

RESOLVED, That the Joint Task Force on Illinois Immigrants and Refugees shall consist of the following members: (i) 2 co-chairpersons who are members of the General Assembly, one of whom is

appointed by the Speaker of the House and one of whom is appointed by the President of the Senate; and (ii) 2 spokespersons who are members of the General Assembly, one of whom is appointed by the Minority Leader of the House and one of whom is appointed by the Minority Leader of the Senate; and (iii) the Speaker of the House, the President of the Senate, the Minority Leader of the House, and the Minority Leader of the Senate may each appoint 4 additional members; and be it further

RESOLVED, That the members shall serve on a voluntary basis and shall be responsible for any costs associated with their participation in the Joint Task Force; and be it further

RESOLVED, That all members of the Joint Task Force shall be considered to be members with voting rights, that a quorum of the Joint Task Force shall consist of a simple majority of the members of the Joint Task Force, and that all actions and recommendations of the Joint Task Force be approved by a simple majority of the members of the Joint Task Force; and be it further

RESOLVED, That the Joint Task Force on Illinois Immigrants and Refugees shall meet at the call of the chairpersons and shall summarize its findings and recommendations in a report to the General Assembly no later than December 31, 2003.

WHEREAS, In 1906, Noah Parden argued successfully before the U.S. Supreme Court on behalf of Ed Johnson, an African-American man wrongly convicted of raping a white woman; because of his efforts for Mr. Johnson, Mr. Parden's life was threatened several times; and

WHEREAS, Mr. Parden won two hundred cases; he had often been compared to Clarence Darrow, the famous criminal lawyer; during his career, he was one of the best known African-American lawyers in the country; he was frequently called from his East St. Louis home to defend those accused in criminal cases; and

WHEREAS, In 1967, the Board of Directors expanded to open their Work Center Developmental Training Program and in 1982, when the wave of deinstitutionalization swept Illinois, the Board of Directors pioneered and led the way to establish one of the first residential facilities in the Chicagoland community, the Supported Living Arrangement (SLA), which serves nine developmentally disabled adults; and

WHEREAS, In 1996, the organization established its Supported Employment Services; the Supported Employment Program continues to provide employment and specialized activities in community-based and integrated settings within the community; in addition, in 1997 the agency successfully undertook, for the first time, national accreditation with the Council on Accreditation of Services for Families and Children, having achieved the maximum number of years as a nationally accredited agency; in each accreditation cycle, WSMRCA/Austin Special received the highest award possible, and in the annual Department of Human Services review has had no deficiencies and has received a 100% rating for the past five years; the organization has also been honored twice with a Proclamation from the City of Chicago for providing exceptional services for developmentally disabled individuals and their families; and

WHEREAS, WSMRCA/Austin Special has grown systematically and progressively meeting its goals so that today they offer vocational, educational, speech, counseling, adaptive swim and gym, residential, supported employment, and transportation services to 140 developmentally disabled adults ages 21-75 who currently attend the Austin Special Work Center, Supported Employment, and Residential Programs; ninety percent are former long-term residents of Illinois institutions; these programs offer services to people who are blind, have hearing loss, seizures, behavior disorders, cerebral palsy and autism, and who may be non-ambulatory; some are dually diagnosed, both mentally retarded and mentally ill; and

WHEREAS, The Austin Special Work Center, a current program of the WSMRCA/Austin Special, and an Illinois Department of Labor Certified Program, provides a wide range of services to over 100 developmentally disabled clients, the majority of whom reside with their parents in the community; the services which are provided focus on improving the clients' work skills and behavior while completing actual work which is subcontracted from Chicago area businesses; and

WHEREAS, In the efforts to engage in broad-based professional advocacy activities on behalf of its developmentally disabled clients, their guardians, families, and the communities they serve, the WSMRCA/Austin established the Human Rights Consortium 15 years ago; today, the Consortium is composed of WSMRCA, CAU (Chicago Alternatives Unlimited), New Horizons for the Developmentally Disabled, H.O.M.E., and North Center for Handicapped; and

WHEREAS, WSMRCA/Austin Special will host a celebration on Sunday, March 9, 2003 in honor of its 50th Anniversary and the outstanding contributions this organization has provided for the community, and also, to honor all the volunteers who helped make its success possible; therefore, be it
