HOUSE BILL 3755. Introduced by Representative Lang, AN ACT concerning civil law.

HOUSE BILL 3756. Introduced by Representative Ford, AN ACT concerning criminal law.

HOUSE BILL 3757. Introduced by Representative Mitchell, Christian, AN ACT concerning public aid.

HOUSE BILL 3758. Introduced by Representative Cabello, AN ACT concerning local government.

HOUSE BILL 3759. Introduced by Representative Cabello, AN ACT concerning local government.

HOUSE BILL 3760. Introduced by Representatives Franks - Sandack, AN ACT concerning public employee benefits, which may also be referred to as The Retirement Means Retirement Act.

HOUSE BILL 3761. Introduced by Representative Ford, AN ACT concerning children.

HOUSE BILL 3762. Introduced by Representatives Franks - Sullivan - Smiddy, AN ACT concerning safety.

HOUSE BILL 3763. Introduced by Representative Walsh, AN ACT concerning education.

HOUSE BILL 3764. Introduced by Representative Scherer, AN ACT concerning appropriations.

HOUSE BILL 3765. Introduced by Representative McAuliffe, AN ACT concerning health.

HOUSE RESOLUTIONS

The following resolutions were offered and placed in the Committee on Rules.

HOUSE RESOLUTION 699

Offered by Representative Cross:

WHEREAS, The term "financial transaction" means a transaction involving the purchase or sale of a stock contract, futures contract, swap contract, credit default swap contract, or options contract; and

WHEREAS, The State of Illinois is home to 4 major financial exchanges and boards of trade: the Chicago Stock Exchange, the Chicago Mercantile Exchange, the Chicago Board of Trade, and the Chicago Board Options Exchange; and

WHEREAS, House Bill 1554 of the 98th General Assembly of the State of Illinois seeks to impose a .01% tax on each transaction conducted on those boards of trade; and

WHEREAS, A 2010 Tax Foundation study found that Illinois residents paid a higher amount of State and local taxes than residents of any of Illinois' neighboring states; and

WHEREAS, In 2011, Illinois increased this tax burden by raising income taxes 66%; and

WHEREAS, Any tax on all financial transactions would be detrimental to the overall economy in the State of Illinois and would hurt the overall job creation of the different companies involved on these various exchanges located in Illinois; and

WHEREAS, The financial sector and the overall economy for the State of Illinois would be significantly negatively impacted by a financial transaction tax; and

WHEREAS, A financial transaction tax would harm average investors who are saving for retirement; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-EIGHTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we state our belief that the State of Illinois should not enact a tax on financial transactions; and be it further

RESOLVED, That suitable copies of this resolution be delivered to all Illinois constitutional officers, the Speaker and Minority Leader of the Illinois House of Representatives, and the President and Minority Leader of the Illinois Senate.

HOUSE RESOLUTION 700

Offered by Representative Arroyo:

WHEREAS, Under the misnomer of the Democratic People's Republic of Korea, the current North Korean government is a continuation of the absolute dynastic dictatorship started by Kim II-sung in 1948; following his death in 1994, Kim II-sung was succeeded by his eldest son, Kim Jong-il; on December 17, 2011, Kim Jong-il died and his youngest son, Kim Jong-un, was immediately installed as his successor; the majority of the North Korean people have experienced unimaginable suffering during the regimes of all 3 dictators; and

WHEREAS, The North Korean government's top priority is total control of all aspects of life in North Korea; all information, artistic expression, academic works, and media activity within its borders is strictly limited, as is freedom of speech; and

WHEREAS, The North Korean government has executed political prisoners, other outspoken opponents of the regime, and certain "repatriated" defectors, as well as members of outlawed religions and organizations; and

WHEREAS, The North Korean government currently holds almost a quarter of a million political prisoners in camps under deplorable conditions; and

WHEREAS, In the early 1990s, more than 2 million inhabitants of North Korea died of starvation due to the failure of the North Korean government-operated centralized agricultural and distribution systems; a 2002 United Nations-European Union survey indicated that one out of every 10 North Korean children are acutely malnourished and 4 out of 10 are chronically malnourished; and

WHEREAS, The North Korean government continues to prevent the monitoring of the delivery of food aid provided by the World Food Program since 1995; and

WHEREAS, The resultant risk of starvation, threat of persecution, and lack of personal freedoms have caused hundreds of thousands of North Koreans to flee, primarily into China, where the women are often at risk of being kidnapped and sold as brides, concubines, or forced into prostitution; and

WHEREAS, The Chinese government has consistently detained, convicted, and imprisoned foreign aid workers who, in accord with United Nations conventions and protocol, assist these North Korean aliens; and

WHEREAS, While the responsibility for domestic refugee resettlement naturally devolves to the South Koreans, the United States should play a leadership role in addressing the plight of these refugees and develop international solutions for this humanitarian crisis; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-EIGHTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we express our solidarity with the North Korean refugees in their quest for relief from hunger and persecution; and be it further

RESOLVED, That we articulate our support for development of a Human Rights and Democracy program that includes meaningful cultural and educational exchanges with North Korea; and be it further

RESOLVED, That we call upon the United States government to take a leadership role in forming an international framework for resettlement of North Korean refugees both here and abroad; and be it further

RESOLVED, That suitable copies of this resolution be presented to President Barack Obama, Secretary of State John Kerry, the members of the Illinois congressional delegation, and the Illinois Human Rights Commission.

Offered by Representative McSweeney:

WHEREAS, Health care and health insurance are among the highest necessities of life for more than 12,000,000 residents of Illinois; and

WHEREAS, Health insurance policies previously offered for sale to American citizens, and enjoyed by them as the result of transactions in a voluntary marketplace, are being withdrawn and banned from sale, partly as a result of their partial compliance or non-compliance with a long and complex set of mandates that will be imposed upon American private-sector health insurance plans starting on January 1, 2014; and

WHEREAS, Many of the men, women, and children who are currently learning that their health insurance policies will be much more expensive, or will not be renewed, live and work in Illinois; and

WHEREAS, It is the duty of the Illinois House of Representatives to listen to the concerns of these individuals, who are faced with the imminent threat of not having insurance to provide for the random chances of health and life; and

WHEREAS, These individuals had been told that if they wanted to keep their existing insurance policies, they would be able to do so, but current events are placing this pledge in serious doubt, and adding to a wave of apprehension and even fear among many thousands of Illinoisans as they search for health-care options for themselves and their loved ones; and

WHEREAS, Those Illinoisans who are searching for potential coverage in 2014 and following years on the federal website "HealthCare.gov" are finding a poorly designed website that, in many cases, is unable to offer customers a choice of insurance policies comparable to the policy choices that they previously enjoyed, or to the policy that they had previously purchased and wanted to continue to keep; and

WHEREAS, In some cases, customers find "HealthCare.gov" becomes unhelpful for them after they have submitted extremely confidential personal financial information about themselves, thereby potentially compromising their deepest privacy without giving them even the opportunity to purchase health care insurance in return; and

WHEREAS, Current United States' press coverage is providing background information to explain the poor performance of "HealthCare.gov", including the revelation that even after a series of emergency fixes is applied to the website over the next few weeks, the site is not expected to have the capacity to handle more than a fraction of the inquiries and transactions that will be imposed upon it if all of the millions of Americans who have been mandated to purchase private-sector health care insurance under the Affordable Care Act attempt to do so using the key website; and

WHEREAS, Responding to this crisis, bipartisan members of the U.S. Congress have expressed their support for the principle that "if you have a health insurance policy and you like it, you ought to be able to keep it"; therefore, be it

RESOLVED, That we congratulate the lawmakers of both parties that are working together to fix this problem in a spirit of problem-solving and bipartisanship; and be it further

RESOLVED, That we affirm the right of Illinois citizens and residents to select their own health insurance policies on the basis of their own knowledge of what is appropriate for them, and congratulate all of those who have spoken out, as citizens and as Americans, in defense of this right; and be it further

RESOLVED, That suitable copies of this resolution be provided to all 18 members of the Illinois Congressional Delegation and to U.S. Senators Richard J. Durbin and Mark Kirk.

HOUSE RESOLUTION 707

Offered by Representative Moylan:

WHEREAS, The recent opening of runway 10C/28C at O'Hare International Airport has caused a dramatic change in the flight patterns and volume over the homes in neighboring communities; many citizens have expressed major concerns about the environmental risks, noise levels, and safety issues that have come with increased flight traffic; and

WHEREAS, Despite the vital importance that O'Hare plays to the local and regional economy, the effects of these new flight patterns on the citizens of our State must be addressed in a manner that benefits both the residents of the affected area and the airport; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-EIGHTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we encourage the City of Chicago, the Chicago Department of Aviation, and the Federal Aviation Administration to revisit the current plans for a voluntary and workable Fly Quiet program; and be it further

RESOLVED, That we encourage all relevant entities to explore all available options to ensure that the residents of the affected areas are adequately protected, while also maintaining the economic integrity of O'Hare International Airport; and be it further

RESOLVED, That suitable copies of this resolution be delivered to the City of Chicago, the Chicago Department of Aviation, and the Federal Aviation Administration.

HOUSE RESOLUTION 708

Offered by Representative Chapa LaVia:

WHEREAS, Insomnia is a disruption of the sleep cycle that can significantly impair everyday functioning; and

WHEREAS, Childhood insomnia is a serious condition which can lead to depression, memory problems, decreased attention spans, and poor performance in school; and

WHEREAS, Children under the age of 12 need 10 to 11 hours of sleep a night; teenagers need 9 hours of sleep per night; and

WHEREAS, Childhood insomnia can be caused by a variety of reasons, such as stress, poor bedtime habits, and diet; and

WHEREAS, Children with physical illnesses, psychiatric disorders, or learning disabilities are more prone to childhood insomnia; and

WHEREAS, About 40% of children have a sleep problem considered to be significant by their parents at some stage of their development; and

WHEREAS, Many cases of childhood insomnia may be solved through non-drug related treatments, such as proper scheduling and exercise; and

WHEREAS, It would benefit students with insomnia to be eligible for Individualized Education Programs in accordance with existing special education laws; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-EIGHTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we strongly encourage all schools in the State of Illinois to address and help students suffering from childhood insomnia; and be it further

RESOLVED, That we encourage the Illinois State Board of Education to develop rules to allow school districts to provide Individualized Education Programs to students with insomnia to further assist with their studies.
