WHEREAS, William Henry "Bill" Cosby, Jr. (born July 12, 1937) is an American comedian, actor, author, television producer, educator, musician, and activist; a veteran stand-up performer, he got his start at the "hungry i" in San Francisco and various other clubs; he then landed a starring role in the 1960s action show "I Spy" and was one of the major performers on the children's television series "The Electric Company" during its first 2 seasons; he created the educational cartoon comedy series "Fat Albert" and "The Cosby Kids", about a group of young friends growing up in the city; and

WHEREAS, During the 1980s, Bill Cosby produced and starred in one of the decade's defining sitcoms, "The Cosby Show", which aired 8 seasons from 1984 to 1992; it was the number one show in America for 5 straight years (1985-89) and highlighted the experiences and growth of an affluent African-American family; he also produced the spin-off sitcom "A Different World", which became second only to "The Cosby Show" in ratings; he starred in the sitcom "Cosby" from 1996 to 2000 and hosted "Kids Say the Darndest Things" for 2 seasons; and

WHEREAS, In 1976, Bill Cosby earned a Doctor of Education degree from the University of Massachusetts Amherst; his dissertation discussed the use of "Fat Albert" and "The Cosby Kids" as a teaching tool in elementary schools; and

WHEREAS, In 2002, scholar Molefi Kete Asante included him in his book "The 100 Greatest African Americans"; and

WHEREAS, Bill Cosby has always been deeply involved in helping educate children and fostering a life-long love of learning; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-EIGHTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we urge the City of Chicago to name the branch of the Chicago Public Library located in the Austin community after actor and comedian Bill Cosby; and be it further

RESOLVED, That suitable copies of this resolution be presented to Chicago Public Library Commissioner Brian Bannon and Chicago Mayor Rahm Emanuel.

WHEREAS, Maya Angelou received the highest civilian honor, the Presidential Medal of Freedom, from President Barack Obama in 2010; and

WHEREAS, Maya Angelou was presented the Literary Arts Award by First Lady Michelle Obama at the BET Honors ceremony in Washington, D.C. in 2012; and

WHEREAS, Maya Angelou received over 50 honorary degrees; she also served as a Reynolds Professor of American Studies at Wake Forest University in Winston-Salem, North Carolina; and

WHEREAS, Maya Angelou fashioned her life around many of the values that Harvey Public Schools District 152 incorporated into its Mission Statement, including academic excellence, leadership, skillful decision-making, respect for others and self, giving your best effort, honesty, personal empowerment, cultural appreciation, and joy of learning; and

WHEREAS, The Maya Angelou Elementary School in Harvey is the only school named after Maya Angelou in the State of Illinois; the school will educate children with the skills they need to face the future, as well as the values that were so intrinsic in this fiercely proud and humble woman; and

WHEREAS, In her presence on September 22, 1995, Maya Angelou Elementary School was dedicated in her name; and

WHEREAS, Maya Angelou passed away on May 28, 2014 at her home in Winston-Salem, North Carolina; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-EIGHTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we proudly rededicate the Maya Angelou Elementary School in Harvey in honor of Maya Angelou and her legacy; and be it further

RESOLVED, That a suitable copy of this resolution be presented to Harvey Public Schools District 152.

HOUSE RESOLUTION 1256

Offered by Representative Moeller:

WHEREAS, On July 16, 2014, Jesse Vega, also known as Jesse Ortiz, escaped from Elgin Mental Health Center custody while being transported to a court hearing concerning criminal charges pending against him; and

WHEREAS, Vega was charged with aggravated domestic battery, aggravated battery causing great bodily harm, aggravated battery in a public place, obstructing justice, and aggravated driving under the influence with a suspended or revoked license; and

WHEREAS, Vega remained at large for 8 hours, placing the community in harm's way for an extended period of time; and

WHEREAS, At the time of the escape, Vega was accompanied by 3 security officers; he fled from the vehicle as it was stopped at a gas station in a residential neighborhood; and

WHEREAS, The safety of individuals residing, working, or traveling in our neighborhoods is of paramount concern; the public requires a full understanding of how this escape occurred so officials may take the necessary steps to help prevent any future escape; and

WHEREAS, This escape constitutes a breakdown in either the design or execution of the procedures governing the transportation of prisoners at the Elgin Mental Health Center; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-EIGHTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we direct the Office of the Auditor General to conduct an investigation to examine the circumstances surrounding Vega's escape and evaluate whether prisoner transport procedures need to be improved at Elgin Mental Health Center and/or all State facilities; and be it further

RESOLVED, That we urge the administration of the Elgin Mental Health Center and all other institutions involved with this inquiry to make available all information to the Office of the Auditor General that may be necessary to their investigation; and be it further

RESOLVED, That the Office of the Auditor General shall present a report to the Illinois House of Representatives detailing the findings of its investigation and any recommendations for procedural reform, should they result from the investigation, not more than one year after the passage of this resolution; and be it further

RESOLVED, That suitable copies of this resolution be delivered to the Governor, the Director of the Department of Human Services, the Director of the Department of Corrections, and the members of the Illinois congressional delegation.

HOUSE RESOLUTION 1267

Offered by Representative McSweeney:

WHEREAS, A proposed educational pension cost shift, which would shift the cost burden from the State of Illinois to local school districts, community colleges, and institutions of higher education, is under discussion; this proposal would require all employers of members in the Teachers' Retirement System and the State Universities Retirement System to pay the normal cost of pension benefits earned; and

WHEREAS, If this proposal were to become policy, for the Teachers' Retirement System and the State Universities Retirement System, it would potentially move \$10.187 billion in estimated normal costs of pension benefits earned from the State to local school districts, community colleges, and institutions of higher learning over a 10-year period; actuarial changes recently made by these 2 systems will further increase these numbers; and

WHEREAS, This plan would move these spending commitments from one taxing body, the State, to a group of taxing bodies, the school districts and community colleges, while additional pension costs would be shifted to State universities; and

WHEREAS, A pension cost shift would lead to a massive increase in local funding requirements on school districts; the cost shift would exacerbate the problem of adequately funding our local schools by taking even more when districts, teachers, and local voters are fighting to simply keep educational opportunities open to our students; in addition, a pension cost shift would likely lead to massive property tax hikes or to classroom cuts that will harm our students; and

WHEREAS, According to the Illinois State Board of Education, 67% of school districts in the State are operating in the red; and

WHEREAS, School districts already bear a large share of the Teachers' Retirement System pension burden by paying a statutory share of the System's total contribution costs, constituting 0.58% of pensionable teacher payroll; districts also contribute towards any locally-negotiated early retirement options and for the pension costs of certain increases in compensation, totaling \$92.5 million in Fiscal Year 2012; and

WHEREAS, Representatives from Northern Illinois University publicly stated that if the cost shift were to be covered by increasing tuition on parents and students, each percentage of payroll cost shifted to the university would translate into a 2% tuition increase; this proposed cost shift would also increase the liability of State-funded universities and all community colleges, thus making higher education even more unaffordable for students and their parents; and

WHEREAS, This plan would harm the interests of all taxpayers, especially in downstate and suburban areas and would sharply increase inequities created by the current school aid formula between Chicago and the rest of the State; because of the impact on institutions of higher education, Chicago taxpayers, parents, and students would also be affected; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-EIGHTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we state our belief that an educational pension cost shift is financially wrong and would only serve to shift pension burdens from the State to the status of an unfunded mandate.

HOUSE RESOLUTION 1273

Offered by Representative Smith:

WHEREAS, The mission of the West Garfield Park Community Stakeholders is to establish and strengthen collaboration among communities, public and private non-profit agencies, and federal, state, local, and tribal governments to support the efforts of community coalitions that are working to prevent and reduce substance use among youth; and

WHEREAS, The West Garfield Park Community Stakeholders also seeks to reduce substance abuse among adults over time by addressing the factors in communities that increase the risk of substance abuse and promoting the factors that minimize the risk of substance abuse; and

WHEREAS, The West Garfield Park Community Stakeholders' purpose is to create opportunities through programs, activities, and events to help direct youth towards positive alternatives to violence, as well as teaching them how to become productive citizens through positive civic engagement; and

WHEREAS, The West Garfield Park Community Stakeholders' vision is to engage a partnership of residents, parents, youth, educational institutions, organizations, and public servants with a common goal to reduce violence within the West Garfield Park community; and

WHEREAS, The White House Office of National Drug Control Policy has directed the Drug Free Communities Support Program, in partnership with the Substance Abuse and Mental Health Services Administration, to provide grants to coalitions that mobilize their communities to prevent youth alcohol, tobacco, illicit drug, and inhalant abuse; and

WHEREAS, As a New-Grantee of the office of Substance Abuse and Mental Health Services Administration, the West Garfield Park Community Stakeholders is working within the Substance Abuse and Mental Health Services Administration's Strategic Prevention Framework to develop and secure the following core competencies: assessment, capacity, planning, implementation, evaluation, sustainability, and cultural competence; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-EIGHTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we designate the date of October 6, 2014 as West Garfield Park Community Violence and Substance Abuse Prevention Day in the State of Illinois.

HOUSE RESOLUTION 1276

Offered by Representative Sandack:

WHEREAS, In 2013, the Illinois Senate adopted Senate Resolution 431, which created the Senate Education Funding Advisory Committee; and

WHEREAS, The purpose of the Senate Education Funding Advisory Committee was to propose a State education funding system that provides adequate, equitable, transparent, and accountable distribution of funds to school districts that will prepare students for achievement and success after high school; and

WHEREAS, On January 31, 2014, the Senate Education Funding Advisory Committee filed its recommendations, which included ending the current General State Aid formula and mandating categorical funding, and replacing it with a new single weighted formula that assigns weighting criteria for students, such as low-income, English Language Learner, transportation needs, special education, and gifted students; and

WHEREAS, Senate Bill 16 was amended in April of 2014 to include the Senate Education Funding Advisory Committee recommendations; a public hearing was held in the Senate and the bill was changed significantly to secure passage from the Senate; and

WHEREAS, The bill is now a piecemeal reallocation of State tax dollars that will negatively impact hundreds of school districts, causing deep budget reductions and financial uncertainty; and

WHEREAS, There is no doubt that education funding reform is a priority to ensure all students are academically successful and prepared for post-secondary education and the workforce; and

WHEREAS, A more equitable and reasonable approach to education funding reform must be taken to make certain that a comprehensive and meaningful reform is achieved; and

WHEREAS, Education funding reform deserves thoughtful and thorough discussion that includes all education stakeholders, parents, teachers, and all members of the General Assembly; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-EIGHTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we urge the members of this body to cease their efforts to pass Senate Bill 16 to make certain that all aspects of the Senate Education Funding Advisory Committee

report are analyzed and discussed thoroughly and publicly by all members of the General Assembly, taxpayers, parents, and the education community.

HOUSE RESOLUTION 1317

Offered by Representative Thapedi:

WHEREAS, In the State of Illinois, an eligible law student and an eligible graduate of law school that is not yet licensed to practice law in any jurisdiction, if he or she satisfies specific requirements, can be granted a temporary license to perform specified legal services under the Supreme Court of Illinois Rules on Admission and Discipline of Attorneys, Article VII, Part A., Rule 711; and

WHEREAS, Under Rule 711, eligible law students and eligible graduates of law schools may render services under the supervision of a member of the Illinois bar, such as negotiating in the settlement of claims; representing clients in mediation and other non-litigation matters; engaging in the preparation and drafting of legal instruments; and appearing in trial courts, courts of review, and administrative tribunals of this State, subject to qualifications; and

WHEREAS, Eligible law students and eligible graduates of law school may perform such permitted legal services in the course of the student's or graduate's work with one or more of the following organizations or programs: a legal aid bureau, legal assistance program, organization, or clinic chartered by the State of Illinois or approved by an American Bar Association-approved law school; the public defender's office; or a law office of the State or any of its subdivisions; and

WHEREAS, The Illinois General Assembly is the legislative body of the State of Illinois authorized to negotiate, prepare, draft, and enact legislation on behalf of the people of Illinois; and

WHEREAS, The Illinois General Assembly has offices comprised of staff attorneys and legislators that analyze and draft legislation and research-related legal issues; some of these offices also have licensed members of the Illinois bar; and

WHEREAS, As currently written, Rule 711 does not clearly authorize eligible law students and eligible law school graduates to perform legal services under the agency of the Illinois General Assembly; and

WHEREAS, Eligible law students and eligible law school graduates that are temporarily licensed under Rule 711 could greatly benefit from the advanced experience gained through the opportunity of working closely with members of the General Assembly while performing legal services related to the legislative process; and

WHEREAS, The General Assembly could greatly benefit from the additional assistance and particularized knowledge of eligible law students and eligible law school graduates that are temporarily licensed under Rule 711 to perform legal services related to the legislative process; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-EIGHTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we urge the Supreme Court of Illinois to amend its Rules on Admission and Discipline of Attorneys, Article VII, Part A. Admission to the Bar, Rule 711 (b), Agencies Through Which Services Must Be Performed, to specifically list the Illinois General Assembly as one of the agencies through which services may be performed as a part of the temporary licensing process, authorizing eligible law students and eligible law school graduates to perform legal services under the Rule; and be it further

RESOLVED, That suitable copies of this resolution be delivered to the members of the Illinois Supreme Court Rules Committee and the Director of the Administrative Office of the Illinois Courts.

HOUSE RESOLUTION 1335

Offered by Representative Pihos:

WHEREAS, The State of Illinois serves over 2,000,000 students in 862 school districts statewide; and

WHEREAS, State funding for pre-kindergarten through grade 12 education in Illinois has been reduced by \$636,640,000 since fiscal year 2009; and

WHEREAS, The State is currently not meeting its statutory obligations of funding general State aid at the Foundation Level of support of \$6,119; instead, the State is underfunding it by close to \$560 million, resulting in an 89% proration rate; and

WHEREAS, Illinois ranks 50th in terms of the state proportion of kindergarten through grade 12 funding, providing for just 32.5% of all funds spent on kindergarten through grade 12 public education, despite the plain language of Article X of the Illinois Constitution, which states: "The State has the primary responsibility for financing the system of public education."; and

WHEREAS, In 2007, 23% of Illinois school districts reported deficit spending; today, more than 67% of Illinois school districts report deficit spending; and

WHEREAS, Reductions in State spending have increased school districts' reliance on local resources, impacting classroom services and financial stability, at a time when school districts are required to undertake more necessary improvements and initiatives, such as teacher and principal evaluations, new and higher learning standards, and assessments; and

WHEREAS, To address this important issue, the Illinois Senate passed Senate Resolution 431 in the spring of 2013, which created the Advisory Committee on Education Funding; and

WHEREAS, The Senate Advisory Committee on Education Funding sought input from stakeholders and members of the public on issues and possible improvements to the existing funding system and eventually made recommendations on education funding reform; and

WHEREAS, Some, but not all, of the final recommendations of the Senate Advisory Committee on Education Funding can be found in Senate Bill 16 (Chief Sponsors Sen. Manar and Rep. Chapa LaVia) of the 98th General Assembly; and

WHEREAS, Senate Bill 16 was an important first step in moving forward on the topic of education funding reform; and

WHEREAS, The Illinois House of Representatives should continue its discussion and give full consideration to any and all recommendations on how to adequately address funding and, more importantly, underfunding of Illinois education; and

WHEREAS, The House of Representatives must stay engaged in public education issues and be prepared to make legislative and administrative recommendations, but to do so it is important that our members have an in-depth understanding of how the State funds education, what changes have been made over recent history, where there is room for improvement, and what implications come as result of any reform; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-EIGHTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that there is created the House Education Funding Advisory Committee, consisting of members appointed as follows: 4 members of the House majority caucus appointed by the Speaker of the House, one of whom shall be designated as a co-chair, and 4 members of the House minority caucus appointed by the House Minority Leader, one of whom shall be designated as a co-chair; and be it further

RESOLVED, That the House Education Funding Advisory Committee shall do the following:

(1) conduct a thorough review of the existing distribution methods and expenditures of all pre-kindergarten through grade 12 education funding, with a focus on general State aid as provided in Section 18-8.05 of the School Code;

(2) make recommendations to implement an education funding system that:

(A) is adequate;

(B) is equitable;

(C) prepares students for achievement and success after high school; and

(D) supports teachers and school leaders; and

(3) consider the following when making its recommendations:

(A) the number of students in a school and school district and the level of need of those students, including special needs populations;

(B) a school district's ability to provide local resources to pay for basic educational needs;

(C) transparency and accountability;

(D) revenue predictability to support sound planning and budgeting by school boards and administrations; and

(E) the long-term implications and outcomes of the funding system, along with provisions that require the system to be monitored, publicly reported, assessed, and improved over time; and be it further

RESOLVED, That the House Education Funding Advisory Committee shall seek input from stakeholders and members of the public on issues and possible improvements to the existing funding system; and be it further

RESOLVED, That the House Education Funding Advisory Committee shall utilize the findings and reports of the Senate Advisory Committee on Education Funding in the preparation of its report to the Speaker and the Minority Leader of the House of Representatives; and be it further

RESOLVED, That we encourage the House Education Funding Advisory Committee and Senate Advisory Committee on Education Funding to hold joint meetings to discuss the recommendations and proposed policies created by both committees; and be it further

RESOLVED, That members of the House Education Funding Advisory Committee shall serve without compensation, and the State Board of Education shall provide administrative and other support to the House Education Funding Advisory Committee; and be it further

RESOLVED, That the House Education Funding Advisory Committee shall meet at the call of the co-chairs, but shall meet a minimum of 4 times per year; and be it further

RESOLVED, That the House Education Funding Advisory Committee shall share its legislative and administrative recommendations with the Speaker and Minority Leader of the House of Representatives no later than December 31, 2014; and be it further

RESOLVED, That a suitable copy of this resolution be delivered to the Chairperson of the State Board of Education and the State Superintendent of Education; and be it further

RESOLVED, That the State Board of Education shall provide a copy of this resolution to school districts in the State.

HOUSE RESOLUTION 1336

Offered by Representative Williams:

WHEREAS, Lung cancer kills 159,000 Americans every year, more than any other form of cancer; and

WHEREAS, Smoking is the most common cause of lung cancer; secondhand smoke exposure, radon, asbestos, and genetic disorders have long been known to cause lung cancer; and

WHEREAS, The World Health Organization's International Agency for Research on Cancer recently added outdoor air pollution and particulate matter to the growing list of air pollutants known to cause lung cancer; and

WHEREAS, Although avoiding exposure to these carcinogens is the best way to prevent lung cancer, people cannot always avoid them because they are so widespread; and

WHEREAS, Early diagnosis and treatment of lung cancer greatly improves survival rates; however, most cases are not diagnosed until their later stages; and

WHEREAS, The lung cancer mortality rate for high-risk populations can be lowered by up to 14% through early detection, including low-dose CT screening; and

WHEREAS, It is estimated that 72,000 American women will die of lung cancer in 2014, which accounts for 26% of all female deaths due to cancer; and

WHEREAS, Lung cancer is the deadliest form of cancer in the United States; and

WHEREAS, Every two-and-a-half minutes, someone in the United States is told that he or she has lung cancer; and

WHEREAS, In the last 36 years, the lung cancer death rate has fallen 28% among men while increasing 98% among women; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-EIGHTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we hereby designate November as Lung Cancer Awareness Month in the State of Illinois, and we encourage all residents to learn more about the detection and treatment of lung cancer; and be it further

WHEREAS, The boundaries of the 32nd Representative District are generally in the inner city of Chicago extending to the southwest suburbs of Burbank, Bridgeview, Hickory Hills, and Justice, Illinois; and

WHEREAS, The 32nd Representative District has a voting-age population of 108,734 people of various ethnic and socio-economic backgrounds; and

WHEREAS, 27,909 of the residents of the 32nd Representative District live at or below the federal poverty level; and

WHEREAS, The 32nd Representative District ranks in the top 3 of Representative Districts reporting incidents of violent crime; and

WHEREAS, The Dan Ryan Expressway is that 12-mile portion of I-90/94 located in the City of Chicago spanning from approximately 95th Street to the south and Roosevelt Road to the north; and

WHEREAS, The Dan Ryan Expressway travels through the 32nd Representative District one linear mile from 67th Street to the north and 76th Street to the south; and

WHEREAS, Within the 32nd Representative District lies Halsted Street, one mile west of the Dan Ryan Expressway, and Cottage Grove Avenue, one mile east of the Dan Ryan Expressway; this area generally encompasses the communities of Englewood and Grand Crossing including the Park Manor neighborhood; and

WHEREAS, In November of 1985, Mayor Harold Washington entered into an intergovernmental agreement with the State of Illinois whereby the State of Illinois could operate Illinois State Lottery kiosks at O'Hare International Airport and, subsequently, Chicago Midway International Airport; and

WHEREAS, In November of 1985, Governor James R. Thompson entered into an intergovernmental agreement with the City of Chicago whereby the Illinois State Police would patrol the Dan Ryan Expressway and all other expressways in the City of Chicago; and

WHEREAS, The State of Illinois receives monies after the imposition of fines and penalties upon those persons cited for, among other things, improperly operating motor vehicles on the Dan Ryan Expressway between 67th Street and 76th Street; and

WHEREAS, The State of Illinois derives financial profits directly from the Illinois State Lottery kiosks located at both O'Hare International and Chicago Midway International Airports; and

WHEREAS, In fact, the Illinois State Lottery posted fiscal year 2013 revenues of: (1) \$4,939,990 from O'Hare International Airport; (2) \$696,776 from Chicago Midway International Airport; and (3) \$656,000,000 overall; and

WHEREAS, It will not be a financial burden on the State of Illinois for the Illinois State Police to expand its patrol area, from the Dan Ryan Expressway between 67th Street and 76th Street one linear mile east and one linear mile west, to support efforts at combating violent crime in the State of Illinois; and

WHEREAS, Since as late as 1999, the Illinois State Police was dispatched to and patrolled the City of East St. Louis, Illinois to support efforts to combat crime in the State of Illinois; and

WHEREAS, As of the date of the filing of this resolution, over 700 registered voters, within the 2 mile rectangular boundary of the Dan Ryan Expressway between 67th Street and 76th Street, have signed a petition imploring the Governor of the State of Illinois to dispatch the Illinois State Police, with all deliberate speed, to that specific area within the 32nd Representative District for a reasonable period of time; and

WHEREAS, These 700 affected residents of the 32nd Representative District have stated that they are in immediate need of assistance and relief to protect their health, safety and welfare; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-EIGHTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that there is created the Englewood Violent Crime Task Force within the Illinois State Police, to consist of the following:

(7) two members of the Illinois House of Representatives chosen by the Speaker of the Illinois House of Representatives, one of whom shall serve as co-chair;

(8) two members of the Illinois House of Representatives chosen by the Minority Leader of the Illinois House of Representatives;

- (9) the President of the Park Manor Neighbors Community Council;
- (10) the Executive Director of Project Brotherhood;
- (11) the President of the Student Government Association at the University of Illinois at Chicago;
- (12) the President of the Student Government Association at Chicago State University;
- (13) the Director of Corrections, or his or her designee who must:
 - (A) be from the Division of Parole;
 - (B) be an active field agent; and
 - (C) possess at least a master's degree in criminal justice or criminology;
- (14) a faculty member of the Department of Criminology, Law & Justice at the University of Illinois at Chicago appointed by the President of the University of Illinois;
- (15) a member of the Chicagoland Chamber of Commerce appointed by the chairman of the board of the Chicagoland Chamber of Commerce;
- (16) a member of the Illinois Chamber of Commerce appointed by the chairman of the board of the Illinois Chamber of Commerce; and
- (17) a member of the Illinois Retail Merchants Association appointed by the President/CEO of the Illinois Retail Merchants Association; and be it further

RESOLVED, That all appointments shall be made no later than 45 days following the adoption of this resolution; and be it further

RESOLVED, That the Task Force shall study and determine the causes of violent crime in Englewood and nearby affected communities; and be it further

RESOLVED, That the Task Force shall study and determine the feasibility of deploying the Illinois State Police to Englewood and nearby affected communities and neighborhoods; and be it further

RESOLVED, That the Task Force shall develop a comprehensive long-term solution to the effect of violent crime in Englewood and nearby affected communities; and be it further

RESOLVED, That the Task Force shall recommend a plan of action to substantially reduce the incidents of violent crime in Englewood and nearby affected communities; and be it further

RESOLVED, That the Task Force shall draft any necessary legislation and make any necessary recommendations for appropriations for the General Assembly to pass and the Governor to sign to place the plan of action into immediate effect; and be it further

RESOLVED, That the Task Force shall report its findings and recommendations and submit any and all proposed legislation to the Governor and General Assembly on or before December 31, 2015; and be it further

RESOLVED, That the members of the Task Force shall serve without compensation, but shall be reimbursed for their reasonable and necessary expenses from the funds appropriated for that purpose from the Illinois State Lottery; and be it further

RESOLVED, That a copy of this resolution be presented to the Speaker of the Illinois House of Representatives, the Minority Leader of the Illinois House of Representatives, the Governor of the State of Illinois, and the Director of State Police.

HOUSE JOINT RESOLUTION 105

WHEREAS, The Voting Rights Act of 1965 is an important piece of legislation that emerged from the Civil Rights Movement and was developed to ensure the fundamental right of all citizens to vote; and

WHEREAS, The Voting Rights Act was reauthorized by Congress in 2006 by an overwhelmingly bipartisan effort; and

WHEREAS, On June 25, 2013, in *Shelby County, Alabama v. Holder*, the United States Supreme Court eliminated a key provision of the Voting Rights Act which provided a screening mechanism for changes in voting procedures in certain states and jurisdictions with a history of voter discrimination; and

WHEREAS, The Supreme Court's decision in *Shelby County* has allowed states and jurisdictions to pursue and justify a range of changes to voting procedures which would infringe upon the right to vote and negatively and disproportionately impact minority voters; and

WHEREAS, These voting changes include enhanced and aggressive voter identification laws, limitations on early voting, and statewide voter purges; and

WHEREAS, On January 16, 2014, United States Senators Patrick Leahy (D-VT), Richard Durbin (D-IL), and Chris Coons (D-DE) introduced The Voting Rights Amendment Act, S. 1945, that would strengthen the foundation of the original Voting Rights Act and combat current and future discrimination; and

WHEREAS, The Voting Rights Amendment Act represents a bipartisan response to the Supreme Court's invitation in *Shelby County* to update the Voting Rights Act and address the demonstrated need for protections to the right to vote; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-EIGHTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE SENATE CONCURRING HEREIN, that we urge Congress to pass S. 1945, the Voting Rights Amendment Act; and be it further

WHEREAS, Five days after the surrender of General Robert E. Lee and the Army of Northern Virginia, then being the principal force bearing arms in support of the Confederate States of America, President Lincoln was fatally wounded on April 14, 1865 by an enraged and resentful partisan of the insurgency; and

WHEREAS, Upon President Lincoln's death on the morning of April 15, 1865, he was identified as a victim of the Civil War and is considered one of the final casualties of the tragic conflict; and

WHEREAS, President Lincoln's home state of Illinois laid claim, with the support of his widow Mary Todd Lincoln, to his mortal remains; over a 20-day period, the remains of the President were returned to Illinois in a scene of intense gratitude for his service to the nation; on May 4, 1865, the remains of the President, after being transported through the streets of Springfield, were laid to rest in Oak Ridge Cemetery, close to the site where they remain today; and

WHEREAS, The 2015 Lincoln Funeral Coalition has taken on the responsibility of organizing a historically accurate reenactment of President Lincoln's funeral procession through Springfield; in so doing,

the Coalition and its Board of Directors, participants, and volunteers have set forth as part of their mission statement the goals of educating reenactment participants, coordinating the reenactment, and promoting the solemn and dignified observance of the occasion; and

WHEREAS, The dates designated for the funeral reenactment are May 2 and May 3, 2015; and

WHEREAS, It is highly fitting that the State of Illinois pay honor and respect to President Lincoln by observing the sesquicentennial of his death and funeral; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-EIGHTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE SENATE CONCURRING HEREIN, that we designate the days of May 2, 2015, May 3, 2015, and May 4, 2015 as days of remembrance in honor of the 150th anniversary of the death and funeral of President Abraham Lincoln; and be it further

RESOLVED, That we request the Governor to order the United States national flag and the State flag of Illinois to be flown at half-staff on the days of May 2, 2015, May 3, 2015, and May 4, 2015; and be it further

RESOLVED, That we encourage all residents of the State to display the United States national flag and the State flag of Illinois at half-staff during these days of remembrance; and be it further

HOUSE JOINT RESOLUTION 115

Offered by Representative Costello:

WHEREAS, Long before Lewis and Clark, our region was home to the ancient societies of Mississippian Culture and the beginnings of urbanism in the eastern woodlands; it was from these societies that today's great Indian Nations sprang, with cultural connections from the Great Lakes to the Gulf of Mexico and along the mighty Mississippi; the beginnings of this urban civilization was spread over 6 counties of eastern Missouri and southwestern Illinois; and

WHEREAS, At the sea of verdure, the fertile American Bottom stretches bluff to bluff at the confluence of America's greatest rivers, the Mississippi and Missouri Rivers, cradling the birth of millennia of agriculture and the rise of the Mississippian Culture; Cahokia Mounds and its mound complexes thrived on the cultivation and trading of corn, with their surplus allowing them to rise and become the "Center of the Universe" of the Mississippian Culture, trading to the north, south, east, and west; and

WHEREAS, Dating from the Mississippian period (800-1350 AD), Cahokia Mounds, covering 3,950 acres, is the earliest and largest pre-Columbian archaeological site north of Mexico and the pre-eminent example of a cultural, religious, and economic center of the pre-historic Mississippian cultural tradition, which extended throughout the Mississippi Valley and the southeastern United States; and

WHEREAS, With a population of 10,000-30,000 at its peak between 1050 and 1150AD, Cahokia Mounds is an early and exceptional example of pre-urban/urban structuring, graphically demonstrating the existence of a society in which a powerful political and economic hierarchy was responsible for the organization of labor, agriculture, and trade; this is reflected in the size and layout of the settlement and the nature and structure of the public and private buildings; and

WHEREAS, Cahokia Mounds' unique role in the nation's history was recognized by the National Park Service through its designation as a National Historic Landmark in 1964 and its placement on the National Register of Historic Places in 1966; and

WHEREAS, Cahokia Mounds' global significance was recognized by the United Nations Education Scientific and Cultural Organization through its designation as a World Heritage Site in 1982; and

WHEREAS, Since 1925, State, local, and private funds have been invested in the Cahokia Mounds Historic Site for acquisition and protection; a formal national park service designation would capitalize on this investment; and

WHEREAS, Cahokia Mounds and its ancient non-contiguous satellite settlements are today in need of additional protection to secure the most significant remnants of the largest Native American civilization on the North American continent north of Mexico from active and passive threats; and

WHEREAS, Over the last 24 months, with guidance from the Indian Nations, federal agencies, Illinois and Missouri state agencies, and local units of government, HeartLands Conservancy developed a thorough, compelling, and rigorous study that met National Park Service standards and criteria demonstrating the feasibility of elevating the status and national designation of Cahokia Mounds; the surrounding mound complexes in the region and their significance, suitability, and feasibility as a potential formal unit of the

National Park Service would ensure that these precious ancient archaeological resources are protected and accessible for all people to experience; and

WHEREAS, Conducting 13 public meetings, media interviews, stakeholder meetings, outreach to 13 tribes/nations, and over 890 surveys, HeartLands Conservancy received support for the study's recommendations and showed that local communities would benefit from revitalized and protected sites with enhanced interpretive and educational programs to teach about the Mississippian Culture, its ancestral significance, and the numerous associated historic traces and cultural themes; and

WHEREAS, The study captured the significance of the region and its ancient history by demonstrating that, through cooperative protection and partnerships, it can remain connected and intact in order to properly interpret remaining sites as well as offering opportunities to protect, enhance, and interpret the natural environment along the Mounds Heritage Trail corridor; and

WHEREAS, National parks generate \$31 billion for local economies each year and are shown to invigorate neighborhood historic renovation and spur business growth; they also provide opportunities for tourism and economic development, natural resource conservation, and improvements of the quality of life for residents of nearby communities; and

WHEREAS, There are no other mounds within the National Park Service that represent the Mississippian Culture as holistically and uniquely as the Cahokia Mounds; combined with the surrounding satellite mound centers, Cahokia emerges as the most significant and unsurpassed example of its time period; and

WHEREAS, The great region of southwestern Illinois and eastern Missouri will, with the assistance of the Indian Nations, become a center of cultural outreach and enrichment by embracing our nation's earliest heritage and re-engaging our ancient past as a foundation for the 21st century; and

WHEREAS, Legislation will be introduced in Congress to create the Mississippian Culture National Historical Park in Southwestern Illinois, which, with thematically-connected non-contiguous mound complexes in the St. Louis Metropolitan Region, will recognize the significance of the Mississippian Culture and its unique national significance in agriculture, ancestral ties, and its status as one of America's first cities; and

WHEREAS, There is a strong consensus that now is the time for immediate action to further develop the Cahokia Mounds and thematically-connected mound complexes to realize their full potential; with new transportation access across the Mississippi River completed and the rebound of the economy, there is even greater pressure to develop this; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-EIGHTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE SENATE CONCURRING HEREIN, that we show our support for the recommendations in "The Mounds - America's First Cities - A Feasibility Study" by HeartLands Conservancy and iterate that not only should the State of Illinois continue to own and operate the Cahokia Mounds State Historic Site and have a collaborative partnership with the National Park Service, but other communities, agencies, and entities should play a role in redeveloping and re-energizing these sites and establish strong and lasting partnerships; and be it further

RESOLVED, That we urge the citizens of this State to actively join HeartLands Conservancy, the Governor of Illinois, and the Illinois Historic Preservation Agency in the Mississippian Culture Initiative; and be it further
