A-S.B. 375 -- **(Walker)** Kotowski - Demuzio - Hutchinson - Bond - Frerichs --- AN ACT concerning State government. **(CA 1) Short Debate**

S.B. 2497 -- **(Smith)** Koehler --- AN ACT concerning government. **Short Debate**

A-S.B. 2556 -- **(Hoffman - Holbrook - Beiser - Reitz - Jackson)** Haine --- AN ACT concerning floodplains. **(CA 1) Short Debate**

S.B. 3117 -- **(Chapa LaVia - Mathias - Holbrook)** Garrett - McCarter --- AN ACT concerning education. **Short Debate**

S.B. 3346 -- **(May - Jakobsson - Winters - Schmitz - Feigenholtz)** Steans - Hunter - Risinger - Collins --- AN ACT concerning safety. **Short Debate**

S.B. 3389 -- **(Gordon, Jehan - Acevedo)** Millner - Haine --- AN ACT concerning criminal law. **Short Debate**

S.B. 3781 -- **(Colvin)** Collins --- AN ACT concerning regulation. **Short Debate**

Order of Resolutions

H.J.R. 105 -- Brauer --- Designates Barn 13 at the Illinois State Fairgrounds in Springfield as the J. Garrett and John J. Tolan Barn in recognition of the contributions of J. Garrett and John Tolan to agriculture in the State. (Agriculture & Conservation RBA)

H.J.R. 114 -- Bradley --- Designates the portion of Herrin Road/County Road 2 between Interstate 57 and Highway 149 as the U.S.M.C. Private Joseph W. Ozbourn Memorial Highway. (Transportation, Regulation, Roads RBA)

H.R. 967 -- Ford --- Urges Congress to pass legislation supporting banks that were affected by the government-sponsored enterprise fallout and the subsequent downturn in the economy to allow those banks for the 2010 tax year to go back 5 years for deductions of losses allowed for the 2008 and 2009 tax years. (Financial Institutions RBA)

A-H.R. 1000 -- Black --- Urges the Illinois Department of Natural Resources to cooperate and coordinate with the Illinois Greenways and Trails Commission in order to develop a model heritage water trail plan as well as national heritage waterways and other high quality recreational waterway trails and recreational opportunities. **(CA 1)** (Agriculture & Conservation RBA)

H.R. 1006 -- Senger - Pihos --- Urges the Comptroller to make payments to school districts for mandated categorical services by program when funding is available, rather than paying for all programs on a quarterly basis. (Elementary & Secondary Education RBA)

H.R. 1046 -- D'Amico - Gordon, Jehan --- Declares April 28, 2010 as Workers' Memorial Day in the State of Illinois. (Labor RBA)

Order of Resolutions

H.R. 1081 -- Senger --- Urges Congress to pass H.R. 3410, the Taking Responsible Action for Community Safety Act. (Judiciary II - Criminal Law RBA)

H.R. 1090 -- D'Amico --- Designates the month of April as Distracted Driving Awareness Month in the State of Illinois. (Vehicles & Safety RBA)
