The psychological and emotional scars for victims runs very deep but hope and healing can be found, especially when we come together as a society to provide the support victims need and help to prevent it in the very first place. So, I'd like to take a quick moment and just remind us of some of these signs of child abuse and encourage that we all utilize our social media platforms today, not to just post a picture of us in blue and with the hashtag, which is great, but also remind our constituents of some of the signs of child abuse. You know, withdrawal from friends or activities; change in behavior, such as aggressive anger, hostility, hyper activity, or change in school performance; depression; anxiety; unusual fears or a sudden loss of self-confidence; an apparent lack of supervision; frequent absence from schools; reluctant to leave school activities as if he or she doesn't want to go home; attempt at running away; rebellious defiant behavior; self-harm; or attempted suicides. Now, these are not all the signs and they can vary depending on the abuse the child is suffering. But today, as we wear blue and raise awareness for Child Abuse Prevention Month, let us also remember that we must all remain vigilant in watching for the signs, encouraging our constituents to remain vigilant. And please, if you see something, say something. Speaking up may not only stop child abuse, it may save a child's life. And I'd also like to give a special shout

Proponents includes Chicago FOP Lodge 7, Police Sergeants Association, Chicago Fire Firefighters Union, City of Chicago, Illinois Association of Chiefs of Police, and Illinois Sheriffs' Association. And just for a monetary number, it raises theirs from about 16,500 a year to about 19 thousand. I'm here for questions and would appreciate an 'aye' vote."

Mazzochi: "Yeah, well, I just want to state for the record and maybe the Governor will hear this when he... and do an Amendatory Veto, but getting rid of the temporary certificate of operation, it may very well be that the fire marshals aren't necessarily thinking about it. But from a building contractor perspective, the ability to have a temporary certificate of operation can be critical and actually can be very helpful to laborers because what it means is you might be able to send supplies up in a temporary elevator, which is going to take a lot of burden off of them so they're literally not carrying stuff off of stairs. SB1486 is brought forward, as many of you are familiar with the murder... because of the murder of Pam Knight and Deidre Silas. The Amendment basically is a full gut and replace, and it defines what pepper spray is, who will use it, how it'll be used, what happens if it's used, how to report the use, and annually reporting component brought forward by ACLU and that it will also be posted to the Web site. It also states that DCFS and ISP will identify the approved devices and jointly develop a training curriculum and program for proper use. It sets forward specific parameters that will limit the risk for our frontline workers and the families they serve."

It's very clear that the device may only be used when they believe... reasonably believes it's necessary to protect themselves from imminent physical danger posed by another person. They can only use the device to capacitate a person attempting physical assault in order to avoid imminent physical harm and to facilitate escape from danger when there is no other alternative."

Ammons: "And does this Bill also hold a person liable in any way, shape, or form? Are they going to be put on leave for investigation if they use these devices on someone?"

McCombie: "Well, if they use the devices improperly, regardless of any plan set in place, there will be... there could be a battery charge. However, the department and CMS, as well as AFSCME, will... through collective bargaining, will determine any sort of punishment through their collective bargaining."

Ammons: "So, currently as this stand, the Bill has no protections for abuse or misuse. There's no clear definition of negligent. They have to determine whether they feel like they're in danger or not. And all of that is based on subjective ideas of the person who's authorized to use it."

McCombie: "Well, it states point blank in it that the use of it is prohibited for reasons outside of their own personal protection. That being said, there is parameters set in place here in the Bill that are... that were brought forward between ACLU and AFSCME to help actually set up parameters. And just... I'd like to remind the Body that there is no... there's nothing stating in the law today that DCFS workers cannot carry. So, this Bill would directly set up parameters to have them carry. And actually, I think the most important thing, that it would be adding a training that would help them deescalate a situation so they would not have to be using it. It also is not a mandate for staff to carry. And if they do carry, they have to go through this training as well."

Ammons: "Thank you. To the Bill. This Bill does not solve any problems of the Department of Children and Family Services, nor does it actually offer any real protection for a worker. I use to be a worker, and whether I have mace or not, this does not offer any true protection for the workers. The Department of Children and Family Services needs to be

Just to remind people that there have been many, many, murders of innocent, unarmed African Americans in this very society with people who have many weapons on their hips and sides and very little accountability for the murders of innocent citizens. And so, once again, we want to arm and change our society into that which we think protection is violence and this is a violent mean to protect workers. I do not support this and ask our Members not to vote for it. I urge a 'no' vote on this measure."

Speaker Harris: "There are other Members seeking to speak. We are on the Order of Short Debate. One in favor, one in opposition. We have heard an opponent. Representative McCombie to close."

McCombie: "Thank you. Let me remind the Body that if this does not pass today, that is a win for DCFS workers because they will be able to carry without any parameters set in place. They will be able to carry without any approved devices known. They will be able to carry without any training. So, let me be clear that that can happen if this Bill does not pass today. And let me remind the Body that this Bill... you're absolutely right, Representative Ammons. DCFS needs a lot of work. We've talked about it, and we continue to talk about it. Will this end up saving lives? I don't know. But it sure

might've helped Pam Knight have three seconds to get away before she was brutally murdered by the hands of a man whose child she was checking on. And it also may have given Deidre Silas a second or three seconds to get away. That's the point of this. I have faith in our ISP and our DCFS workers that they are not going to be using this as a tool to hurt children. They are doing this only to protect themselves and to get away. Is this the end-all? Absolutely not. Will this be helpful in a knife fight? Probably not. Will this be helpful if they have a gun to their head? Probably not. But this is one tool we can give them and we can allow them to have parameters put in place. And the training that they're going to receive for this is also going to help them in other areas of their job performance. I ask for your support in the name of Pam Knight and the name of Deidre Silas and in the future name of anybody who might be in this position. Thank you."

I have... again, I have a problem with establishing floors on discussions between parties in their collective bargaining, especially

The problem is, is that then these women don't follow up and their early cancer turns into a more dangerous cancer. In the second part of the Amendment, improves access to HPV vaccines for those who want to get them. They would be... the Food and Drug Administration expanded the age at which the HPV vaccine is approved for up to age 45. Research shows that for women who have abnormalities, if they can get this vaccine, they have... it can reduce the

What Senate Bill 3930 does is to expand what must be included in DCEO's plan to facilitate this. And then also creates what we call the Border Community COVID-19 Mitigation Grant Program, subject to appropriation. So, in the first part, DCEO is required to add to the plan to make sure and notify small businesses and municipalities of all funding opportunities that the State of Illinois and the Federal Government are offering to small businesses and municipalities. And second, it requires notification to small businesses and municipalities whenever there are new restrictions placed upon those communities, as it may relate to COVID-19 public health emergency. Fortunately, most of those mitigations are... are gone, but in the worst-case scenario, if they were to come back, we'd want to make sure, especially in our border communities where the other states may have different mitigation strategies, to make sure that those local governments and small businesses are aware of what those restrictions are to make sure they can make... you know, make the best of a bad situation. And then second, the

It helps businesses and municipalities in being more economically competitive with bordering states. A question we had in committee that wasn't clear is, does this Bill include the City of Chicago?"

Halpin: "So, after committee, I did follow up with the department on that question to ask what the current definition, or how they interpret the current definition under the plan. Are we going to cut some income taxes? Are we going to cut some other taxes? It seems like that's quite to the contrary that we want to just tax everybody and pinpoint just a few. And so, I think this is the wrong policy. I think we need to be looking at some reform that helps everybody in this state to be more competitive with our neighbors across the border. Thank you."

Speaker Harris: "Representative Halpin to close."

Halpin: "You know, I appreciate the comments from the other side of the aisle. I would point out that one of the previous speakers talked about certain taxes that we have in Illinois. In my area, across the river in Iowa, there are dozens of services that are taxed that we don't tax in the State of Illinois. And I think anybody can play that game. The game that I want to play is, as cheerleader for the state, make sure that our border communities are an attractive place to live and work and to make sure that we help them out when we are faced with an unprecedented health emergency. On March 24, 2022, the Illinois Supreme Court told us that if we want to clearly ban this practice, the General

Assembly should pass a law to do it. The House can make this happen if just 16 Democratic Legislators agree to vote for HB2929 in the next few days. I sent a letter to Speaker Welch asking him to release it for a vote. Thus far, he's declined to respond, let alone act. But I can expect that from Speaker Welch. But it's sad that not a single Democrat in this chamber has shown their willingness to support HB29 (sic-2929), even in some amended form. I told you about this legislation here on the floor, that it would ban this practice. Not one of you came to talk to me about it or otherwise show your support. Not one of you was willing to stand for reform by signing on as a cosponsor. And not one of you even said that there was a way you could support it as long as we could make some language changes. Now, supposedly there are at least 19 of you who claim that you want to stand up against Mike Madigan's corruption and make for a better Illinois. But are you actually going to put a real vote behind your press conference promises? Because if you don't, each and every one of you in the Majority of this chamber who fails to act are effectively endorsing, with your inaction, that it's okay in Illinois for public official A to use their campaign funds to fund their criminal public corruption defense. And to the people of Illinois, we're down to the last seven days in the end of the Legislative Session. Mike Madigan is scheduled to go to trial in September. So, that means if that the Democratic Party won't do anything about this now, they ain't going to and he's going to be able to use all of those campaign funds. And they will prove, once again, that if you want to end public corruption and practices in Illinois, you can't
