For decades it was commonly understood by litigants and commonly recognized by courts that a person whose federal civil rights are violated can get damages for the emotional toll and distress this exacts when the discriminating entity receives federal assistance. Last year, a state... a U.S. Supreme Court decision reversed that longstanding jurisprudence, and the decision is likely to be relied upon by courts to deny emotional distress damages to persons subject to discrimination under several federal civil rights laws, including the Americans with Disabilities Act, the Civil Rights Act of '64, which prohibits discrimination based on race, color, or national origin, Title IX, or the Age Discrimination Act of 1975. Accordingly, the Civil Rights Remedies Restoration Act seeks to restore to Illinois citizens what for decades was the law of the land, the right

Continuing on page 28 of the Calendar, under House Bills-Third Reading, we have House Bill 2300, Representative Davis. Mr. Clerk, please read the Bill."

Clerk Bolin: "House Bill 2300, a Bill for an Act concerning finance. Third Reading of this House Bill."

Speaker Evans: "Representative Davis is recognized."

Davis, W.: "Thank you very much, Mr. Speaker. This is my first Bill, so if anybody would like to ... okay, maybe not. So, thank you, Ladies and Gentlemen of the House. House Bill 2300 is an initiative of the Illinois Department of Commerce and Economic... Department of Commerce and Economic Opportunity. Many of you may be familiar what is called the Illinois Works Program, which is a training program initiated by the state to help train individuals, particularly people of color and women, on... through an apprenticeship program so that they can have the opportunity to gain a skill and a trade and to be able to work on projects. What House Bill 2300 does, it seeks to make a few changes to the Illinois Works Program as follows: it provides Illinois Works pre-apprenticeship graduates with additional opportunities by incorporating them into existing apprenticeship initiative goals. It provides additional waiver eligibility for the aforementioned legislative change in the event there are insufficient Illinois Works pre-apprenticed graduates to meet the goal. It adds an accountability provision for noncompliance of

contractors to work with the program. It updates bid credit eligibility to encourage the hiring of Illinois Works preapprenticeship graduates by contractors. And it updates compliance certification to include all possible options. I'd

be more than happy to answer any questions." Speaker Evans: "Representative Keicher is recognized." Keicher: "Thank you, Mr. Speaker. Will the Sponsor yield?" Speaker Evans: "He indicates he will."

Keicher: "Representative, you and I both have the honor to work on the task force, or the panel that's working on it right now for Illinois Works, and I have a couple issues really centered around the availability and some of the issues that we have in the rural part of the state. Are there any penalties that are included in this provision?"

Davis, W.: "I believe there are some small penalties, yes."

Keicher: "And what is that small penalty level? If you can share with me. I'm trying to scroll through the analysis right now."

- Davis, W.: "According to my notes here, it could be the termination of a current contract, suspension from future participation for a period of not to exceed 3 years, financial penalty of up to 25 percent of the contract or agreement amount, or any combination thereof."
- Keicher: "And while this is a worthy goal that we're working towards on this commission, those are pretty hefty penalties, don't you think?"

Davis, W.: "No, they could be worse."

Keicher: "That's very true. They certainly could. One of the concerns that we have, Representative, especially in the rural areas and when we look at the number of graduates that

are coming out of the Illinois Works certified programs and we're specifically targeting those that are in that apprenticeship phase, we're worried about our contractors able to meet the criteria that we're setting out here. Have you had any discussions with labor or contractors on how to maybe close that in our more rural areas?"

- Davis, W.: "Well, I'm not sure if this... the conversation I had is the one you are referring to, but I have talked to the laborers and they have expressed some concerns. Nothing they said was a deal breaker to the effort, but they did have some additional thoughts that we're going to continue to work on in the Senate."
- Keicher: "Okay. So, there's probably something coming in the Senate on this that'll help fix it a little bit?"
- Davis, W.: "Well, I know with the laborers, what they brought. You know, again, those changes I think are palatable. I know they've talked to DCEO about it. And so, I expect, you know, there's some agreement on some of those changes that they'd like to see."
- Keicher: "So, again, to get on the record, when we're looking at 700 graduates, I believe is the number over the course of the year, and we have about 45 graduates per year, per program, we start to divide those up among the trades. And if we have 10, 15 different trades that are coming out of that Illinois Works Program, we're putting a very high bar in place with a very significant penalty. I just want to make sure that we're careful 'cause I don't know that that's working towards the goal that both you and I share about getting the right people in the right job in the right place in this state."

- Davis, W.: "Well, I can appreciate that and certainly appreciate your participation on the Works Panel Review meetings as we do this. And I can appreciate, when we talk about penalties and what that could mean or how that can be perceived, but I think it's ... I think, for me anyway, it's more about making sure that we are really trying to accomplish the goal. So, a penalty, and again, however you characterize it or feel about it, I think in this case we know penalties could be worse. At least from my perspective it could be worse. I can assure you, when they brought this to me and we talked about that, my thought was that they should be worse than what they have. And so, they felt differently about it. And so, I understand that you're trying to at least move the ball forward. At least put something in place that would encourage the contractors to participate in a more meaningful way to try to get to those numbers that we are working on. So, again, this may or may not be perfect in that respect, but I think it's an opportunity to move the ball forward. And if the concerns that you've talked about are those of the laborers, I know we're working to try to bring agreement to some of their concerns."
- Keicher: "Would you be open, along the way... again, we're trying to right size and get this. Would you be open, along the way, to maybe having a more regional approach to this so that our more urban areas near the city, where we have some significant problems, this is being more readily addressed, versus I hear from contractors all the time... and granted we're not talking about apprentices in the examples that have been shared with me. But we have folks that are an hour and 15 minutes away

from somebody in that trade that would help them satisfy this. And the appeal process is onerous, and with these increased penalties, I, again, worry that we're going to be chasing good work out of the rural areas of this state for something that's maybe not as attainable. I appreciate your argument. I'm going to vote 'no' on this for the time being and hopefully we'll see a little bit of a repair in the Senate."

Davis, W.: "Absolutely."

Keicher: "Thank you."

Davis, W.: "Thank you."

Speaker Evans: "Representative Davis to close."

Davis, W.: "Thank you very much, Mr. Speaker. Again, this is an effort to try to really ramp up the number of apprentishes ... apprenticeships or apprentices, excuse me, that come out of this program. And I know sometimes we are back and forth with penalties to someone or how we feel about that, but for me, this is something that we have to put in place to try to at least encourage the participation of those contractors. I am willing to acknowledge what Representative Keicher said about what that means in different parts of the state, and maybe there is a conversation that ensues to talk about how those numbers look in different parts of the state and how we can shape them to not necessarily make it so that someone is going to get a penalty but still hold that penalty there to make sure that they're all doing the right thing. So, with that, thank you very much for your participation, Representative Keicher. And for Members, I ask for a 'yes' vote."

And so, it adds language concerning a genetic predisposition as another way to access early screening. I'm happy to answer your questions."

Speaker Evans: "Representative Keicher is recognized." Keicher: "Thank you, Mr. Speaker. Will the Sponsor yield?" Speaker Evans: "She indicated she will."

Keicher: "Representative, we saw this in the Insurance Committee, and we had a little bit of a dialogue on this, and I saw a similar Bill in immigration. I think we're going to have some folks on our side that are both up and down on this for various reasons, but I just want to be very clear with what this Bill does. And from our analogy and information, we found out... or we believe that the Styrofoam, you can recycle it 100 percent, even if it's been used in food products. It can be used in other products. And I agree 100 percent that we don't want to put it into the landfills, but Styrofoam can be used for other products. And so, I would encourage a 'no' vote, and we can use Styrofoam in another ways. And the idea behind this Bill is to make some changes so our human service workforce can better access loan repayment, and I think most of us know that we have a pretty significant workforce shortage in Illinois. But in particular, we have a raging health care workforce shortage and a raging behavioral health care workforce shortage, of which human services is a part. And just to provide some color for how and why this relief is so needed, when I was a human service worker, after my bachelor's degree, I made \$9.40 an hour. And then after my

master's degree, I made \$15 an hour. So, these changes will bring relief to our Illinois human service sector. Happy to answer any questions."

- Windhorst: "Thank you, Representative. I noticed that this came through committee on a partisan vote. It appeared there was some opposition from our side. - Windhorst: "And their... this program is currently not funded to 100 percent? Is that accurate?"
- LaPointe: "That's accurate. The program is... was created in statute last year, and it's currently not funded."

Windhorst: "So, we don't have a great grasp yet on how it's working because of its newness, would that be fair to say?"

LaPointe: "Correct. It's not yet implemented because it's not funded."

Windhorst: "All right. I have no other questions."

Right now, there is no

Windhorst: "Representative, this applies just to adjunct professors and part-time professors. Is that..."

Stuart: "That is correct."

Windhorst: "Correct. Was there a reason full-time faculty or professors were not included?"

- Stuart: "There's a huge discrepancy in compensation when it comes
 to full-time tenured faculty and part-time. Often time an
 adjunct is teaching one course, maybe earning 1 thousand to
 3 thousand dollars over the entire semester and may have to
 pay up to \$200 of that in terms of a parking pass."
- Windhorst: "Well, I guess that raises the question, what about students parking? Why weren't they included in receiving free parking?"
- Stuart: "This is a very narrowly defined issue, just to the plight of adjunct professors."
- Windhorst: "Some of the complaints or concerns, I should say, received by our side is that the cost of parking is borne by those who use it and giving some free will cause those costs to be passed on to other individuals who maybe aren't being compensated like those staff members are. Would you care to address that?"
- Stuart: "Well, I mean... I'll point out that the institutions, you know, have not filed in opposition to this. I've been talking to them about this for quite a long time, and I think they have figured out that they are able to cover this cost. Partly because they pay many of these employees extremely low wages to begin with."

Windhorst: "Thank you for your answers."

Stuart: "Thank you."

Speaker Evans: "Representative Stuart to close."

Stuart: "I'd appreciate an 'aye' vote."

Harper: "Yes. We're using that definition."

- Harper: "Well, sure. We're going to make sure that there are connections. The connection is that these are environmental justice communities, communities that have an overburden of issues that are affecting the public's health. Be it air concerns, air quality, or water. And so, as we know, here in the State of Illinois, communities that do have environmental justice concerns are those same communities that suffer from a host of other concerns, just as my community does in the 6th District."
- Windhorst: "I guess another concern is, by putting these additional regulations and costs in, is that going to discourage investment in these communities, those that may want to invest..."
- Harper: "I don't think so. I think we're trying to find the right balance of encouraging business but also protecting the health of the residents who are in those same areas that the businesses inhabit."
- Windhorst: "I would say a \$200 thousand fee may be a cost prohibitive for some. To the Bill. Based on the fact that this is a large fee increase and that the environmental justice community term is very broadly written and may not have much connection to the goals of this Bill, I would encourage a 'no' vote."

Speaker Evans: "Representative Harper to close."

Harper: "Thank you. I encourage an 'aye' vote."

Ammons: "Yes. We've passed a companion Bill that hopefully will be discussed in the budget process, asking for a million dollars to be put into a grant fund for this particular program. I am not certain if that will actually get into the budget, but we are advocating for it."

House Bill 2531 requires that Illinois Department of Transportation to establish a process for prequalification of offers of public... of a public-private agreement. The department is given six months from the effective date to create such a process. And essentially what we are asking for this Bill, with this Bill, is that there's a lot of conversation about building a third airport in the Southland. And essentially what we're asking here is that IDOT put out a request for proposal, as I'm calling it, to see if there's anybody interested in doing so. Many people in the Southland feel that there is a developer who has the resources, the capacity, and the desire to build it, and they would love to be able to respond to this document. So, what we're asking is that IDOT put a document out there to see if there is a developer willing to respond. And lastly, whether or not there

is someone interested or not interested, again, that's what this process is all about. So, maybe we can answer the question once and for all and put this issue to bed. But we think there's someone out there willing... ready, willing, and able in order to do so. Be more than happy to answer any questions."

Windhorst: "Thank you, Mr. Speaker. Will the Sponsor yield?"

- Speaker Evans: "He indicates he will."
- Windhorst: "Do we have a cost estimate on this?"
- Davis, W.: "You mean on..."
- Windhorst: "Do we know how much it will cost?"
- Davis, W.: "For them to put the document out?"
- Windhorst: "Well, the entirety of not only this Bill but... first with this Bill, then the entirety of the project. Do we know?"
- Davis, W.: "Well, the Bill is asking them to put out an RFQ, so that should be minimal cost to them."
- Windhorst: "Right."
- Davis, W.: "It's up to the department."
- Windhorst: "And then, generally, can you speak to that?"
- Davis, W.: "Well, you mean to the RFQ?"

Windhorst: "To the cost, generally. What the potential cost could be. Do we even have an estimate that would be satisfactory?"

Davis, W.: "No. If you're talking about actually building the facility, I don't know... we don't know what the cost is, but that's what this document is about. Someone who can respond with information, someone that has this capacity, has this knowledge, who can respond to a document that could estimate

what it could bought... what it could cost to do this facility. So, the reality is we don't know."

Windhorst: "And what are the expected benefits from doing this?" "Well, if you talking about building an airport, I Davis, W.: simply direct you to O'Hare and Midway. With all the development that is around those areas, that is one thing that will certainly come by way of it. But there are ... I think we're approximately 10 thousand jobs to build the air... 50 thousand jobs to build the airport and could be as many as 10 thousand jobs for its continued operations. So, that is something that we expect from that as well. In the South Suburbs, where I am, we have seen the proliferation of Amazon facilities, their fulfillment centers, all throughout the South and Southwest Suburbs. So, right now, if a plane lands in Rockford, they've got to move that product all the way to South Suburbs. So, we're locked ... we're talking about efficiencies as well. If there is a airport facility there, then certainly it'll create efficiencies for those companies who would like to land planes there and then distribute their packages, or the same packages you and I would purchase, they'd have a much easier way of getting that done than currently what exists. And then lastly what I'll say, Representative, is that we are all Illinois Legislators. We talk about building in Illinois. Right now, those companies are looking at Gary, across the border, very close to where I am, as where they want to expand. And they want to expand there because, again, the ease of moving goods and packages from the Gary airport to the South Suburban fulfillment sites. So, this Bill is about moving that conversation forward to

try to see who is available, who is out there, and who has the willingness to be able to build such a facility in our region there."

- Windhorst: "A lot of times with projects timing is important. As it relates specifically to this Bill, why are you bringing this forward right now?"
- Davis, W.: "Well, the idea of building a third airport has been around for a number of years. At one point they thought about building a passenger airline, and that got met with a lot of resistance from the existing airports in the Chicagoland area that move passengers. They just said they didn't want the competition. So, over time it has now evolved so that it is now a cargo airport. And I've explained to you, with the proliferation of cargo logistic centers all throughout the South Suburbs, this facility could do all of those companies a great service if they're allowed to move goods and packages from that facility that could be 15 minutes away from them or a very short distance away from them as well."

Windhorst: "Is there anyone opposed to this Bill?"

- Davis, W.: "According to ILGA site, there are a few organizations opposed to it. The majority of them are open lands groups and environmental-style groups."
- Windhorst: "And it does look like from our analysis there may be both business and environmental concerns. Do you know what those concerns are? Have they expressed those to you?"
- Davis, W.: "Well, I think because we're talking about an open space, that may suffice with the open lands concern. There was a gentleman that testified in committee from one of the open lands groups... I don't want to get the two confused... but

he testified from an open lands group. As far as businesses are concerned, I think they're looking at the boom that could come relative to business development, as well as job development as well. Not only for Will County, Kankakee County, but coming north into South Cook County, as well as into the South Side of Chicago."

- Windhorst: "Specifically, we show the Chicagoland Chamber of Commerce is in opposition. Do you know what the nature of their opposition is?"
- Davis, W.: "Not talked to them. I could speculate, and I don't really want to do that. But no, I have not talked to the Chicagoland Chamber of Commerce."

Windhorst: "I have no other questions. Thank you."

Speaker Evans: "Representative Walsh is recognized."

Walsh: "Will the Sponsor yield?"

Speaker Evans: "He indicates he will."

Walsh: "So, Representative, just so I'm clear, this airport is one of the… probably the very first Bills that I voted on back in 2012, when I first came in, and we set up at P3 to do a public-private partnership with the third airport. That correct?"

Davis, W.: "I believe so."

Walsh: "And sometime around 2014, I believe the state bought Bult Field that was the beginning of the South Suburban airport in, I... you might have been out there for that signing. Is that true?"

Davis, W.: "I wasn't, but I think I remember..."

Walsh: "So, where I'm getting at is the state has owned this property for quite some time. The footprint of that airport

is all in play. And so, just for clarification, with this Bill, basically we're forcing or requesting that IDOT put out a request for qualifications to continue into this P3. Is that the intention?"

- Davis, W.: "Well, the request ... again, the request for qualifications, and I may be repeating what you just said, is to find out if there is, and I'm saying a developer, who has the capacity to build the facility. If ... for those who are opposed, and I'm not saying you are, but for those who are, let's answer the question. If nobody responds to it, and clearly no one has the interest in doing so. But what we do know is that the administration has embarked upon a couple of different studies to a) find out if cargo is sufficient there, which, I believe it is. And then the second that we've ... excuse me. The second that we've learned about is that what else can be built there. So, even for the open lands folks, something is going to be built there. I'm advocating for an airportstyle facility to move cargo, but something is going to be there. Over the last several years, the state has purchased the land, with the exception of about the, I believe, the last 500 acres or so, which is not critical to the operation of the facility but the buffer zones that need to be created around the facility. So ... "
- Walsh: "Thank you. I just wanted to clarify that all of this has been in limbo. It's left residents, farmers, et cetera, in kind of, you know, a question state that they don't know what's going on and moving this process forward would get more clarity, and I think that's your intention here. I'm

glad to support the Bill, and I urge an 'aye' vote. Thank you."

Sotomayor's legal aspirations came early. She decided she wanted to be an attorney at the age of 10 after watching Perry Mason. Consequently, she studied diligently through high school, graduating valedictorian of her class. She earned her bachelor's degree in history from Princeton University, graduating summa cum laude. At Yale Law School, Sotomayor cochaired the Latin American and Native American Students Association and worked as an editor for the Yale Law Journal. After graduating with her JD, she worked as an Assistant District Attorney before heading to private practice, focusing on intellectual property rights and copyright litigation. While sitting on the United States District Court for the Southern District of New York, Sotomayor became famous

for being the judge who saved Major League Baseball. Thanks to her strike ending decision in Silverman v. Major League Baseball Players Relations Committee, Inc. She served in the United States Court of Appeals for the Second Circuit for more than a decade, hearing more than 3 thousand cases and authoring around 380 majority opinions. Sotomayor was nominated and confirmed to the Supreme Court in 2009. The first case she heard was Citizens United v. Federal Election Commission, where she dissented from the majority. During her time on the court, Sotomayor continues to fight for the protection of affirmative action, upheld the Affordable Care Act twice, and ruled with the majority in Obergefell v. Hodges to legalize same-sex marriage in all 50 states. On top of her legendary legal career, Sotomayor lives with type 1 diabetes, having been diagnosed with type 1 diabetes at only seven years old. And she is living proof that one can succeed in life despite chronic health conditions. Sotomayor's intellect and passion for the law sets her apart as a legal giant and history maker. Her success is a prime example that anyone, even a girl from the projects, can rise and serve their country with honor and integrity. Thank you, Mr. Speaker." Speaker Evans: "Representative Sanalitro is recognized."

Sanalitro: "Thank you, Mr. Speaker. I rise to recognize Women History Month. In honor of Women's History Month, I would like to recognize a woman from District 48 who is making history every single day. Eva Rodgers is a PGA teaching professional at Medinah Country Club. She has been working in the male-dominated golf industry since 2012 and is truly leaving a mark on the hundreds of golfers that she works with.
