- Keicher: "Thank you, Mr. Speaker. Please let the record reflect Representatives Elik, McLaughlin, and David Friess are excused today."
- Speaker Hoffman: "The record shall reflect. Have all recorded themselves who wish? Have all recorded themselves who wish? Have all recorded themselves who wish? Mr. Clerk, please take... Mr. Clerk, please take the record. There being 104 Members answering the roll call, a quorum is present. Representative Grant, for what reason do you seek recognition?"
- Grant: "Thank you, Chair. A Madam of... excuse me, moment of personal privilege, please."

Speaker Hoffman: "State your point."

Grant: "I am here to rise for a personal point of privilege to remind us of the significance of this week, National Nurses Week, which takes place annually from May 6 to May 12. This is a time when we pause to recognize the invaluable contributions that nurses make to our communities and our state and our nation. At this point, I am going to make this speech a little bit more personal. My daughter, this is her second degree, just became a nurse. And I watched how she struggled and her classmates struggled to get through nursing school. It's grueling. The boards are hard. If you're not a good standardized test taker, too bad. You take the standardized test and you pass. She is now an ICU ... neuro ICU nurse at Loyola University Hospital. She sees a lot. She works very hard. All of our nurses work hard. Nurses are the backbone of our health care system. They work tirelessly, day in and day out, to provide the compassionate and expert care to the people of Illinois. From the smallest rural clinics to

the largest urban hospitals, nurses are there to offer support, comfort, and healing. They are often the first point of contact for the patient seeking medical attention and the last to say goodbye. During the COVID-19 pandemic, we witnessed the unwavering dedication of nurses as they faced unprecedented challenges. They risk their own health and safety to care for those who were suffering, often during long hours, under extreme conditions. Their courage and commitment to their profession are a testament to their character and inspiration to us all. I urge my fellow Members to join me in acknowledging the vital role nurses play in our society. Let us commit to supporting their ongoing education and professional development as well as advocating for policies that prioritize their well-being. To all nurses across Illinois and beyond, we say thank you. And, yes, nurses need to earn more money. Thank you."

Speaker Hoffman: "Representative Weaver."

Weaver: "Point of ... point of personal privilege."

Speaker Hoffman: "Please state your point."

Weaver: "Ladies and Gentlemen of the chamber, if I could have your attention, please. Today, we welcome a really, really special person to our chamber. A man who probably had more of an impact on my life than anybody outside of my family, my high school football coach, Jeff Alderman. Growing up, I thought that Coach Alderman was teaching me about football. But really, he was teaching me how to be a man. When he would yell at me to put down the barbells and stop doing curls and get my butt into the squat rack, he wasn't just teaching me about football. He was teaching me that to be successful in

life you got to do the hard things. When I would show up 30 seconds late to practice and he'd make me do a 100-yard bear crawls, I thought it was just something that football coaches did. But really, he was teaching me to be a man of your word and to hold up to your commitments, especially when it's about being a part of something that's bigger than yourself. When we would have our games, before we would start, we'd gather in a huddle and he'd give us kind of a pep talk. Then we'd take a moment of silence to reflect and say a prayer. And then he'd say, 'I love you guys. Let's go beat those sons a guns.' And what I now realize is that for a lot of teammates, it was probably the only time that week that they heard a father figure tell them that they loved them. We had some pretty good teams. We won a lot of games. But none of that compares to the thousands of young men who you taught how to grow up to be men, men who worked hard, men who honored their word, men who were full of compassion for their community because they knew that it was about being a part of something that was bigger than themselves. Coach Alderman, you could put the fear of God with me and in my heart better than anybody else, but I knew it at the time and I know it now, that it was done so with love. So, to any of you young guys that might be watching this, I want you to know, I love you quys. Go beat those sons of quns. Coach, I owe you a huge thanks and to all the coaches that I had throughout my life for the positive impact that you had on me that will not quickly be forgotten or lost. So, if you'll say it with me one last time, 'We bad. That's a fact, Jack. Go Eagles.'" Speaker Hoffman: "Representative Johnson."

Johnson: "Point of personal privilege, Mr. Speaker." Speaker Hoffman: "Please state your point."

Johnson: "There's a popular proverb... proverb used in Croatia, bez muke nema nauke. It means without hardship, there is no knowledge. Adrian Madunic, my Croatian friend, had been the region manager of our Illinois Department of Commerce and Economic Opportunity in Northwestern Illinois for 10 years, when, in January of 2022, he began having difficulty breathing and started seeking out answers in the Quad Cities. His trail eventually took him to University of Iowa Hospital as well as the Mayo Clinic. For six months, as Adrian's condition worsened through misdiagnosis after misdiagnosis, an infection disease specialist at Unity Point in Rock Island finally was able to find that Adrian had contracted histoplasmosis, a rare and fungal infection that often leads to death if untreated. This infection's found in Mississippi and Ohio River Valleys and derives from the spores in the soil and air when breathed in and can and will attack any part of the body, in particular the lungs and blood stream. Those particular at risk are farmers, landscapers, and construction workers. Adrian eventually took leave from his job and spent a month at Unity Point being treated, followed by two months of recovery in the hospital, and then five more months in physical therapy learning how to walk and use his hands and arms once again. The road was long, but he never gave up. On March 29 of this year, Adrian was finally able to return to work, representing the citizens in the State of Illinois. I'm not going to lie, I remember visiting him in the hospital last year and really thought we were going to

lose him. I should've known better than to estimate... underestimate the strength of my brother from Croatia and the healing power of love and prayer. His wife, Brandi, and daughter, Kellsey, have been inspiring our community for years through the Ribbons for Kellsey HOPE Mission that raises funds for helping those with epilepsy and autism. This is a family that continues to serve us in many capacities every day. Please join me, and many of his colleagues that are here today, in officially welcoming Adrian back to work. And please, let's give his family a warm Springfield welcome. They're up here to my left. Thank you, guys."

- Speaker Hoffman: "Members, we will be doing House Bills on Second Reading. We'll begin in page 2... on page 2 of the Calendar. On page 2 of the Calendar appears House Bill 300. Please read the Bill, Mr. Clerk. Representative Stuart."
- Clerk Bolin: "House Bill 300, a Bill for an Act concerning education. The Bill was read for a second time previously. No Committee Amendments. Floor Amendment #2 is offered by Representative Stuart."

Speaker Hoffman: "Representative Stuart on Floor Amendment #2." Stuart: "The Amendment becomes the Bill. Can we adopt the Amendment and then debate it on Third?"

- Speaker Hoffman: "Representative Stuart moves for the adoption of Floor Amendment #2 to House Bill 300. All those in favor signify by saying 'aye'; opposed 'nay'. In the opinion of the Chair, the 'ayes' have it. And the Amendment is adopted. Third Reading. Please read the Bill, Mr. Clerk."
- Clerk Bolin: "House Bill 300, a Bill for an Act concerning education. Third Reading of this House Bill."

Speaker Hoffman: "Representative Stuart on House Bill 300." Stuart: "Thank you, Mr. Speaker. House Bill 300 is an update to the teacher minimum salary Bill that we passed a few years back. When we passed that initial Bill, we set a ramp to get to the \$40 thousand and we had dollar salary amounts put in. And then we had basically a mechanism for it to follow inflation. I've had outreach from a lot of superintendents and school business officials and others and also from the union side that that was a little bit unclear. So, this just seeks to clarify so that everybody knows the exact inflation index that we're talking about when it comes time to set the next salary schedule."

Speaker Hoffman: "On this question, Leader Windhorst." Windhorst: "Thank you, Mr. Speaker. Will the Sponsor yield?" Speaker Hoffman: "Indicates she'll yield."

Windhorst: "Thank you. Representative, just to clarify a few things, does this Bill change the minimum teacher salary?"

Stuart: "So, the minimum teacher salary would have changed under previous legislation that had very broad bipartisan support in the past, so a change would be happening tied to inflation. This is just clarifying exactly what number and when that number is calculated."

Windhorst: "This Bill does not change that... that amount?"

Stuart: "No, it doesn't change the mechanism that was already in place for that to happen."

Windhorst: "And with regard to the six percent... sometimes it's referred to as a cap, but I don't believe that's the accurate term. But the six percent reimbursement..."

Stuart: "Right."

Windhorst: "...for the pension. Would you explain how that is impacted in this Bill?"

- Stuart: "Sure. So, what happens is if a district chooses to increase compensation to a point where it would be over six percent, then the district would be on the hook basically for those excessive pension costs. In this case, we may have districts that have to... I'll put it bluntly. First of all, most of our districts are at the 40 or, you know, will be there. This is going to impact very few districts and make change. But if because of this Act they have to raise salaries and it goes just above that six percent, instead of the district kind of being hit twice, only for those will that cap not be in effect."
- Windhorst: "So, just... for further clarification, the state has mandated a certain school district, then raised their minimum teacher salary."

Stuart: "Correct."

Windhorst: "That will cause some school districts to raise their salary greater than six percent."

Stuart: "Correct."

- Windhorst: "And the local taxpayer, through potential property tax increases, or the local school district would be the ones who would be paying for that pension cost above six percent." Stuart: "Correct."
- Windhorst: "So, this Bill would take that increase, which was a state mandate, and the state would handle the pension cost above six percent."

Stuart: "Perfectly stated. Thank you."

Windhorst: "All right. I wanted to make sure I had that correct."

Stuart: "Yes."

- Windhorst: "So, would you explain why there was a change to how... who determines what the inflationary increase is?"
- Stuart: "So, I had... this actually came to me from superintendents who, you know, addressed that there was... there could be a discrepancy in what inflationary number we're talking about when that number is taken, like what time of the year relative to when contract negotiations would begin. And the idea of this is this... you know, that is a floor when it comes to a negotiation on a new contract. Everyone's coming to the table with the same number as that absolute floor by making this make sense. We put it through COGFA as a neutral party, for lack of a better term."
- Windhorst: "And the General Assembly was previously supposed to be involved based on prior legislation, and we will not be involved with that calculation in the future. Is that correct?"
- Stuart: "There was a very, I guess, broad term or... it just said subject to review by the General Assembly, but no direct mechanism for what that meant. And we think that COGFA being the one to certify the number meets that necessity. Obviously, everything is subject to the General Assembly because here we are making a fix to an existing structure. And if we feel that another change needs to happen in a few years, we can always do that."
- Windhorst: "And so, you mentioned that there was bipartisan support for the minimum teacher salary. There were Members on our side that voted against the minimum teacher salary. If

someone was... a Member was against that Bill, why should they be for this Bill?"

Stuart: "I would say that... I mean, this is a mechanism that is in place. This speaks to a lot of those specific local property tax concerns that some districts had. And this will... it just makes that negotiating process better. And this, like I said, agreed upon by superintendents, by the labor unions, by everybody involved. It was a lot of negotiation and talk to get to this to make this all work well. So, I would say the minimum salary is in place. It was set to grow. This is clarifying how that growth is going to happen and our superintendents have had input on how that's going to happen."

Windhorst: "Thank you."

Speaker Hoffman: "Leader Davidsmeyer."

Davidsmeyer: "Thank you, Mr. Speaker. Will the Sponsor yield?" Speaker Hoffman: "She indicates she'll yield."

Davidsmeyer: "So, when the \$40 thousand minimum teacher salary came into place, it was an unfunded mandate passed by the State of Illinois. And I'm actually... I'm rising in support of this... this Bill because it takes a little bit of that unfunded mandate and it kind of rolls it back just a little bit to make sure that they don't have to pay the penalty on anything above six percent over... for the increase. Now, my concern is, I... I think that we should not only be looking at the individuals who were... the new teachers that were pushed up to the 40 percent. Are we... are we looking at all teachers who were increased or just increased to 40 percent?"

Stuart: "Well, when you increase to the 40 thousand or whatever it becomes based on inflation, you know, it's an entire salary structure..."

Davidsmeyer: "Correct."

Stuart: "...scale. So, every teacher in the district is impacted." Davidsmeyer: "So... so, it would take care of everybody..."

Stuart: "Correct."

Davidsmeyer: "...above them as well?"

Stuart: "Correct."

Davidsmeyer: "Okay. For this one-time adjustment?"

Stuart: "Well, whenever they adjust... because it will adjust every time they're going into a salary negotiation. Depending on what's happening with inflation, we will be at a different number."

Davidsmeyer: "Okay. And... and the minimum teacher salary is adjusted by CPI, correct?"

Stuart: "Correct."

Davidsmeyer: "So, that will go up. So, then, as it pushes the rest of their staff up, it will cover the entire school district, not just those minimum salaried teachers?"

Stuart: "Correct."

Davidsmeyer: "Okay. Just want to make sure. Thank you very much." Stuart: "Thank you. Thank you for your support."

Speaker Hoffman: "Representative Reick."

Reick: "Thank you, Mr. Speaker. Will the Sponsor yield?"

Speaker Hoffman: "She indicates she'll yield."

Reick: "Representative, is this... I understand the fact that we have a CPI adjustment that we have to examine in the state. And according to the original Bill, if my recollection is

correct, the General Assembly had the… had the ability to review that. I have two questions for you. Are we seeing this adjustment having to happen now because of our more hyperinflation times and we're hitting that… that number faster? And second of all, are we taking the ability of the General Assembly to review this out of this Bill… as a result of this Bill?"

- Stuart: "So, the reason we need to address this now is because, as I said, when we first put the minimum salary into place, we had a ramp to get to 40. And we are now at the point where in the next upcoming negotiations would be the first time that this CPI index would have an impact. And it was unclear exactly what we intended to be the CPI to be used. When ... is it just the timing of it and all of that. So, that's why this clarification needed to be done. And I'll be honest, this has been a discussion I have had with superintendents for the last few years, but a lot of them were, as a lot of us said, you know, building a plane, flying it at the same time, trying to get through COVID. So, we kept saying, we need to keep talking about this, we need to keep talking about this. But we were talking about much more urgent, pressing matters. And then we have finally had a little bit of breathing room time to hammer this out and to get to something that makes sense and is... so, like I said, we all know where we're starting from when we talk about the minimum."
- Reick: "So, what is our standard of CPI at this point, according to this Bill?"
- Stuart: "According to the Bill, 'In accordance with this Section, the Commission on Government Forecasting and Accountability

shall certify and publish the minimum salary rate to be used for the 2024-25 school year no later than September 30, 2023. By no later than July 20, 2024 and annually on or before each July 20 thereafter...'"

Reick: "So, do we know what the CPI rate is?"

- Stuart: "I don't have that handy right... I'm sure I could... someone could find it for me. I don't have it written down in front of me."
- Reick: "Does the General Assembly continue to have oversight on this?"
- Stuart: "Well, I... like I said, what it said in the original Bill was subject to review by the General Assembly. There was never a specific review system that it had to come through a committee or anything. Having this go through COGFA, that does have General Assembly oversight. And like I answered your Floor Leader, everything is subject to review by the General Assembly because we can take any... you know, any piece of legislation and consider it later and make changes to it. We do it... that we do that guite frequently."
- Reick: "But what you're saying is that this Bill takes... specifically takes away that review of the General Assembly and puts it into the... into COGFA. Is that what you're saying?" Stuart: "So, the question that was brought to me by the
- superintendents was, the original Bill said subject to review by the General Assembly, but we gave no indication of when that review was done, what the reporting is, and when it would be set and finalized. So, this takes..."

Reick: "I believe that that would ... "

Stuart: "...that discrepancy out."

Reick: "I don't think... to the Bill. I don't think that's a... necessarily a discrepancy. I think it's something that we should have defined in the original statute or in this... in this change, rather than transferring the responsibility of General Assembly review over to an independent agency. One which does very good work, I will be the first to admit. But the fact is, is that it is the General Assembly's job. And actually, trying to take away the General Assembly's responsibility for reviewing this, when it could have been defined in statute and made a lot more plain as to what those parameters were going to be would have been a much better way of doing this. Thank you, Mr. Speaker."

Speaker Hoffman: "Representative Stuart to close." Stuart: "I would just appreciate an 'aye' vote. Thank you." Speaker Hoffman: "The question is, 'Shall House Bill 300 pass?'

All those in favor vote 'aye'; all opposed vote 'nay'. The voting is open. Have all voted who wish? Have all voted who wish? Have all voted who wish? Mr. Clerk... Mr. Clerk, please take the record. Speaker Hoffman: "Representative West on Floor Amendment #1."

- West: "Thank you, Mr. Speaker. Floor Amendment #1 satisfies the concerns of all parties that's... that are a part of this Bill. I ask for its adoption."
- Speaker Hoffman: "Representative West moves for the adoption of Floor Amendment #1 to House Bill 2898. All those in favor signify by saying 'aye'; all opposed 'nay'. In the opinion of the Chair, the 'ayes' have it. And the Amendment is adopted. Third Reading. Mr. Clerk, please read the Bill."
- Clerk Bolin: "House Bill 2898, a Bill for an Act concerning education. Third Reading of this House Bill."

Speaker Hoffman: "Representative West."

West: "Thank you, Mr. Speaker. House Bill 2898 amends the Monetary Award Program, the MAP grant Section under the Private Business and Vocational Schools Act and under the Higher Education of Student Assistance Act by adding a subsection for the refund of MAP awards for a private business or a vocational school of higher education in Illinois if a judgement is found against the institution for using unfair or deceptive practices, as determined by the Federal Trade Commission. The Amendment ensures that... it satisfies the concerns of those representing the for-profit institutions. The focus of this Bill is primarily for for-profit higher education institutions. We are ensuring that they're using MAP grant funding for programming, for student education, more so than marketing or anything of... of that nature. If they are found to be deceptive, they will have to give it

back to the state. And if they're not, then this is something that good actors will not have to worry about. And so, I will entertain any questions and ask for its approval." Speaker Hoffman: "Leader Windhorst on House Bill 2898." Windhorst: "Thank you, Mr. Speaker. Will the Sponsor yield?" Speaker Hoffman: "He indicates he'll yield."

- Windhorst: "Representative West, I note... in the underlying Bill there was a partisan roll call in committee and there was opposition to the Bill. It appears with the Amendment that came unanimous out of committee, and the opposition was removed. Is that an accurate statement?"
- West: "That's accurate. The 'no' votes were mainly because I didn't have an Amendment in place yet. But then we did the work to satisfy everyone and brought forth the Amendment, and it came out unanimously."
- Windhorst: "And the opposition from the Illinois Coalition of Private Colleges and Universities, Chicagoland Chamber of Commerce, among others has also been removed with that Amendment?"
- West: "Based on what I saw a minute ago, after talking with the Republican spokesperson, I saw that they slipped in neutral. So, yes, we are good to go."

Windhorst: "Thank you."

West: "Thank you."

Speaker Hoffman: "Representative Swanson."

Swanson: "Thank you, Mr. Speaker. Will the Sponsor yield?"

Speaker Hoffman: "Indicates he'll yield."

Swanson: "Thank you, Sir. To Representative West, I know, and as pointed out by the Floor Leader here, that we were concerned

about some of the issues, and I appreciate you working with all those who were opposed to at least bring them to neutral. I know one of the things we were concerned about was the effective date. That this could've affected some institutions retroactively, which would have been difficult, in which you were able to negotiate and get that a set date to which they would work from. Also, it was unclear about who could make that determination. I think you worked well with the... the group and those in opposition to bring that to a positive ending. And then also, the Bill didn't specify any type of specific evidence that would be required, where that was brought together. And through your efforts and leadership, we were able to bring that to a... a good close. So, with that, I... I would urge an 'aye' vote. And great work. Thank you."

West: "Thank you, Sir."

West: "Thank you so much. I would appreciate a favorable roll call. Thank you."

Croke: "Mr. Speaker, Floor Amendment 2 just changes the effective date from July 2023 to January 2024."

- Speaker Hoffman: "Representative Croke moves for the adoption of Floor Amendment #2 to House Bill 2518. All those in favor signify by saying 'aye'; all opposed 'nay'. In the opinion of the Chair, the 'ayes' have it. And the Amendment is adopted. Third Reading. Please read the Bill, Mr. Clerk."
- Clerk Bolin: "House Bill 2518, a Bill for an Act concerning revenue. Third Reading of this House Bill."

Speaker Hoffman: "Representative Croke on House Bill 2518."

Croke: "House Bill 2518 adds engine repair to the exiting aircraft repair exemption. This tax exemption is expected to be revenue positive for the State of Illinois because engine repair work is currently not being done here in the state. Just for clarification, this exemption does not apply to commercial aircrafts and the entity doing the engine repair work receives the exemption. The Bill has bipartisan support, passed

Under the current Illinois Pesticide Act, the Department of Agriculture was limited to a \$750 fine for this terrible incident involving more than 20 exposed workers. Under the current Act, exposed humans are treated like animals or damaged crops. Incidents like the one that happened in this county should never happen again, and this legislation will deter sprayers from irresponsible behaviors around humans. So, what does actually SB203 do? It sets a minimum fine of \$500 for human pesticide exposure incidents. And when multiple humans are exposed, the fine will go up in a tiered manner. For 1 to 2 humans, \$500 per person. For 3 to 4 humans

exposed, \$750 per person. For far more... 5 or more humans exposed, 1,250 per person. I'm ready to take any questions." Speaker Hoffman: "On this question, Leader Windhorst." Didech: "Thank you, Mr. Speaker. Senate Bill 380 creates the Illinois Fertility Fraud Act, which creates a new civil cause of action for fertility fraud against health care providers, embryologists, or any other person involved in fertility treatment who knowingly or intentionally substitutes their own human reproductive material without the patient's consent. The conduct at issue in this Bill is shocking and disturbing, but it is surprisingly common. There are dozens of doctors in the United States who are known to have committed fertility fraud. Fertility fraud is a gross violation of all medical standards of care and egregiously violates the trust between doctors and patients. Because of the unusual nature of fertility fraud and the novel legal issues that it touches, the currently existing causes of

action are not well equipped to serve the victims. This conduct necessitates a specific cause of action, narrowly tailored to the harms caused to all the victims, including the mother, her partner, and the children involved. There are efforts in statehouses across the country to pass legislation on this matter as well as the United States Congress. Today, Illinois has an opportunity to join these efforts and give the victims of fertility fraud the tools they need to recover damages and to disincentivize this behavior going forward. Thank you for your consideration. I'm happy to answer any guestions."

- Speaker Hoffman: "Seeing no one seeking recognition, the question is, 'Shall Senate Bill 380 pass?' All those in favor vote 'aye'; all opposed vote 'nay'. The voting is open. And this Bill, having received a Constitutional Majority, is hereby declared passed. Representative Slaughter on Senate Bill 422. Mr. Clerk, please read the Bill."
- Clerk Bolin: "Senate Bill 422, a Bill for an Act concerning criminal law. Third Reading of this Senate Bill."

Speaker Hoffman: "Representative Slaughter."

Slaughter: "Thank you, Mr. Speaker and Ladies and Gentlemen of the House. Senate Bill 422 contains two provisions pertaining to the Illinois Department of Corrections. The first adds last known address, medical and dental records to the list of information the Illinois Department of Corrections shall collect and maintain in their master record file. This can be

critically important in regards to the care of the individuals in the Department of Corrections as well as creating a continuum of care as they reenter into society. The second main provision provides for Department of Corrections, in consultation with the Department of Information and Technology, to conduct an impact study to be completed on or before January 1, 2024 in regards to digitizing all the master record files of the inmates of the Department of Corrections. I know of no opposition. I urge a 'yes' vote."

- Speaker Hoffman: "Seeing no one seeking recognition, the question is, 'Shall Senate Bill 422 pass?' All those in favor vote 'aye'; all opposed vote 'nay'. The voting is open. Have all voted who wish? Have all voted who wish? Have all voted who wish? Mr. Clerk, please take the record. On this question, there are 98 voting 'yes', 6 voting 'no', 0 voting 'present'. And this Bill, having received a Constitutional Majority, is hereby declared passed. Moving to page 5 of the Calendar, appears Senate Bill 685, Representative DeLuca. Mr. Clerk, please read the Bill."
- Clerk Bolin: "Senate Bill 685, a Bill for an Act concerning local government. Third Reading of this Senate Bill."

Speaker Hoffman: "Representative DeLuca."

DeLuca: "Thank you, Mr. Speaker, Ladies and Gentlemen. Senate Bill 685 provides that townships on a cash basis or modified cash basis of accounting can only count levied tax funds towards their general assistance fund if received within their fiscal year. This issue was brought by Monee Township, who was being penalized when the records using yearly audits did not show the same figures as the tax objections lawsuits

brought by the county debt. It turned out that next year's levy was being added as income, though they did not receive it until after the close of the fiscal year. Senate Bill 685 will clarify this so the accrual method is not used. I ask for your support."

Speaker Hoffman: "On this question, Representative Halbrook." Halbrook: "Thank you, Mr. Speaker. A question of the Sponsor." Speaker Hoffman: "Sponsor yields."

- Halbrook: "Yeah. So, Representative, we had a... kind of a... we were trying to have a lengthy debate about it. We didn't get all these subjects aired out. We... I was concerned about the change in the definition of equipment to capital, and I'm not sure if you got clarification when that happened and why."
- DeLuca: "Yes, Representative, because it is exclusively... almost exclusively used towards savings for longer term capital improvements. That was the purpose for that definition change."
- Halbrook: "So, when did that definition change? I'm not seeing that come through. When did that change? Did it just... somebody decide to change it or did we pass legislation here to that effect?"

DeLuca: "No, it's in this Bill."

Halbrook: "Okay."

DeLuca: "It's in this Bill for the purpose of clarifying it."

Halbrook: "So, how would that affect other... I mean, if you change it in one code, wouldn't you have to change it for the municipalities and the counties and other things like that?"

- DeLuca: "No. This is only for townships, and it's only townships that are on the cash basis or modified cash basis. That's the... the clarification purpose."
- Halbrook: "So, as I dug into this matter, it looks like this township and many others and library... there was multiple local units of government that had been sued for the past four years. Are you aware of all those... those different suits?"
- DeLuca: "Well, I'm not sure which ones you're referring to, but I can speak to Monee Township."
- Halbrook: "Right. Well, there's been multiple ones in Will County, and it had nothing to do, nothing in those suits... and they were lengthy... lengthy multi-page suits and... and none of them that I can find talk about the accounting method. Okay? What it talked about was the taxation or the levy of funds that exceeded three, four, five, six, seven, eight, nine times the average annual expenses of the previous three years. That's why they were sued, is because they were overtaxing the residents of those respective districts. I... to me, the nature of this Bill is completely wrong. They've lost multiple suits, multiple years for overtaxing the residents of their... of their townships, library districts, whatever the case might be."
- DeLuca: "That may be the case in some townships. None of those have been brought to my attention. It's not... as far as I know, it's not the case here in Monee Township or other townships that are on the modified cash basis."
- Halbrook: "Yeah. Again, in the… in the tax lawsuits that I read, it didn't have anything to do with the accounting method. This is a matter of the residents of these districts have been overtaxed for multiple years. It violates the law that

caps those funds at three times... or two and a half times the average expenses of the last three years. Ladies and Gentlemen, I would urge a 'no' vote. Thank you."

Speaker Hoffman: "Representative DeLuca to close."

Basically, we're just reducing fees for the copies at the coroner's office after 20 years. Urge an 'aye' vote."

Podiatric physicians are our doctors of podiatric medicine. And this is consistent with

When you have other health care personnel giving immunizations, how is that recorded so that the… their health history is all in one place and easy to access?"
- Mah: "I believe many providers are connected through systems such as MyChart where everything is in a central location. And there are primary care providers that are also in contact with the specialists. So, my understanding is that there should be communication and that this is, you know, nothing unusual from what typically takes place."
- Hauter: "Okay. And then this was approved by the Illinois State Medical Society? Did they take a position?"

Mah: "Yes. Yes, they're in agreement."

Hauter: "Thank you very much."

Speaker Hoffman: "Seeing no one seeking further recognition, Leader Mah to close."

Scherer: "Thank you, Mr. Speaker. Today, I have Senate Bill 1351. It passed unanimously out of the Senate. And what it does is allows retiring teachers to waive their evaluation in the final year before they retire. I'd be happy to answer any questions and appreciate an 'aye' vote."

Speaker Hoffman: "On this question, Leader Windhorst." Windhorst: "Thank you, Mr. Speaker. Will the Sponsor yield?" Speaker Hoffman: "She indicates she'll yield." Windhorst: "Representative, this Bill is similar to House Bill

Windhorst: "And that vote was 86 to 18. Does that..."

Stuart: "I have 89 to 18, but it was a bipartisan."

Windhorst: "Yeah, 89 to 18 is correct."

Stuart: "Yeah."

Windhorst: "I stated that wrong. So, there were 18 Members on our side on House Bill 296 that voted 'no' that is identical to this Bill, prior to the Amendment. Thank you."

Senate Bill 1497 is an Hirschauer: initiative of our Senior Advisory Committee that I share with Senator Villa back in the district, and it addresses the unnecessary use of psychotropic drugs and physical restraints in nursing homes. According to a 2020 AARP report, Illinois was ranked one of the highest in the nation for unnecessary use of psychotropic drugs within nursing homes. This Bill addresses that by putting stricter limitations on the use of the drugs and requiring prescribing physicians to be forthright with the patients on the benefits and harms of medication. It also clearly defines the circumstances in which psychotropic drugs can be used. And in addition, it provides guidelines for administration of the drugs and the undue use of restraints to ensure that our residents are only using restraints when necessary. And I ask for your 'aye' vote."

Speaker Hoffman: "On this question, Leader Windhorst." Windhorst: "Thank you, Mr. Speaker. Will the Sponsor yield?" Speaker Hoffman: "She indicates she'll yield."

Windhorst: "Representative, initially, when the Bill was filed, HCCI was opposed, but the Amendment removed their opposition and moved them to neutral. Is that correct?"

Hirschauer: "That is correct. The Amendment in the Senate put them at neutral."

Windhorst: "Is there any known opposition to the Bill?" Hirschauer: "None."

Delgado: "Thank you, Mr. Speaker. Currently, Federal immigration law requires employers to verify that their employees are lawfully authorized to work in the United States. Employees do have the possibility, however, of receiving a no-match letter from the Social Security Administration for a variety of reasons, such as name changes, work authorizations, employment visas, and other bureaucratic errors. There have situations where employers terminate employees who receive a no-match letter, even though these employees could be legally working in the United States. So, Senate Bill 1515 addresses this issue by requiring that if an employer receives a nomatch letter from the Social Security Administration, they must provide the documents to the employee that are deficient, according to the no-match letter; provide instructions on how the employee can correct the deficiency and an explanation of the employee's right to have representation during the verification process; and finally, provide the employee 30 days of unpaid leave to correct any verification discrepancy. This is something that is currently in effect in 80 nursing homes across the State of Illinois. And I ask for an 'aye' vote."

Speaker Hoffman: "On this question, Representative Ugaste."

Senate Bill 1570 authorizes all municipalities and school districts to use the design-build delivery method for government contracts. House Bill... Senate Bill 1570 extends this authority to non-Home Rule municipalities and school districts using the same methods and procedures for evaluating and awarding contracts as the Design-Build

Procurement Act. Design-build means the designer architect of the project and the contractor for the completion of the project is the same person. This is in contrast to the designbid-build where the bidder is a contractor based on the bid specifications on a design previously created and provided to the contractor as part of the request for bids. Speaker Hoffman: "Leader Windhorst."

Windhorst: "Thank you, Mr. Speaker. Will the Sponsor yield?" Speaker Hoffman: "He indicates he'll yield."

legislation will make a technical change to existing legislation regarding death certificates for service members. Currently, local registrars or county clerks can provide a certified copy of death certificates at no charge for active duty or retired veterans, retired being defined as serving 20 years or more, and to the families at no cost. Senate Bill 1595 replaces the phrase 'retired' with 'honorably discharged veteran' in order to allow veterans who did not serve the requisite 20 years or more to take advantage of this program. The Department of Natural Resources will take over the underground railroad conductor recognition program established in Tazwell County, and currently available in Tazwell, Peoria, Woodford, and Sangamon Counties, marking the gravesites of the conductors of the underground railroad throughout the State of Illinois and maintain a website showing citizens the location of these markers and other underground railroad locations. The task force will work with the Department of Natural Resources to outline the best ways to promote new and existing underground railroad locations and highlight these locations to increase knowledge and education of these locations and how they're connected. I ask for your support."

Marron: "Thank you, Representative. And I know we talked about this a little bit in committee, and I think I shared some of our... our concerns in committee. So, this... just for

Syed: "Correct."

- Marron: "But... so, help me understand. It... it requires IDOT, but it also involves the University of Illinois. The university can be involved in the pilot project?"
- Syed: "They can be if they choose to be, but it allows for the... or for IDOT to incorporate them in that process if they'd like to be."
- Marron: "So, I think some of our concerns were just around the specificity of the… of the pilot program, exactly what all that entailed. And then also, were you able to get any kind of cost analysis on the program?"
- Syed: "So, once again, that'll be left up to IDOT, but we are giving a lot of discretion to IDOT to figure out how exactly they're going to come up with this pilot program and how they're going to execute it because we believe that they have the expertise when it comes to these kinds of matters related to bridges and viaducts."
- Marron: "Okay. So, I think, as I reiterated in committee, I think our... our concerns, or at least my concerns, were twofold. Just kind of the... the lack of specificity on the pilot program itself. And then also, including with that, a lack of a cost estimate. And then secondly, the fine that we're allowing IDOT to levy to truckers that may be involved in a situation like this. So, I'm going to lean towards 'no' on this, but I'm happy to... to listen to further debate and stay openminded. Thank you."
- Syed: "Thank you."

Speaker Hoffman: "On this question, Representative Fritts." Fritts: "Thank you, Mr. Speaker. Will the Sponsor yield?" Speaker Hoffman: "Indicates she'll yield."

- Fritts: "Representative Syed, we had a lot of great conversation about this Bill in committee. What is the nature of what you're bringing forward, this Bill?"
- Syed: "There have been very serious crashes into bridges and viaducts that threaten the safety of truck drivers, that threaten the safety of these bridges, collapses, infrastructure problems, and ultimately a cost on taxpayers. So, a numerous amount of issues that have brought forth this legislation."
- Fritts: "But didn't you talk about a specific bridge in committee that addressed your interest in this topic?"
- Syed: "Yeah, so there is one bridge that is in my district. It's not owned by IDOT, so it doesn't directly apply to this legislation. But the Chief Sponsor of the person in the Senate, Senator Ventura, who brought forth this Bill, has a bridge in Joliet in her district that has been hit numerous times, that has flipped over trucks, and has caused significant issues for the safety of people and the infrastructure in that area."
- Fritts: "Okay. Have you, yourself, ever driven an oversized
 vehicle?"
- Syed: "I do not have a commercial driver's license, so I have not driven an oversized vehicle. However, I have been on a ridealong with a police officer in my own district in an oversized vehicle. So, I have experience in that realm."

Fritts: "Okay. To the Bill."

Speaker Hoffman: "To the Bill."

Fritts: "Ladies and Gentlemen of the House, all bridges are very, very clearly marked, especially if they're under 13 feet, 6 inches. They're required to be. They're so marked that even the exits before the bridges, if you're on an interstate system, are clearly marked to let you know that you need to exit. I have driven an oversized vehicle many, many times, and there's a couple things that you have to remember when doing that. Your head has to be on a swivel, and as the driver, it's your responsibility to know the height of the vehicle that you're driving, even if it's going clear the set overpass. Any strike to a bridge is strictly operator error for not knowing ... not knowing. It's not IDOT's responsibility in that case. This Bill that you're talking about is not the answer to the problem that you're trying to seek. I would suggest an extra Rules of the Road lesson or CDL driver to this nature. Adding expense to taxpayers is ... is not the answer but... through this pilot program. I strongly encourage a 'no' vote. Thank you."

Speaker Hoffman: "Representative Benton."

Benton: "Thank you, Mr. Speaker. I'm an ironworker by trade, and I build bridges. And I actually work on these hazard bars that we're talking about right now. I've worked on the bridge that she's talking about in Joliet, that's part of my local. And this could end up saving money for the taxpayers. So, to the Bill."

Speaker Hoffman: "To the Bill."

Benton: "These hazard bars help save the infrastructure that's already in place, from having to put in the new infrastructure

going forward. It can save a lot of time from trucks actually going in and having to shut down a bridge after the damage that's put in, to have a structural engineer come out and inspect it afterwards. So, I think this is a good Bill, and this is going to save taxpayers in the long run by having that sacrificial hazard bar put in front of the bridge. And I urge an 'aye' vote on this... this Bill."

- Speaker Hoffman: "Seeing no one seeking further recognition, Representative Syed to close."
- Syed: "I just want to reiterate that there's no stakeholder opposition on this Bill. It passed out of the Senate unanimously. And to insist that we don't have an issue when you have issues like these where there are trucks that have collapsed on the road causing damage to infrastructure, causing cost on taxpayers, and causing threats to human life is absolutely preposterous to me. So, I urge an 'aye' vote for the safety of people, to save cost... costs on taxpayers, and to just build better infrastructure and make sure that it's being protected. Thank you."
