Clerk O'Brien: "House Bill 985, a Bill for an Act to add Section 10-8 to the Criminal Code of 1961. Third Reading of the Bill."

Speaker McPike: "Representative Daley"

Bill 985 would amend the Criminal Code, and it would create
a new offense for a unlawful sale of a public travel ticket

Daniels: "Will the Sponsor yield?"

Daniels: "We want to discuss your Bill a little bit, because the Republicans over on this side of the aisle understand that you're trying to rush this Bill through. Is that correct?"

Daley: "That is correct."

Daniels: "Just what we thought. Now if I understand correctly, this Bill prohibits the sale of a ticket for travel to an unemancipated minor under 17 years of age. Is that right?"

Daley: "Correct."

Daniels: "Now let me give this hypothetical. Taking urban flight, if a young person wants to open his sphere of influence and take a bus to DuPage County. You're trying to stop that?"

Daley: "Not to DuPage."

Daniels: "That's alright with you. But what if that same person wanted to take a bus ride to McHenry County?"

Daley: "Only outside of Illinois."

Daniels: "Only outside of Illinois?"

Daley: "Correct."

Daniels: "You have something against Iowa?"

Daley: "I love, I love Iowa."

Daniels: "Iowa, did you hear that? Republicans? This man has something against the University of Iowa."

Daniels: "The Hawkeyes."

Daniels: "Well some of the facts we look at: public conveyance now, an airplane, a boat, a bus, a railroad, a train. Now isn't that what your city needs? The RTA. Aren't you trying to encourage travel outside of the city? And other areas of the state."

Daley: "We encourage travel throughout the state and Chicago all the time, Lee."

Daniels: "Well Mr. Speaker, the Members on this side of the aisle are very concerned, because it's obvious that he's trying to rush this Bill through. And we may have to look at this very, very carefully before we decide whether or not to support it."

Speaker McPike: "Representative DeLeo."

DeLeo: "Thank you, Mr. Speaker, Members of the House. I have a personal interest in this Bill. Representative Daley was asked to put in legislation. Last summer there was a young girl by the name of Anna Marie DeLeo, who purchased... who was a 15 year old girl, who purchased a bus ticket at the Greyhound bus station in Chicago, Illinois. After being lost for approximately 12 or 14 days in the western states of the great U.S.A., the State's Attorney of Cook County, and the Illinois State Police were checking bus stations and distributing photographs of this young lady. When purchased a bus ticket at the Greyhound bus station in Chicago, the ticket agent asked this young girl, with her guitar and knap sack in hand, if she was she old enough to travel in her state, never checking any I.D. The young lady said that she left her driver's license in the car and she was still able to purchase a bus ticket. The grievance

that this family went through, the heartache for 12 or 14 days came to a climactic ending, when this girl was found alive in Oregon. This is not a joke this Legislation. This Legislation is to protect children, minor children leaving these facilities, O'Hare airport, Trailway bus station, Greyhound bus stations. This piece of Legislation is very important where we can have some sort of index, and some sort of control on children leaving the State of Illinois. And I urge a 'yes' vote in this matter."

Speaker McPike: "Representative Daley to close."

Daley: "Mr. Speaker and Members of the House, I would just ask for a favorable vote. As Representative DeLeo indicated, this was a personal friend that it occurred to. And hopefully this will prevent some runaways in the future and some daughters or sons, from being prevented and being caught in prostitution. I would ask for a favorable vote."

Speaker McPike: "The Gentleman moves for the passage of House Bill 985. The question is, 'Shall House Bill 985 pass?' All in favor vote 'aye', opposed vote 'no'. Representative Daniels."

Daniels: "Well Mr. Speaker, Ladies and Gentlemen of the House.

On behalf of the Republicans on this side of aisle, we have enjoyed Representative Daley as a Member of the House and wish him the well...wish him well in the future. Hope that his career is as long and distinguished as he chooses it to be, and as we know it will be. We send you off with good fond memories of your service here, John. And wish you the best and obviously wish your brother the best in his new duties as the Mayor of Chicago. And happy to join in the passage of this very important Bill."

Speaker McPike: "Representative Ryder."

Ryder: "Mr. Speaker, I would echo the kind words of the Minority Leader. However I was voting red for the reason that I'm

not sure that Representative soon to be Daley...Senator Daley can stand the pressure of the heavy work load within the Senate. And I realize that that will require him to accommodate a new life style and to be kind of laid back, but I would suggest that by sending him over we might be able to get some better results out of the Senate. Speaker McPike: "Representative Regan."

Regan: "Thank you Mr. Speaker, Members of the House. To the Bill first. To the Bill is very important, 85 percent of runaways are at high, high risk. The others don't get on that bus and they get back home. To John, who I've worked with in Jud. II. Over these short periods of months a great guy a long order guy and I'm going to miss you, John and believe me, it's not just because I have to travel in Chicago all the time. In the short time that I've been here, every one of you have made me grow to a better person, no matter what party you're from, no matter what section of the state you're from. I respect your district but I respect your friendship. the various committees we've served on, I think we've worked well. To the Members on the Republican side, I respect your voice and I hope the Republican voice is heard To the Leadership, I thank you for the assistance you've given me and the Bills that I've presented here behalf of the State's Attorney...former State's Attorney of Cook County, with your help Lee, and the help of your Members, his Bills passed from this chamber. To the Members on the Democratic side, from downstate, from the suburbs, I thank you each and every one of you. Members of the Chicago delegation, both black and white, because we're only one delegation and that's how I view it and I thank each and every one of you. I hope as we have a new Mayor, that the Chicago delegation will work together for the improvement of the City of Chicago. And finally to my good friend Jim DeLeo. From the day I walked in this place, he took me by the hand and showed me the ropes. I will never forget his friendship and will just grow much stronger.
