It is important that issues be pinpointed and conditions improved now, so that the ever increasing elderly population is handled effectively and humanly everywhere. We must move and be prepared with the waves of the future. We, as seniors, can bring so much to society with our years of experience, and I fully intend to do just that. I ask that you, as a Legislative Body, remember that we, as seniors, can give much to this state, but we need your input and concern in the fairness of the job market, and of course, the biggest concern we all have is the health care system. The quality of life for our senior citizens need be one of which we, as a nation and as a state can be very proud. Thank you very much."

I just am at another passage in my life and the senior citizens programs are becoming more meaningful to me, but I do want to invite all of you to come over and celebrate with me and have a piece of this wonderful cake that Sandy Huffman has made. She is one creator. So, you are all welcome to join in some birthday cake over here today."

Speaker Granberg: "Happy birthday, Mr. Johnson. Mr. Lyons."

Lyons: "Mr. Speaker and Members of the House of Representatives. Before they leave, I would like to introduce up in the northwest corner of the Gallery the Coalition of Polish American Women from Chicago. God bless you ladies on behalf of Joan Smuda and Marie Otto, thanks for coming down. Thank you, Mr. Speaker."

Speaker Granberg: "We are being visited today by former State Representative, State Senator Donnie Trotter. And Representative Connie Howard for purposes of an introduction. And Representative Todd Stroger. Representative Howard."

Howard: "I'd like my colleagues in the General Assembly to be aware of the fact that we are joined today by students from Chicago Vocational High School. They have been honored as one of five schools in the nation regarding education innovations. At this time, I would like to read along with Representative Stroger, a proclamation that has been prepared by Senator Trotter, regarding Chicago Vocational High School. Whereas the Members of the General Assembly

are honored to recognize Chicago Vocational High School in Chicago, Illinois and whereas, Chicago Vocational High School was named one of five schools in the nation to be used as a model for the restructuring the nation's secondary education system. U.S. Secretary of Education Richard W. Reilly announced that Chicago Vocational High School has been selected along with Hoover High School in San Diego, California, William Turner Technical High School in Miami, Florida, St. Louis Academy in St. Louis, Missouri, and Central Park East Secondary School in New York. And whereas, Chicago Vocational High School has restructured the school into eight mini schools, redesigned curriculum so that true academic and vocational integration occurred, personalized learning through the adoption of an academy structure developed and implemented a broad array of school, community, and business partnerships, invested in technical preparation, job training, intern and apprentice programs and initiated, or instituted that is, extensive teacher training programs that revolutionize pedagogy. And whereas, Chicago Vocational High School was selected as one of the lead schools of the fifty Schools Project sponsored by the Coalition of Essential Schools, each year several foreign and domestic educators tour Chicago Vocational High School seeking ideas and help in restructuring their own schools. And whereas, Chicago Vocational High School has a 99.9% African-American student population with an attendance of 2700. The school is located on the far southeast side of the city, 53.8% of the students are from low-income households, 67% go on to college upon graduation, 23% enter the work force or the armed services. And whereas, the Chicago Vocational High School received the Exemplary School Award for school

leadership sponsored by the Chicago Board of Education. Mrs. Betty Despenza Green, the school's principal has received many awards and honors for her hard work and efforts in restructuring the school. Together with her fine staff, Mrs. Despenza Green has completely redeveloped the curriculum and goals of the school, centering its focus on a work based environment which prepares the students for their future careers. Therefore, be it resolved and this is by the Senate of the 90th General Assembly of the State of Illinois, that we commend the Chicago Vocational High School's principal and staff for its exceptional work in restructuring the programs of the school to make viable and essential changes within the school and aiding in the development of its students. We recognize Chicago Vocational High School on receiving the honor of being named one of the five schools to be used as a model of restructuring by proclaiming April 30, 1997, a Chicago Vocational High School Day in the State of Illinois. And be it further resolved, that a suitable copy of this proclamation be presented to Mrs. Betty Despenza Green, principal of Chicago Vocational High School in Chicago."

Trotter: "Good afternoon, everyone. I take great pride and I'm very proud to have the student body, or some of the members of the student body from CVS to be here with us today. At a time that we're discussing in both Chambers, education reform, education finance reform and asking for teacher and parent accountability, CVS exemplifies what we're looking for. The U.S. Department of education has identified this school as being on the cutting edge of education reform. I have with me today, who will introduce members of her staff and members from the local school council, the Doctor Despenza Green."

Despenza Green: "Thank you, Senator Trotter, who has led the way in bringing us here and thanks to our Representatives Howard and Stroger. We are very very pleased and honored that the State of Illinois is acknowledging the kind of work that we are doing. We also appreciate, of course, the fact that the Federal Government did indeed acknowledge the hard work that we do along with the assistance of our parents, our local school council members and of course, the best students in the State of Illinois. I do want to, however, acknowledge the fact that with us today are a number of our students, there are some freshmen, sophomore, junior and senior students. So, if you can just kind of wave, you'll notice them over here. We would like to acknowledge that we also, along with us, are three of our staff members: Mr. Milton Norris, Mr. Carl Soretto and Mr. Paris Huston. In addition, I would be remiss and I am going to end because I know that educators are known to be winded, however, I'm going to ask the local school council president, and it is this Body that empowered the LSC, who has done so much for CVS and is certainly responsible for the kind of acknowledgement that we are getting. So, I would like Mr. Otha Miller, the president of our local school council to simply say, hello. Thank you."

Miller: "Good afternoon, parents, friends, LSC members from Chicago Vocational High School. What is so ironic about us being here today, is that as you debate the funding reform, you mostly hear about the negative things that happen in Chicago public school systems, public school system per se. But I want to say there are great things that are happening in the public school system, particularly in Chicago. And I think as you debate the refunding issue you will see that those dollars are well spent. CVS just received national

Howard: "CVS is not only just a great academic center, it has also provided us with Jewan Howard of the Bullets, Chris Sorrage, Chicago Bears, Dick Butkus, Chicago Bears, I think everybody knows him. But right now, I would like to introduce our State Superintendent of Education, Joseph Spagnolo, to give the principal an award."

Spagnolo: "Thank you very much, Representative. It is my pleasure, on behalf of the Illinois State Board of Education, to present Doctor Betty Despenza Green a certificate of appreciation. The certificate reads, 'The Chicago Vocational High School in recognition of meritorious service, your devotion to excellence in education in the State of Illinois is appreciated and commended by the Illinois State Board of Education. Your service to the educational community and to the people of the State of Illinois is an example worthy of emulation.' I want to congratulate the principal, the local school council and the student body."

Green: "Thank you so much for welcoming our students."
