INDIANA The Legislature is considering a measure that would prohibit nepotism in township government. Peggy Kerns of NCSL's Ethics Center says that while family hires sometimes can make sense, but "when public money is involved, there should be a lot of effort to make (hiring) an open process." At the state level, Indiana is considered to have some of the toughest nepotism laws.

The changes include a revision to the revolving door law as applicable to state employees, more timely and complete personal financial disclosure by executive branch officials, and a pay-to-play provision.

The House Ethics and Elections Committee is also studying a change to the state's personal financial disclosure law for elected officials.

The bill seeks to codify a district court decision that ruled the Senate and Assembly are the only bodies with the power to discipline their members for actions related to the legislative process. The House is considering comprehensive ethics reform legislation that would mandate ethics training, expand the definition of lobbyist, provide for electronic filling of campaign finance and lobbying activity, and change the Ethics Commission's process for investigating a complaint, among other provisions. The Governor also plans to introduce reform legislation, the most sweeping overhaul of the state's ethics laws since 1973, according to his office.

ILLINOIS The General Assembly, other public officials, and good government groups are examining a variety of reforms centered on campaign finance, lobbyist disclosure, revolving door, gift bans, contracting with government, and the Freedom of Information Act. President Cullerton and Speaker Madigan have created the 16-member Joint Committee on Government Reform, a bipartisan effort to consider these and other ethics reform issues.

The recent revelations resulting from Governor Blagojevich's impeachment and the appointment of U.S. Senator Roland Burris have triggered a proposals in both chambers requiring that U.S. Senate vacancies be filled by a special election rather than governor appointment. A House resolution reprimanding Senator Roland Burris and calling for his expulsion was also filed. There is yet another House bill circulating asks the U.S. Senate Ethics Committee to conduct an investigation.

MISSISSIPPI A Senate bill that would have banned state agencies and departments from using general funds to hire contract lobbyists and limited legislators from receiving campaign contributions during the state's legislative session narrowly failed to pass. The legislation was filed after a six-month study by the Senate Ethics Committee into the use of contract lobbyists by state agencies.

There are three House proposals that would create an ethics commission that remain in the bipartisan ethics committee.

After the first vote, the Senate held a second, deciding again by 59 to 0 to bar Mr. Blagojevich from ever holding public office again in Illinois.

ILLINOIS The impeachment trial of Governor Blagojevich began in the Senate. Senators are examining one article of impeachment that lists 13 actions by the Governor demonstrating an abuse of power. The Senate is scheduled to meet for six straight days, breaking only on Sunday, after which they will resume meeting if necessary. The Constitution requires that 40 of 59 senators must find the Governor guilty in order to remove him from office.

LOUISIANA The Ethics Board will be asked to appoint a temporary administrator next week, one who would likely serve through the end of the

legislative session in late June. The Board has been without an administrator since June 2008, despite a civil service search for a replacement. UTAH A recent poll shows that 79 percent of surveyed registered voters believe that most or all of the state's legislators behave ethically, but 87 percent want an independent ethics commission created to investigate complaints against legislators. WISCONSIN The Assembly will vote on a rule that bans members from fundraising while developing the state budget. The ban on fundraising would last from the date the Governor introduces the budget until it is signed into law. The Senate has no plans to adopt a similar rule, although there has been support for it in the past.

UTAH House Republicans have presented ethics reform bills that would create a one-year cooling-off period before state legislators or elected state executives can become registered lobbyists. The GOP proposals would also further restrictions on legislative gift-taking, restrict personal use of campaign funds after leaving office and require more timely filing of campaign contribution reports. Utah House Democrats have criticized the plan saying that certain contributions that currently must be reported will become exempt from reporting under the GOP proposal. The Desert News. NEW MEXICO The investigation into whether Gov. Bill Richardson's aides had steered a consulting contract to a political backer has highlighted the lack of ethics laws in New Mexico. New Mexico is one of a handful of states that have no caps on campaign donations and has no independent ethics commission to investigate potential conflicts of interest.

MASSACHUSETTS Governor Deval Patrick unveiled new comprehensive reforms aimed at restoring public confidence in state government. His proposal would give the Secretary of State subpoena powers over lobbyists and political campaign records. Additionally, the State Ethics Commission would be permitted to share information with the State Inspector General, the Attorney General, and several other enforcement offices.

ILLINOIS For the first time in state history, the House voted to impeach the Governor upon the recommendation from the investigatory committee charged with examining the case. The chair of the committee stated that the Governor Blagojevich's actions had betrayed the public trust and proved he was unfit to govern. The Governor has said he will not resign.

MASSACHUSETTS Governor Patrick proposed an overhaul of ethics and lobbying laws after reviewing recommendations made by his ethics task force. Among the suggested reforms are granting subpoena power to the Secretary of State, wiretapping authority to the Attorney General, increased fines for violation of conflict of interest laws, a greater gift ban restriction, and a broader definition of "lobbying."
