## Be it enacted by the People of the State of Illinois, represented in the General Assembly:

- Section 5. The Illinois Income Tax Act is amended by changing Section 704A as follows:
- 6 (35 ILCS 5/704A)
- 7 Sec. 704A. Employer's return and payment of tax withheld.
- 8 (a) In general, every employer who deducts and withholds or 9 is required to deduct and withhold tax under this Act on or 10 after January 1, 2008 shall make those payments and returns as
- 11 provided in this Section.
- 12 (b) Returns. Every employer shall, in the form and manner 13 required by the Department, make returns with respect to taxes 14 withheld or required to be withheld under this Article 7 for 15 each quarter beginning on or after January 1, 2008, on or 16 before the last day of the first month following the close of 17 that quarter.
- 18 (c) Payments. With respect to amounts withheld or required 19 to be withheld on or after January 1, 2008:
- 20 (1) Semi-weekly payments. For each calendar year, each
  21 employer who withheld or was required to withhold more than
  22 \$12,000 during the one-year period ending on June 30 of the
  23 immediately preceding calendar year, payment must be made:

- (A) on or before each Friday of the calendar year, for taxes withheld or required to be withheld on the immediately preceding Saturday, Sunday, Monday, or Tuesday;
- (B) on or before each Wednesday of the calendar year, for taxes withheld or required to be withheld on the immediately preceding Wednesday, Thursday, or Friday.

Beginning with calendar year 2011, payments made under this paragraph (1) of subsection (c) must be made by electronic funds transfer.

- (2) Semi-weekly payments. Any employer who withholds or is required to withhold more than \$12,000 in any quarter of a calendar year is required to make payments on the dates set forth under item (1) of this subsection (c) for each remaining quarter of that calendar year and for the subsequent calendar year.
- (3) Monthly payments. Each employer, other than an employer described in items (1) or (2) of this subsection, shall pay to the Department, on or before the 15th day of each month the taxes withheld or required to be withheld during the immediately preceding month.
- (4) Payments with returns. Each employer shall pay to the Department, on or before the due date for each return required to be filed under this Section, any tax withheld or required to be withheld during the period for which the

1 return is due and not previously paid to the Department.

- (d) Regulatory authority. The Department may, by rule:
- (1) Permit employers, in lieu of the requirements of subsections (b) and (c), to file annual returns due on or before January 31 of the year for taxes withheld or required to be withheld during the previous calendar year and, if the aggregate amounts required to be withheld by the employer under this Article 7 (other than amounts required to be withheld under Section 709.5) do not exceed \$1,000 for the previous calendar year, to pay the taxes required to be shown on each such return no later than the due date for such return.
- (2) Provide that any payment required to be made under subsection (c)(1) or (c)(2) is deemed to be timely to the extent paid by electronic funds transfer on or before the due date for deposit of federal income taxes withheld from, or federal employment taxes due with respect to, the wages from which the Illinois taxes were withheld.
- (3) Designate one or more depositories to which payment of taxes required to be withheld under this Article 7 must be paid by some or all employers.
- (4) Increase the threshold dollar amounts at which employers are required to make semi-weekly payments under subsection (c)(1) or (c)(2).
- (e) Annual return and payment. Every employer who deducts and withholds or is required to deduct and withhold tax from a

person engaged in domestic service employment, as that term is defined in Section 3510 of the Internal Revenue Code, may comply with the requirements of this Section with respect to such employees by filing an annual return and paying the taxes required to be deducted and withheld on or before the 15th day of the fourth month following the close of the employer's taxable year. The Department may allow the employer's return to be submitted with the employer's individual income tax return or to be submitted with a return due from the employer under Section 1400.2 of the Unemployment Insurance Act.

- (f) Magnetic media and electronic filing. Any W-2 Form that, under the Internal Revenue Code and regulations promulgated thereunder, is required to be submitted to the Internal Revenue Service on magnetic media or electronically must also be submitted to the Department on magnetic media or electronically for Illinois purposes, if required by the Department.
- (g) For amounts deducted or withheld after December 31, 2009, a taxpayer who makes an election under subsection (f) of Section 5-15 of the Economic Development for a Growing Economy Tax Credit Act for a taxable year shall be allowed a credit against payments due under this Section for amounts withheld during the first calendar year beginning after the end of that taxable year equal to the amount of the credit for the incremental income tax attributable to full-time employees of the taxpayer awarded to the taxpayer by the Department of

1 Economic Opportunity under Commerce and the Economic 2 Development for a Growing Economy Tax Credit Act for the taxable year and credits not previously claimed and allowed to 3 be carried forward under Section 211(4) of this Act as provided 5 in subsection (f) of Section 5-15 of the Economic Development 6 for a Growing Economy Tax Credit Act. The credit or credits may 7 not reduce the taxpayer's obligation for any payment due under this Section to less than zero. If the amount of the credit or 8 9 credits exceeds the total payments due under this Section with 10 respect to amounts withheld during the calendar year, the 11 excess may be carried forward and applied against 12 taxpayer's liability under this Section in the succeeding 13 calendar years as allowed to be carried forward under paragraph (4) of Section 211 of this Act. The credit or credits shall be 14 applied to the earliest year for which there is a tax 15 16 liability. If there are credits from more than one taxable year 17 that are available to offset a liability, the earlier credit shall be applied first. Each employer who deducts and withholds 18 or is required to deduct and withhold tax under this Act and 19 20 who retains income tax withholdings under subsection (f) of 21 Section 5-15 of the Economic Development for a Growing Economy 22 Tax Credit Act must make a return with respect to such taxes 23 and retained amounts in the form and manner that 24 Department, by rule, requires and pay to the Department or to a 25 depositary designated by the Department those withheld taxes 26 not retained by the taxpayer. For purposes of this subsection

- (q), the term taxpayer shall include taxpayer and members of 1 the taxpayer's unitary business group as defined under 2 paragraph (27) of subsection (a) of Section 1501 of this Act. 3 This Section is exempt from the provisions of Section 250 of 4 this Act. No credit awarded under the Economic Development for 5 a Growing Economy Tax Credit Act for agreements entered into on 6 7 or after January 1, 2015 may be credited against payments due 8 under this Section.
- 9 (h) An employer may claim a credit against payments due 10 under this Section for amounts withheld during the first 11 calendar year ending after the date on which a tax credit 12 certificate was issued under Section 35 of the Small Business 13 Job Creation Tax Credit Act. The credit shall be equal to the 14 amount shown on the certificate, but may not reduce the 15 taxpayer's obligation for any payment due under this Section to 16 less than zero. If the amount of the credit exceeds the total 17 payments due under this Section with respect to amounts withheld during the calendar year, the excess may be carried 18 19 forward and applied against the taxpayer's liability under this 20 Section in the 5 succeeding calendar years. The credit shall be applied to the earliest year for which there is a tax 21 22 liability. If there are credits from more than one calendar 23 year that are available to offset a liability, the earlier credit shall be applied first. This Section is exempt from the 24 25 provisions of Section 250 of this Act.

- 8 Sec. 5-5. Definitions. As used in this Act:
- 9 "Agreement" means the Agreement between a Taxpayer and the 10 Department under the provisions of Section 5-50 of this Act.
- 11 "Applicant" means a Taxpayer that is operating a business
- 12 located or that the Taxpayer plans to locate within the State
- 13 of Illinois and that is engaged in interstate or intrastate
- 14 commerce for the purpose of manufacturing, processing,
- assembling, warehousing, or distributing products, conducting
- 16 research and development, providing tourism services, or
- 17 providing services in interstate commerce, office industries,

"Committee" means the Illinois Business Investment Committee created under Section 5-25 of this Act within the Illinois Economic Development Board.

"Credit" means the amount agreed to between the Department and Applicant under this Act, but not to exceed the lesser of:

(1) the sum of (i) 50% of the Incremental Income Tax attributable to New Employees at the Applicant's project and (ii) 10% of the training costs of New Employees; or (2) 100% of the Incremental Income Tax attributable to New Employees at the Applicant's project. However, if the project is located in an underserved area, then the amount of the Credit may not exceed the lesser of: (1) the sum of (i) 75% of the Incremental Income Tax attributable to New Employees at the Applicant's project

and (ii) 10% of the training costs of New Employees; or (2) 100% of the Incremental Income Tax attributable to New Employees at the Applicant's project. If an Applicant agrees to hire the required number of New Employees, then the maximum amount of the Credit for that Applicant may be increased by an amount not to exceed 25% of the Incremental Income Tax attributable to retained employees at the Applicant's project; provided that, in order to receive the increase for retained employees, the Applicant must provide the additional evidence required under paragraph (3) of subsection (b) of Section 5-25.

"Department" means the Department of Commerce and Economic Opportunity.

"Director" means the Director of Commerce and Economic Opportunity.

"Full-time Employee" means an individual who is employed for consideration for at least 35 hours each week or who renders any other standard of service generally accepted by industry custom or practice as full-time employment. An individual for whom a W-2 is issued by a Professional Employer Organization (PEO) is a full-time employee if employed in the service of the Applicant for consideration for at least 35 hours each week or who renders any other standard of service generally accepted by industry custom or practice as full-time employment to Applicant.

"Incremental Income Tax" means the total amount withheld during the taxable year from the compensation of New Employees

- and, if applicable, retained employees under Article 7 of the Illinois Income Tax Act arising from employment at a project
- 3 that is the subject of an Agreement.

## "New Employee" means:

- (a) A Full-time Employee first employed by a Taxpayer in the project that is the subject of an Agreement and who is hired after the Taxpayer enters into the tax credit Agreement.
  - (b) The term "New Employee" does not include:
  - (1) an employee of the Taxpayer who performs a job that was previously performed by another employee, if that job existed for at least 6 months before hiring the employee;
  - (2) an employee of the Taxpayer who was previously employed in Illinois by a Related Member of the Taxpayer and whose employment was shifted to the Taxpayer after the Taxpayer entered into the tax credit Agreement; or
  - (3) a child, grandchild, parent, or spouse, other than a spouse who is legally separated from the individual, of any individual who has a direct or an indirect ownership interest of at least 5% in the profits, capital, or value of the Taxpayer.
- (c) Notwithstanding paragraph (1) of subsection (b), an employee may be considered a New Employee under the Agreement if the employee performs a job that was

25	"Professional Employer Organization" (PEO) means an

employee leasing company, as defined in Section 206.1(A)(2) of

1 the Illinois Unemployment Insurance Act.

"Related Member" means a person that, with respect to the Taxpayer during any portion of the taxable year, is any one of the following:

- (1) An individual stockholder, if the stockholder and the members of the stockholder's family (as defined in Section 318 of the Internal Revenue Code) own directly, indirectly, beneficially, or constructively, in the aggregate, at least 50% of the value of the Taxpayer's outstanding stock.
- (2) A partnership, estate, or trust and any partner or beneficiary, if the partnership, estate, or trust, and its partners or beneficiaries own directly, indirectly, beneficially, or constructively, in the aggregate, at least 50% of the profits, capital, stock, or value of the Taxpayer.
- (3) A corporation, and any party related to the corporation in a manner that would require an attribution of stock from the corporation to the party or from the party to the corporation under the attribution rules of Section 318 of the Internal Revenue Code, if the Taxpayer owns directly, indirectly, beneficially, or constructively at least 50% of the value of the corporation's outstanding stock.
- (4) A corporation and any party related to that corporation in a manner that would require an attribution

of stock from the corporation to the party or from the party to the corporation under the attribution rules of Section 318 of the Internal Revenue Code, if the corporation and all such related parties own in the aggregate at least 50% of the profits, capital, stock, or value of the Taxpayer.

(5) A person to or from whom there is attribution of stock ownership in accordance with Section 1563(e) of the Internal Revenue Code, except, for purposes of determining whether a person is a Related Member under this paragraph, 20% shall be substituted for 5% wherever 5% appears in Section 1563(e) of the Internal Revenue Code.

"Taxpayer" means an individual, corporation, partnership, or other entity that has any Illinois Income Tax liability.

"Underserved area" means a geographic area that meets one or more of the following conditions:

- (1) the area has a poverty rate of at least 20% according to the latest federal decennial census;
- (2) 75% or more of the children in the area participate in the federal free lunch program according to reported statistics from the State Board of Education;
- (3) at least 20% of the households in the area receive assistance under the Supplemental Nutrition Assistance Program (SNAP); or
- (4) the area has an average unemployment rate, as determined by the Illinois Department of Employment

- Security, that is more than 120% of the national unemployment average, as determined by the U.S. Department of Labor, for a period of at least 2 consecutive calendar
- 4 years preceding the date of the application.

  - (1) The election under this subsection (f) may be made only by a Taxpayer that (i) is primarily engaged in one of the following business activities: water purification and treatment, motor vehicle metal stamping, automobile manufacturing, automobile and light duty motor vehicle manufacturing, motor vehicle manufacturing, light truck and utility vehicle manufacturing, heavy duty truck manufacturing, motor vehicle body manufacturing, cable television infrastructure design or manufacturing, or wireless telecommunication or computing terminal device design or manufacturing for use on public networks and (ii) meets the following criteria:
    - (A) the Taxpayer (i) had an Illinois net loss or an Illinois net loss deduction under Section 207 of the Illinois Income Tax Act for the taxable year in which

the Credit is awarded, (ii) employed a minimum of 1,000 full-time employees in this State during the taxable year in which the Credit is awarded, (iii) has an Agreement under this Act on December 14, 2009 (the effective date of Public Act 96-834), and (iv) is in compliance with all provisions of that Agreement;

(B) the Taxpayer (i) had an Illinois net loss or an Illinois net loss deduction under Section 207 of the Illinois Income Tax Act for the taxable year in which the Credit is awarded, (ii) employed a minimum of 1,000 full-time employees in this State during the taxable year in which the Credit is awarded, and (iii) has applied for an Agreement within 365 days after December 14, 2009 (the effective date of Public Act 96-834);

(C) the Taxpayer (i) had an Illinois net operating loss carryforward under Section 207 of the Illinois Income Tax Act in a taxable year ending during calendar year 2008, (ii) has applied for an Agreement within 150 days after the effective date of this amendatory Act of the 96th General Assembly, (iii) creates at least 400 new jobs in Illinois, (iv) retains at least 2,000 jobs in Illinois that would have been at risk of relocation out of Illinois over a 10-year period, and (v) makes a capital investment of at least \$75,000,000;

(D) the Taxpayer (i) had an Illinois net operating loss carryforward under Section 207 of the Illinois

Income Tax Act in a taxable year ending during calendar year 2009, (ii) has applied for an Agreement within 150 days after the effective date of this amendatory Act of the 96th General Assembly, (iii) creates at least 150 new jobs, (iv) retains at least 1,000 jobs in Illinois that would have been at risk of relocation out of Illinois over a 10-year period, and (v) makes a capital investment of at least \$57,000,000; or

- (E) the Taxpayer (i) employed at least 2,500 full-time employees in the State during the year in which the Credit is awarded, (ii) commits to make at least \$500,000,000 in combined capital improvements and project costs under the Agreement, (iii) applies for an Agreement between January 1, 2011 and June 30, 2011, (iv) executes an Agreement for the Credit during calendar year 2011, and (v) was incorporated no more than 5 years before the filing of an application for an Agreement.
- (1.5) The election under this subsection (f) may also be made by a Taxpayer for any Credit awarded pursuant to an agreement that was executed between January 1, 2011 and June 30, 2011, if the Taxpayer (i) is primarily engaged in the manufacture of inner tubes or tires, or both, from natural and synthetic rubber, (ii) employs a minimum of 2,400 full-time employees in Illinois at the time of application, (iii) creates at least 350 full-time jobs and

retains at least 250 full-time jobs in Illinois that would have been at risk of being created or retained outside of Illinois, and (iv) makes a capital investment of at least \$200,000,000 at the project location.

- (1.6) The election under this subsection (f) may also be made by a Taxpayer for any Credit awarded pursuant to an agreement that was executed within 150 days after the effective date of this amendatory Act of the 97th General Assembly, if the Taxpayer (i) is primarily engaged in the operation of a discount department store, (ii) maintains its corporate headquarters in Illinois, (iii) employs a minimum of 4,250 full-time employees at its corporate headquarters in Illinois at the time of application, (iv) retains at least 4,250 full-time jobs in Illinois that would have been at risk of being relocated outside of Illinois, (v) had a minimum of \$40,000,000,000 in total revenue in 2010, and (vi) makes a capital investment of at least \$300,000,000 at the project location.
- (1.7) Notwithstanding any other provision of law, the election under this subsection (f) may also be made by a Taxpayer for any Credit awarded pursuant to an agreement that was executed or applied for on or after July 1, 2011 and on or before March 31, 2012, if the Taxpayer is primarily engaged in the manufacture of original and aftermarket filtration parts and products for automobiles, motor vehicles, light duty motor vehicles, light trucks and

utility vehicles, and heavy duty trucks, (ii) employs a 1 2 minimum of 1,000 full-time employees in Illinois at the time of application, (iii) creates at least 250 full-time 3 Illinois, (iv) relocates iobs in its corporate headquarters to Illinois from another state, and (v) makes a capital investment of at least \$4,000,000 at the project 6 7 location.

- (2) An election under this subsection shall allow the credit to be taken against payments otherwise due under Section 704A of the Illinois Income Tax Act during the first calendar year beginning after the end of the taxable year in which the credit is awarded under this Act.
- (3) The election shall be made in the form and manner required by the Illinois Department of Revenue and, once made, shall be irrevocable.
- (4) If a Taxpayer who meets the requirements of subparagraph (A) of paragraph (1) of this subsection (f) elects to claim the Credit against its withholdings as provided in this subsection (f), then, on and after the date of the election, the terms of the Agreement between the Taxpayer and the Department may not be further amended during the term of the Agreement.
- (g) A pass-through entity that has been awarded a credit under this Act, its shareholders, or its partners may treat some or all of the credit awarded pursuant to this Act as a tax payment for purposes of the Illinois Income Tax Act. The term

- 1 "tax payment" means a payment as described in Article 6 or
- 2 Article 8 of the Illinois Income Tax Act or a composite payment
- 3 made by a pass-through entity on behalf of any of its
- 4 shareholders or partners to satisfy such shareholders' or
- 5 partners' taxes imposed pursuant to subsections (a) and (b) of

At 17 18 the request of the Board, the Director of Commerce and Economic 19 Opportunity or his or her designee, the Director of the 20 Governor's Office of Management and Budget or his or her 21 designee, the Director of Revenue or his or her designee, the 22 Director of Employment Security or his or her designee, and an elected official of the affected locality, such as the chair of 23 24 the county board or the mayor, may serve as members of the 25 Committee to assist with its analysis and deliberations.

  - (3) That, if not for the Credit, the project would not occur in Illinois, which may be demonstrated by evidence that receipt of the Credit is essential to the Applicant's decision to create new jobs in the State, such as the magnitude of the cost differential between Illinois and a competing State; in addition, if the Applicant is seeking an increase in the maximum amount of the Credit for retained employees, the Applicant must provide any means

including, but not limited to, evidence the Applicant has multi-state location options and could reasonably and efficiently locate outside of the State, or demonstrate demonstration that at least one other state is being considered for the project, or evidence the receipt of the Credit is a major factor in the Applicant's decision and that without the Credit, the Applicant likely would not create new jobs in Illinois, or demonstration that receiving the Credit is essential to the Applicant's decision to create or retain new jobs in the State.

- (4) A cost differential is identified, using best available data, in the projected costs for the Applicant's project compared to the costs in the competing state, including the impact of the competing state's incentive programs. The competing state's incentive programs shall include state, local, private, and federal funds available.
- (5) The political subdivisions affected by the project have committed local incentives with respect to the project, considering local ability to assist.
- (6) Awarding the Credit will result in an overall positive fiscal impact to the State, as certified by the Committee using the best available data.
- (7) The Credit is not prohibited by Section 5-35 of this Act.

  - (4) A requirement that the Taxpayer shall maintain operations at the project location that shall be stated as a minimum number of years not to exceed 10.
  - (5) A specific method for determining the number of New Employees employed during a taxable year.
  - (6) A requirement that the Taxpayer shall annually report to the Department the number of New Employees, the Incremental Income Tax withheld in connection with the New Employees, and any other information the Director needs to perform the Director's duties under this Act.
  - (7) A requirement that the Director is authorized to verify with the appropriate State agencies the amounts reported under paragraph (6), and after doing so shall

issue a certificate to the Taxpayer stating that the amounts have been verified.
