1 AMENDMENT TO HOUSE BILL 482

2 AMENDMENT NO. _____. Amend House Bill 482 by replacing
3 everything after the enacting clause with the following:

4 "Section 5. The Public Library District Act of 1991 is
5 amended by changing Section 15-15 as follows:

6 (75 ILCS 16/15-15)

7 Sec. 15-15. Territory included within municipality or
8 school district.

9 (a) A district may, by ordinance and referendum, annex
10 territory if that territory is:

11 (1) located within the boundaries of a municipality or
12 school district that is included, entirely or partially,
13 within the district;

14 (2) contiguous to the district; and

15 (3) without local, tax-supported public library
16 service.

1 An ordinance under this subsection must describe the territory
2 to be annexed. Prior to adopting the ordinance, the board of
3 trustees of the library district shall send notice of the
4 proposed ordinance to the president of the board of trustees of
5 each public library located within one mile of the territory to
6 be annexed. The library district may, in addition, provide
7 notice of a proposed annexation ordinance on a website
8 maintained by the library district. At any meeting of the board
9 of trustees in which an annexation ordinance under this Section
10 is considered, the board shall provide a reasonable opportunity
11 for any interested person to make public comments on the
12 proposed annexation ordinance.

13 (b) Within 15 days of the passage of the annexation
14 ordinance, the library district shall send notice of the
15 adoption of the ordinance, a copy of the map showing the
16 boundaries of the territory to be annexed, and a copy of the
17 text of the publication notice required in this Section to the
18 president of the board of trustees of each public library with
19 territory within one mile of the territory to be annexed.
20 Within 15 days after the adoption of the ordinance it shall be
21 published as provided in Section 1-30. The board may vacate an
22 annexation ordinance before its publication.

23 (c) The publication or posting of the ordinance shall
24 include a notice of ~~(i) the specific number of voters required~~
25 ~~to sign a petition requesting that~~ the question of the adoption
26 of the ordinance to be submitted to the voters of the district

1 or the territory to be annexed and ~~or both, (ii) the time in~~
2 ~~which the petition must be filed, and (iii) the date of the~~
3 prospective referendum. ~~The district secretary shall provide a~~
4 ~~petition form to any individual requesting one.~~

5 (d) Upon the passage of the annexation ordinance under this
6 Section ~~If no petition is filed with the library district~~
7 ~~within 30 days after publication or posting of the ordinance,~~
8 ~~the annexation shall take effect. If, however, within the 30~~
9 ~~day period, a petition is filed with the Board of Trustees of~~
10 ~~the library district, signed by voters of the district or the~~
11 ~~territory to be annexed, or both, equal in number to 10% or~~
12 ~~more of the total number of registered voters in the district,~~
13 ~~the territory to be annexed or both, asking that the question~~
14 ~~of the annexation of the territory be submitted to the voters~~
15 ~~of the territory, the board of trustees shall may vacate the~~
16 ~~annexation ordinance or~~ certify the question to the proper
17 election authority, who shall submit the question at the next
18 regular election. Notice of this election shall be given and
19 the election shall be conducted in accordance with the Election
20 Code. The proposition shall be submitted to the voters in
21 substantially the following form:

22 Shall (description of territory) be annexed to (name of
23 public library district), (location), Illinois?

24 (e) If a majority of votes cast upon the proposition in the
25 district, and also a majority of votes cast upon the
26 proposition in the territory to be annexed, are in favor of the

1 proposition, the Board of Trustees of the library district may
2 conclude the annexation of the territory.

3 (f) If, before the effective date of this amendatory Act of
4 the 100th General Assembly ~~this amendatory Act of the 94th~~
5 ~~General Assembly~~, a district has annexed territory under this
6 Section ~~and that annexation complies with the requirements set~~
7 ~~forth in this Section, as changed by this amendatory Act of the~~
8 ~~94th General Assembly, then, for all purposes~~, that annexation
9 is hereby validated, ratified, and declared to be in full force
10 and effect. ~~from: (i) 30 days after publication or posting of~~
11 ~~the ordinance if no petition was filed with the library~~
12 ~~district under subsection (d); or (ii) if a petition was filed,~~
13 ~~on the date that the district concluded the annexation of the~~
14 ~~territory under subsection (e).~~
