1 AN ACT concerning transportation.

Be it enacted by the People of the State of Illinois, represented in the General Assembly:

Section 5. The State Finance Act is amended by adding
Section 5.878 as follows:

7 <u>Sec. 5.878. The Prostate Cancer Awareness Fund.</u>

8 Section 10. The Illinois Vehicle Code is amended by 9 changing Section 3-699.14 as follows:

11 Sec. 3-699.14. Universal special license plates.

12 (a) In addition to any other special license plate, the Secretary, upon receipt of all applicable fees and applications 13 14 made in the form prescribed by the Secretary, may issue Universal special license plates to residents of Illinois on 15 behalf of organizations that have been authorized by the 16 17 General Assembly to issue decals for Universal special license plates. Appropriate documentation, as determined by the 18 19 Secretary, shall accompany each application. Authorized 20 organizations shall be designated by amendment to this Section. When applying for a Universal special license plate the 21

applicant shall inform the Secretary of the name of the 1 2 authorized organization from which the applicant will obtain a 3 decal to place on the plate. The Secretary shall make a record of that organization and that organization shall remain 4 5 affiliated with that plate until the plate is surrendered, revoked, or otherwise cancelled. The authorized organization 6 7 may charge a fee to offset the cost of producing and 8 distributing the decal, but that fee shall be retained by the 9 authorized organization and shall be separate and distinct from 10 any registration fees charged by the Secretary. No decal, 11 sticker, or other material may be affixed to a Universal 12 special license plate other than a decal authorized by the 13 General Assembly in this Section or a registration renewal 14 sticker. The special plates issued under this Section shall be 15 affixed only to passenger vehicles of the first division, 16 including motorcycles and autocycles, or motor vehicles of the 17 second division weighing not more than 8,000 pounds. Plates issued under this Section shall expire according to the 18 multi-year procedure under Section 3-414.1 of this Code. 19

(b) The design, color, and format of the Universal special license plate shall be wholly within the discretion of the Secretary. Universal special license plates are not required to designate "Land of Lincoln", as prescribed in subsection (b) of Section 3-412 of this Code. The design shall allow for the application of a decal to the plate. license plates shall comply with rules adopted by the Secretary 1 governing the requirements for and approval of Universal 2 3 special license plate decals. The Secretary may, in his or her discretion, allow Universal special license plates to be issued 4 5 as vanity or personalized plates in accordance with Section 6 3-405.1 of this Code. The Secretary of State must make a version of the special registration plates authorized under 7 8 this Section in a form appropriate for motorcycles and 9 autocycles.

10 (c) When authorizing a Universal special license plate, the 11 General Assembly shall set forth whether an additional fee is 12 to be charged for the plate and, if a fee is to be charged, the 13 amount of the fee and how the fee is to be distributed. When 14 necessary, the authorizing language shall create a special fund 15 in the State treasury into which fees may be deposited for an 16 authorized Universal special license plate. Additional fees 17 may only be charged if the fee is to be paid over to a State agency or to a charitable entity that is in compliance with the 18 19 registration and reporting requirements of the Charitable 20 Trust Act and the Solicitation for Charity Act. Any charitable entity receiving fees for the sale of Universal special license 21 22 plates shall annually provide the Secretary of State a letter 23 of compliance issued by the Attorney General verifying that the entity is in compliance with the Charitable Trust Act and the 24 25 Solicitation for Charity Act.

renewal period, in addition to the appropriate registration 1 2 fee, if applicable, the Secretary shall collect any additional 3 fees, if required, for issuance of Universal special license plates. The fees shall be collected on behalf of the 4 5 organization designated by the applicant when applying for the plate. All fees collected shall be transferred to the State 6 7 agency on whose behalf the fees were collected, or paid into 8 the special fund designated in the law authorizing the 9 organization to issue decals for Universal special license 10 plates. All money in the designated fund shall be distributed 11 by the Secretary subject to appropriation by the General 12 Assembly.
