SYNOPSIS AS INTRODUCED:

Proposes to amend the Executive Article of the Illinois Constitution. Eliminates the Office of Lieutenant Governor, beginning with the term of office otherwise commencing in 2019, and modifies the order of succession to the Office of the Governor. Effective upon being declared adopted.

3	RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE
4	HUNDREDTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE SENATE
5	CONCURRING HEREIN, that there shall be submitted to the
6	electors of the State for adoption or rejection at the general
7	election next occurring at least 6 months after the adoption of
8	this resolution a proposition to amend Article V of the
9	Illinois Constitution by changing Sections 1, 2, 3, 6, and 7
10	and by repealing Sections 4 and 14 as follows:
11	ARTICLE V
12	THE EXECUTIVE
13	(ILCON Art. V, Sec. 1)
14	SECTION 1. OFFICERS
15	The Executive Branch shall include a Governor, Lieutenant
16	Governor, Attorney General, Secretary of State, Comptroller
17	and Treasurer elected by the electors of the State. They shall
18	keep the public records and maintain a residence at the seat of
19	government during their terms of office.

- 1 SECTION 2. TERMS
- 2 These elected officers of the Executive Branch shall hold
- 3 office for four years beginning on the second Monday of January
- 4 after their election and, except in the case of the Lieutenant
- 5 Governor, until their successors are qualified. They shall be
- 6 elected at the general election in 1978 and every four years
- 7 thereafter.

- 10 SECTION 3. ELIGIBILITY
- To be eligible to hold the office of Governor, Lieutenant
- 12 Governor, Attorney General, Secretary of State, Comptroller or
- 13 Treasurer, a person must be a United States citizen, at least
- 25 years old, and a resident of this State for the three years
- 15 preceding his or her election.

- 18 SECTION 4. JOINT ELECTION (REPEALED)
- 20 Governor, one vote shall be cast jointly for the candidates
- 21 nominated by the same political party or petition. The General
- 22 Assembly may provide by law for the joint nomination of
- 23 candidates for Governor and Lieutenant Governor.

SECTION 6. GUBERNATORIAL SUCCESSION

- (a) In the event of a vacancy, the order of succession to the office of Governor or to the position of Acting Governor shall be the Lieutenant Governor, the elected Attorney General, the elected Secretary of State, the elected Comptroller, the elected Treasurer, the President of the Senate, the Speaker of the House of Representatives, the Minority Leader of the Senate, and the Minority Leader of the House of Representatives. If an officer next in the line of succession is of a different political party than the Governor he or she is replacing, then that officer, and each officer thereafter, shall be skipped in the line of succession until an officer of the same political party may succeed the Governor. If there is no officer in the line of succession of the same political party as the Governor to be replaced, then succession shall proceed according to the order of succession provided in this subsection (a), regardless of the political party of the succeeding officer and then as provided by law.
 - (b) If the Governor is unable to serve because of death, conviction on impeachment, failure to qualify, resignation or other disability, the office of Governor shall be filled by the officer next in line of succession for the remainder of the term or until the disability is removed.
 - (c) Whenever the Governor determines that he may be

- seriously impeded in the exercise of his <u>or her</u> powers, he <u>or</u>

 <u>she</u> shall so notify the Secretary of State and the officer next

 in line of succession. The latter shall thereafter become

 Acting Governor with the duties and powers of Governor. When
- 5 the Governor is prepared to resume office, he <u>or she</u> shall do
- so by notifying the Secretary of State and the Acting Governor.

 (d) The General Assembly by law shall specify by whom and
- 9 resume office may be questioned and determined. The Supreme

by what procedures the ability of the Governor to serve or to

- 10 Court shall have original and exclusive jurisdiction to review
- 11 such a law and any such determination and, in the absence of
- 12 such a law, shall make the determination under such rules as it
- may adopt.

- 16 SECTION 7. VACANCIES IN OTHER ELECTIVE OFFICES
- 17 If the Attorney General, Secretary of State, Comptroller or
- 18 Treasurer fails to qualify or if his <u>or her</u> office becomes
- 19 vacant, the Governor shall fill the office by appointment. The
- 20 appointee shall hold office until the elected officer qualifies
- 21 or until a successor is elected and qualified as may be
- 22 provided by law and shall not be subject to removal by the
- 23 Governor. If the Lieutenant Governor fails to qualify or if his
- 24 office becomes vacant, it shall remain vacant until the end of
- 25 the term.

- 3 SECTION 14. LIEUTENANT GOVERNOR DUTIES (REPEALED)
- 4 The Lieutenant Governor shall perform the duties and
- 5 exercise the powers in the Executive Branch that may be
- 6 delegated to him by the Governor and that may be prescribed by
- 7 law.
