10	(a) Any agency or instrumentality of the State of Illinois
11	or unit of local government may seek recovery for the cost of
12	the repair or replacement of damaged or destroyed roadway
13	property. As used in this Section, "roadway property" includes
14	road safety equipment and emergency equipment. Depreciation
15	may not be used as a factor in determining the cost of the
16	damaged or destroyed roadway property for which recovery is

1 sought.

2	(b) Any agency or instrumentality of the State of Illinois
3	or unit of local government may seek recovery for the cost of
4	the repair of damaged or destroyed highways, highway
5	structures, or traffic-control devices that result from
6	operating, driving, or moving a truck tractor-semitrailer
7	combination exceeding 55 feet in overall dimension authorized
8	under paragraph (1) of subsection (b) or paragraph (1) of
9	subsection (f) of Section 15-107 of the Illinois Vehicle Code.
10	The measure of liability for the damage is the cost of
11	repairing the highway, highway structure, or traffic-control
12	device, or the depreciated replacement cost of a highway
13	structure or traffic-control device.

Section 10. The Illinois Vehicle Code is amended by changing Section 15-107 as follows:

17 (625 ILCS 5/15-107) (from Ch. 95 1/2, par. 15-107)

18 Sec. 15-107. Length of vehicles.

(a) The maximum length of a single vehicle on any highwayof this State may not exceed 42 feet except the following:

(1) Semitrailers.

(2) Charter or regulated route buses may be up to 45
feet in length, not including energy absorbing bumpers.
(a-1) A motor home as defined in Section 1-145.01 may be up

to 45 feet in length, not including energy absorbing bumpers.
 The length limitations described in this subsection (a-1) shall
 be exclusive of energy-absorbing bumpers and rear view mirrors.

4 (b) On all non-State highways, the maximum length of 5 vehicles in combinations is as follows:

(1) A truck tractor in combination with a semitrailer 6 7 may not exceed 65 55 feet overall dimension. An agency or 8 instrumentality of the State of Illinois or any unit of 9 local government shall not be required to widen or 10 otherwise alter a non-State highway constructed before the effective date of this amendatory Act of the 100th General 11 Assembly to accommodate truck tractors under this 12 13 paragraph (1).

14 (2) A truck tractor-semitrailer-trailer or truck
15 tractor semitrailer-semitrailer may not exceed 60 feet
16 overall dimension.

17 (3) Combinations specially designed to transport motor vehicles or boats may not exceed 60 feet overall dimension. 18 19 (4) The distance between the kingpin and the center 20 axle of a semitrailer longer than 48 feet, in combination 21 with a truck tractor, may not exceed 42 feet 6 inches. The 22 limit contained in this paragraph (4) shall not apply to trailers or semitrailers used for the transport of 23 24 livestock as defined by Section 18b-101.

1 nature that cannot readily be dismembered are exempt from length limitations, provided that no object may exceed 80 feet 2 3 in length and the overall dimension of the vehicle including 4 the load may not exceed 100 feet. This exemption does not apply 5 to operation on a Saturday, Sunday, or legal holiday. Legal holidays referred to in this Section are the days on which the 6 following traditional holidays are celebrated: New Year's Day; 7 Memorial Day; Independence Day; Labor Day; Thanksgiving Day; 8 9 and Christmas Day.

Vehicles and loads operated by a public utility while en route to make emergency repairs to public service facilities or properties are exempt from length limitations, provided that during night operations every vehicle and its load must be equipped with a sufficient number of clearance lamps on both sides and marker lamps on the extreme ends of any projecting load to clearly mark the dimensions of the load.

A tow truck in combination with a disabled vehicle or combination of disabled vehicles, as provided in paragraph (6) of subsection (c) of this Section, is exempt from length limitations.

All other combinations not listed in this subsection (b) may not exceed 60 feet overall dimension.

(c) Except as provided in subsections (c-1) and (c-2), combinations of vehicles may not exceed a total of 2 vehicles except the following:

(1) A truck tractor semitrailer may draw one trailer.

1 (2) A truck tractor semitrailer may draw one converter dolly or one semitrailer. 2 3 (3) A truck tractor semitrailer may draw one vehicle 4 that is defined in Chapter 1 as special mobile equipment, 5 provided the overall dimension does not exceed 60 feet. (4) A truck in transit may draw 3 trucks in transit 6 coupled together by the triple saddlemount method. 7 (5) Recreational vehicles consisting of 3 vehicles, 8 9 provided the following: 10 (A) The total overall dimension does not exceed 60 11 feet. (B) The towing vehicle is a properly registered 12 13 vehicle capable of towing another vehicle using a 14 fifth-wheel type assembly. 15 The second vehicle in the combination of (C) 16 vehicles is a recreational vehicle that is towed by a fifth-wheel assembly. This vehicle must be properly 17 18 registered and must be equipped with brakes, 19 regardless of weight. 20 (D) The third vehicle must be the lightest of the 3 vehicles and be a trailer or semitrailer designed or 21 22 used for transporting a boat, all-terrain vehicle, 23 personal watercraft, or motorcycle. 24 (E) The towed vehicles may be only for the use of 25 the operator of the towing vehicle.

(F) All vehicles must be properly equipped with

operating brakes and safety equipment required by this Code, except the additional brake requirement in subdivision (C) of this subparagraph (5).

4 (6) A tow truck in combination with a disabled vehicle
5 or combination of disabled vehicles, provided the towing
6 vehicle:

7 (A) Is specifically designed as a tow truck having 8 a gross vehicle weight rating of at least 18,000 pounds 9 and equipped with air brakes, provided that air brakes 10 are required only if the towing vehicle is towing a 11 vehicle, semitrailer, or tractor-trailer combination 12 that is equipped with air brakes. For the purpose of 13 this subsection, gross vehicle weight rating, or GVWR, 14 means the value specified by the manufacturer as the 15 loaded weight of the tow truck.

(B) Is equipped with flashing, rotating, or
oscillating amber lights, visible for at least 500 feet
in all directions.

19(C) Is capable of utilizing the lighting and20braking systems of the disabled vehicle or combination21of vehicles.

(D) Does not engage a tow exceeding 50 highway
miles from the initial point of wreck or disablement to
a place of repair. Any additional movement of the
vehicles may occur only upon issuance of authorization
for that movement under the provisions of Sections

15-301 through 15-319 of this Code. 1 The Department may by rule or regulation prescribe 2 3 additional requirements regarding length limitations for a 4 tow truck towing another vehicle. 5 For purposes of this Section, a tow-dolly that merely serves as substitute wheels for another legally licensed 6 7 vehicle is considered part of the licensed vehicle and not 8 a separate vehicle. 9 (7) Commercial vehicles consisting of 3 vehicles, 10 provided the following: (A) The total overall dimension does not exceed 65 11 12 feet. 13 (B) The towing vehicle is a properly registered 14 vehicle capable of towing another vehicle using a 15 fifth-wheel type assembly or a goose-neck hitch ball. 16 (C) The third vehicle must be the lightest of the 3 vehicles and be a trailer or semitrailer. 17 18 (D) All vehicles must be properly equipped with 19 operating brakes and safety equipment required by this 20 Code. 21 (E) The combination of vehicles must be operated by 22 a person who holds a commercial driver's license (CDL). (F) The combination of vehicles must be en route to 23 24 a location where new or used trailers are sold by an 25 Illinois or out-of-state licensed new or used trailer 26 dealer.

1 (c-1) A combination of 3 vehicles is allowed access to any 2 State designated highway if: 3 (1) the length of neither towed vehicle exceeds 28.5 feet; 4 5 (2) the overall wheel base of the combination of vehicles does not exceed 62 feet; and 6 (3) the combination of vehicles is en route to a 7 8 location where new or used trailers are sold by an Illinois 9 or out-of-state licensed new or used trailer dealer. 10 (c-2) A combination of 3 vehicles is allowed access from any State designated highway onto any county, township, or 11 municipal highway for a distance of 5 highway miles for the 12 purpose of delivery or collection of one or both of the towed 13 vehicles if: 14 15 (1) the length of neither towed vehicle exceeds 28.5 16 feet; (2) the combination of vehicles does not exceed 40,000 17 18 pounds in gross weight and 8 feet 6 inches in width; 19 (3) there is no sign prohibiting that access; 20 (4) the route is not being used as a thoroughfare 21 between State designated highways; and (5) the combination of vehicles is en route to a 22 23 location where new or used trailers are sold by an Illinois 24 or out-of-state licensed new or used trailer dealer. 25 (d) On Class I highways there are no overall length 26 limitations on motor vehicles operating in combinations

2 3 (1) The length of a semitrailer, unladen or with load, in combination with a truck tractor may not exceed 53 feet.

4 (2) The distance between the kingpin and the center of 5 the rear axle of a semitrailer longer than 48 feet, in 6 combination with a truck tractor, may not exceed 45 feet 6 7 inches. The limit contained in this paragraph (2) shall not 8 apply to trailers or semi-trailers used for the transport 9 of livestock as defined by Section 18b-101.

6 (8) A towaway trailer transporter combination may not
7 exceed 82 feet overall dimension.

Vehicles operating during daylight hours when transporting 8 9 poles, pipes, machinery, or other objects of a structural 10 nature that cannot readily be dismembered are exempt from 11 length limitations, provided that no object may exceed 80 feet in length and the overall dimension of the vehicle including 12 13 the load may not exceed 100 feet. This exemption does not apply 14 to operation on a Saturday, Sunday, or legal holiday. 9 (e-1) Combinations of vehicles not exceeding 65 feet

(1) From any State designated highway onto any county,
 township, or municipal highway for a distance of 5 highway

3 (e-2) Except as provided in subsection (e-3), combinations 4 of vehicles over 65 feet in length, with no overall length 5 limitation except as provided in subsections (d) and (e) of 6 this Section, are allowed access as follows:

7 (1) From a Class I highway onto any street or highway
8 for a distance of one highway mile for the purpose of
9 loading, unloading, food, fuel, repairs, and rest,
10 provided there is no sign prohibiting that access.

11 (2) From a Class I or Class II highway onto any State 12 highway or any locally designated highway for a distance of 13 5 highway miles for the purpose of loading, unloading, 14 food, fuel, repairs, and rest.

15 (e-3) Combinations of vehicles over 65 feet in length 16 operated by household goods carriers or towaway trailer 17 transporter combinations, with no overall length limitations 18 except as provided in subsections (d) and (e) of this Section, 19 have unlimited access to points of loading, unloading, or 20 delivery to or from a manufacturer, distributor, or dealer.

(f) On Class III and other non-designated State highways, the length limitations for vehicles in combination are as follows:

(1) Truck tractor-semitrailer combinations, must
 comply with either a maximum 55 feet overall wheel base or
 a maximum 65 feet extreme overall dimension. <u>An agency or</u>

instrumentality of the State of Illinois or any unit of local government shall not be required to widen or otherwise alter a Class III or other non-designated State highway constructed before the effective date of this amendatory Act of the 100th General Assembly to accommodate truck tractor-semitrailer combinations under this paragraph (1).

8 (2) Semitrailers, unladen or with load, may not exceed
9 53 feet overall dimension.

10 (3) No truck tractor-semitrailer-trailer or truck
11 tractor semitrailer-semitrailer combination may exceed 60
12 feet extreme overall dimension.

13 (4) The distance between the kingpin and the center 14 axle of a semitrailer longer than 48 feet, in combination 15 with a truck tractor, may not exceed 42 feet 6 inches. The 16 limit contained in this paragraph (4) shall not apply to 17 trailers or semi-trailers used for the transport of 18 livestock as defined by Section 18b-101.

19 (g) Length limitations in the preceding subsections of this20 Section 15-107 do not apply to the following:

(1) Vehicles operated in the daytime, except on Saturdays, Sundays, or legal holidays, when transporting poles, pipe, machinery, or other objects of a structural nature that cannot readily be dismembered, provided the overall length of vehicle and load may not exceed 100 feet and no object exceeding 80 feet in length may be 1 transported unless a permit has been obtained as authorized 2 in Section 15-301.

3 (2) Vehicles and loads operated by a public utility
4 while en route to make emergency repairs to public service
5 facilities or properties, but during night operation every
6 vehicle and its load must be equipped with a sufficient
7 number of clearance lamps on both sides and marker lamps
8 upon the extreme ends of any projecting load to clearly
9 mark the dimensions of the load.

10 (3) A tow truck in combination with a disabled vehicle 11 or combination of disabled vehicles, provided the towing 12 vehicle meets the following conditions:

(A) It is specifically designed as a tow truck
having a gross vehicle weight rating of at least 18,000
pounds and equipped with air brakes, provided that air
brakes are required only if the towing vehicle is
towing a vehicle, semitrailer, or tractor-trailer
combination that is equipped with air brakes.

(B) It is equipped with flashing, rotating, or
oscillating amber lights, visible for at least 500 feet
in all directions.

(C) It is capable of utilizing the lighting and
braking systems of the disabled vehicle or combination
of vehicles.

(D) It does not engage in a tow exceeding 50 miles
 from the initial point of wreck or disablement.

1 The Department may by rule or regulation prescribe 2 additional requirements regarding length limitations for a tow 3 truck towing another vehicle. The towing vehicle, however, may 4 tow any disabled vehicle from the initial point of wreck or 5 disablement to a point where repairs are actually to occur. 6 This movement shall be valid only on State routes. The tower 7 must abide by posted bridge weight limits.

8 For the purpose of this subsection, gross vehicle weight 9 rating, or GVWR, shall mean the value specified by the 10 manufacturer as the loaded weight of the tow truck. Legal 11 holidays referred to in this Section shall be specified as the 12 day on which the following traditional holidays are celebrated:

13 New Year's Day;

14 Memorial Day;

15 Independence Day;

16 Labor Day;

17 Thanksgiving Day; and

18 Christmas Day.

(h) The load upon any vehicle operated alone, or the load 19 20 upon the front vehicle of a combination of vehicles, shall not 21 extend more than 3 feet beyond the front wheels of the vehicle 22 or the front bumper of the vehicle if it is equipped with a 23 front bumper. The provisions of this subsection (h) shall not 24 apply to any vehicle or combination of vehicles specifically 25 designed for the collection and transportation of waste, 26 recyclable materials during the vehicle's garbage, or

operation in the course of collecting garbage, waste, or recyclable materials if the vehicle is traveling at a speed not in excess of 15 miles per hour during the vehicle's operation and in the course of collecting garbage, waste, or recyclable materials. However, in no instance shall the load extend more than 7 feet beyond the front wheels of the vehicle or the front bumper of the vehicle if it is equipped with a front bumper.

(i) The load upon the front vehicle of an automobile 8 9 transporter or a stinger-steered vehicle specifically designed 10 to transport motor vehicles shall not extend more than 4 feet 11 beyond the foremost part of the transporting vehicle and the load upon the rear transporting vehicle shall not extend more 12 13 than 6 feet beyond the rear of the bed or body of the vehicle. 14 This paragraph shall only be applicable upon highways 15 designated in paragraphs (d) and (e) of this Section.

(j) Articulated vehicles comprised of 2 sections, neither of which exceeds a length of 42 feet, designed for the carrying of more than 10 persons, may be up to 60 feet in length, not including energy absorbing bumpers, provided that the vehicles are:

1. operated by or for any public body or motor carrier
 authorized by law to provide public transportation
 services; or

24 2. operated in local public transportation service by
25 any other person and the municipality in which the service
26 is to be provided approved the operation of the vehicle.
