SYNOPSIS AS INTRODUCED:

30 ILCS 105/5.652
110 ILCS 805/2-11.2 new
110 ILCS 805/2-16.09

Amends the Public Community College Act. Provides that the Illinois Community College Board may collect a fee to cover the cost of processing and handling individual student-level data requests pursuant to an approved data sharing agreement. Renames the ICCB Instructional Development and Enhancement Applications Revolving Fund to the ICCB Research and Technology Fund. Provides that the Fund shall receive all moneys received from processing requests for individual student-level data, and that money from the Fund shall be used for costs associated with maintaining and updating individual student-level data systems. Amends the State Finance Act to make a conforming change. Effective July 1, 2017.

4 Section 5. The State Finance Act is amended by changing
5 Section 5.652 as follows:

7 Sec. 5.652. The ICCB Research and Technology ~~Instructional~~

10 Section 10. The Public Community College Act is amended by
11 changing Section 2-16.09 and by adding Section 2-11.2 as
12 follows:

14 Sec. 2-11.2. Processing fee. The State Board may collect a
15 fee to cover the cost of processing and handling individual
16 student-level data requests pursuant to an approved data
17 sharing agreement. The fee shall not be assessed on any
18 entities that are complying with State or federal-mandated
19 reporting. The fee shall be set by the Board by rule. Money
20 from the fee shall be deposited into the ICCB Research and
21 Technology Fund.

2 Sec. 2-16.09. ICCB Research and Technology Instructional
3 ~~Development and Enhancement Applications Revolving~~ Fund. The
4 ICCB Research and Technology Instructional Development and
5 ~~Enhancement Applications Revolving~~ Fund is created as a special
6 fund in the State treasury. The State Board shall deposit into
7 the Fund moneys received by the State Board from the sale of
8 instructional technology developed by the State Board and all
9 moneys received from processing requests for individual
10 student-level data. All moneys in the Fund shall be used by the
11 State Board, subject to appropriation by the General Assembly,
12 for costs associated with maintaining and updating that
13 instructional technology and individual student-level data
14 systems.
