### SB1612

## SYNOPSIS AS INTRODUCED:

110 ILCS 805/3-7.10 from Ch. 122, par. 103-7.10

Amends the Public Community College Act. Provides that various petitions and filings must be filed with the county clerk or the county board of election commissioners, as the case may be, of the county in which the principal office of the community college board is located, rather than the secretary of the board of trustees. Makes conforming changes.

# Be it enacted by the People of the State of Illinois, represented in the General Assembly:

Section 5. The Public Community College Act is amended by
changing Section 3-7.10 as follows:

6 (110 ILCS 805/3-7.10) (from Ch. 122, par. 103-7.10)

7 Sec. 3-7.10. Nominations for members of the board shall be 8 made by a petition signed by at least 50 voters or 10% of the 9 voters, whichever is less, residing within the district and shall be filed with the county clerk or the county board of 10 election commissioners, as the case may be, of the county in 11 12 which the principal office of the community college board is located secretary of the board. In addition to the requirements 13 14 of the general election law, the form of such petitions shall be substantially as follows: 15

Nomination papers filed under this Section are not valid 6 7 unless the candidate named therein files with the county clerk 8 or the county board of election commissioners, as the case may 9 be, of the county in which the principal office of the 10 community college board is located, together with secretary of 11 the board a receipt from the county clerk, if filing with a 12 county board of election commissioners, showing that the candidate has filed a statement of economic interests as 13 14 required by the Illinois Governmental Ethics Act. Such receipt 15 shall be so filed either previously during the calendar year in 16 which his nomination papers were filed or within the period for the filing of nomination papers in accordance with the general 17 election law. 18

The <u>county clerk or the county board of election</u> <u>commissioners, as the case may be, of the county in which the</u> <u>principal office of the community college board is located</u> <u>secretary of the board</u> shall notify each candidate, or the appropriate committee, for whom a petition for nomination has been filed of their obligations under the Campaign Financing Act, as required by the general election law. Such notice shall be given on a form prescribed by the State Board of Elections and in accordance with the requirements of the general election law.

All petitions for the nomination of members of a board of 4 5 trustees shall be filed with the county clerk or the county board of election commissioners, as the case may be, of the 6 7 county in which the principal office of the community college 8 board is located <del>secretary of the board</del> within the time 9 provided for by the general election law. Said county clerk or 10 board of election commissioners <del>secretary</del> shall make 11 certification to the proper election authority in accordance 12 with the requirements of the general election law. If the secretary is an incumbent board member seeking reelection, a 13 14 disinterested person must be a witness to the filing of his petition. It is the duty of the county clerk or board of 15 16 election commissioners, as the case may be, secretary to 17 provide candidates with petition forms and statements of 18 candidacy.

The <u>county clerk or board of election commissioners</u>, as the <u>case may be</u>, <del>secretary</del> shall within 7 days of filing or on the last day for filing, whichever is earlier, acknowledge to the petitioner in writing his <u>or its</u> acceptance of the petition.

23 In all newly organized districts the petition for the 24 nomination of candidates for members of the board at the first 25 election shall be addressed to and filed with the regional 26 superintendent in the manner specified for the petitions for

- 1 candidates of a community college board. For such election the
- 2 regional superintendent shall fulfill all duties otherwise
- 3 assigned to the secretary of the board.
