2 AMENDMENT NO. _____. Amend Senate Bill 2021, AS AMENDED,
3 with reference to page and line numbers of Senate Amendment No.
4 2 as follows:

5 on page 12, line 15, by replacing "Adjudications" with "Unless
6 expressly allowed by law, adjudications"; and

7 on page 23, line 16, after "prosecutor", by inserting "or by
8 the Office of the Secretary of State"; and

9 on page 25, line 20, by replacing "5" with "60"; and

10 on page 26, line 6, by replacing "first degree murder" with "a
11 disqualified offense"; and

12 on page 26, line 12, by replacing "5" with "60"; and

1 on page 26, line 13, after the period, by inserting "For the
2 purposes of this subsection (0.3), "disqualified offense"
3 means any of the following offenses: Section 8-1.2, 9-1, 9-1.2,
4 9-2, 9-2.1, 9-3, 9-3.2, 10-1, 10-2, 10-3, 10-3.1, 10-4, 10-5,

9 29D-14.9, 29D-20, 30-1, 31-1a, 32-4a, or 33A-2 of the Criminal
10 Code of 2012, or subsection (b) of Section 8-1, paragraph (4)
11 of subsection (a) of Section 11-14.4, subsection (a-5) of
12 Section 12-3.1, paragraph (1), (2), or (3) of subsection (a) of
13 Section 12-6, subsection (a-3) or (a-5) of Section 12-7.3,
14 paragraph (1) or (2) of subsection (a) of Section 12-7.4,
15 subparagraph (i) of paragraph (1) of subsection (a) of Section
16 12-9, subparagraph (H) of paragraph (3) of subsection (a) of
17 Section 24-1.6, paragraph (1) of subsection (a) of Section
18 25-1, or subsection (a-7) of Section 31-1 of the Criminal Code
19 of 2012."; and

20 on page 27, by replacing lines 23 through 25 with the
21 following:

22 "(d) the minor was adjudicated for an offense which
23 would be a Class B misdemeanor, Class C misdemeanor, or a
24 petty or business offense if committed by an adult."; and

1 on page 27, line 26, by deleting "(Blank)."; and

2 on page 28, by replacing lines 23 and 24 with "birthday
3 eligible under this Act ~~subsection~~ have been expunged ~~as~~
4 ~~provided in this subsection.~~"; and

5 on page 30, line 22, after "murder", by inserting "or an
6 offense under Article 11 of the Criminal Code of 2012 if the
7 person is required to register under the Sex Offender
8 Registration Act; provided that:"; and

9 on page 31, line 17, by replacing "the" with "that the"; and

10 on page 34, by replacing lines 21 through 23 with the
11 following:

12 "() e. was adjudicated for the offense or offenses, which
13 would have been a Class B misdemeanor, a Class C misdemeanor,
14 or a petty offense or business offense if committed by an
15 adult."; and

16 on page 34, by replacing lines 25 and 26 with "except first
17 degree murder or an offense under Article 11 of the Criminal
18 Code of 2012 if the person is required to register under the
19 Sex Offender Registration Act, and 2 years have passed since
20 the case was closed."; and

1 on page 35, line 7, by replacing "e." with "f e.".
