A BILL FOR

1 AN ACT concerning appropriations.

2 **Be it enacted by the People of the State of Illinois, represented**
3 **in the General Assembly:**

4 ARTICLE 0.5

5 Section 1. Purpose. This Act makes appropriations and
6 reappropriations for State fiscal year 2018. Article 3
7 contains reappropriations of certain appropriations as may have
8 been appropriated for State fiscal year 2017 by a Public Act
9 of the 100th General Assembly. To the extent that such a Public
10 Act has not been enacted, Article 4 contains appropriations of
11 identical amounts and purposes to those in Article 3 but as new
12 appropriations rather than as reappropriations. Section 99 of
13 Article 5 sets forth an effective date that causes Article 3
14 to become effective if and only if an applicable Public Act of
15 the 100th General Assembly should be enacted; should such not
16 be enacted, the Section causes Article 4 to become effective.

17 ARTICLE 1

18 Section 1. "Operational expenses" defined. For the purposes
19 of this Act, the term "operational expenses" includes the
20 following items:

- 21 (a) Personal Services;
22 (b) State contributions to Social Security;

- 1 (c) Group Insurance;
2 (d) Contractual Services;
3 (e) Travel;
4 (f) Commodities;
5 (g) Printing;
6 (h) Equipment;
7 (i) Electronic data processing;
8 (j) Telecommunications services;
9 (k) Operation of automotive equipment;
10 (l) Refunds;
11 (m) Employee retirement contributions paid by the employer;
12 (n) Permanent improvements;
13 (o) Deposits to other funds.

14 Section 5. In addition to other amounts appropriated, the
15 amount of \$40,650,000, or so much thereof as may be necessary,
16 is appropriated from the General Revenue Fund to the Department
17 of Natural Resources for operational expenses of the fiscal
18 year ending June 30, 2018.

19 Section 10. The following named sums, or so much thereof

3 Section 40. The sum of \$250,000, or so much thereof as may
4 be necessary, is appropriated from the Wildlife and Fish Fund
5 to the Department of Natural Resources for the non-federal cost
6 share of a Conservation Reserve Enhancement Program to
7 establish long-term contracts and permanent conservation
8 easements in the Illinois River Basin; to fund cost share
9 assistance to landowners to encourage approved conservation
10 practices in environmentally sensitive and highly erodible
11 areas of the Illinois River Basin; and to fund the monitoring
12 of long-term improvements of these conservation practices as
13 required in the Memorandum of Agreement between the State of

2 ARTICLE 5

3 Section 99. Effective date. This Article, Article 0.5, 1,
4 and 2 take effect July 1, 2017. Article 3 takes effect July
5 1, 2017 if and only if a bill of the 100th General Assembly
6 making new appropriations for the amounts and purposes in
7 article 3 becomes law. Article 4 takes effect July 1, 2017 if
8 and only if a bill of the 100th General Assembly making new
9 appropriations for the amounts and purposes in Article 3 does
10 not become law. Notwithstanding the foregoing, this Act
11 becomes law if and only if Senate Bill 2063 of the 100th General
12 Assembly (the Unbalanced Budget Response Act), as introduced
13 in the Illinois Senate, becomes law.
