Be it enacted by the People of the State of Illinois, represented in the General Assembly:

5	Section 5. The following named amounts, or so much thereof

2 Section 10. The sum of \$16,000,000, or so much thereof as 3 may be necessary, is appropriated from the Federal Support 4 Agreement Revolving Fund to the Department of Military Affairs 5 Facilities Division for expenses related to Army National Guard 6 Facilities operations and maintenance as provided for in the 7 Cooperative Funding Agreements, including costs in prior years.

8 Section 15. The sum of \$10,000, or so much thereof as may 9 be necessary, is appropriated from the General Revenue Fund to 10 the Department of Military Affairs Office of the Adjutant 11 General Division for expenses related to the care and 12 preservation of historic artifacts.

13 Section 20. The sum of \$1,000,000, or so much thereof as 14 may be necessary, is appropriated from the Military Affairs 15 Trust Fund to the Department of Military Affairs Office of the 16 Adjutant General Division to support youth and other programs, 17 provided such amounts shall not exceed funds to be made 18 available from public or private sources.

Section 25. The sum of \$5,000,000, or so much thereof as may be necessary, is appropriated from the Illinois Military Family Relief Fund to the Department of Military Affairs Office -3- OMB101 00039 CLF 45039 b

of the Adjutant General Division for the issuance of grants to persons or families of persons who are members of the Illinois National Guard or Illinois residents who are members of the armed forces of the United States and who have been called to active duty as a result of the September 11, 2001 terrorist attacks, including costs in prior years.

Section 30. The sum of \$850,000, or so much thereof as may
be necessary, is appropriated from the General Revenue Fund to
the Department of Military Affairs for deposit into the Federal
Support Agreement Revolving Fund.

Section 35. The sum of \$100,000, or so much thereof as may be necessary, is appropriated from the State Military Justice Fund to the Department of Military Affairs for expenses of military justice as provided in the Illinois Code of Military Justice.

Section 99. Effective Date. This Act takes effect July 1,2019.
