

101ST GENERAL ASSEMBLY State of Illinois 2019 and 2020 HB4737

SYNOPSIS AS INTRODUCED:

20 ILCS 415/8b

from Ch. 127, par. 63b108b

Amends the Personnel Code. Provides that each application to fill a State employment vacancy shall include a checkbox for applicants having prior work experience in the field for which they are applying for employment with the State. Provides that following examinations to test the relative fitness of applicants for the respective positions in State service, applicants having prior work experience in the relevant employment field shall be given priority among all successful candidates listed as eligible for appointment or promotion. Provides that any applicant found to have falsely claimed prior work experience in the field for which he or she is applying for employment with the State shall not be eligible for State employment for 24 months.

1 AN ACT concerning State government.

Be it enacted by the People of the State of Illinois, represented in the General Assembly:

- Section 5. The Personnel Code is amended by changing Section 8b as follows:
- 6 (20 ILCS 415/8b) (from Ch. 127, par. 63b108b)
- 7 Sec. 8b. Jurisdiction B Merit and fitness.
- 8 (a) For positions in the State service subject to the 9 jurisdiction of the Department of Central Management Services 10 with respect to selection and tenure on the basis of merit and 11 fitness, those matters specified in this Section and Sections
- 12 8b.1 through 8b.17.
- (b) Application, testing, and hiring procedures for all 13 14 State employment vacancies for positions not exempt under Section 4c shall be reduced to writing. The written procedures 15 16 shall be provided to each State agency and university for posting and public inspection at each agency's office and each 17 university's placement office. The Director 18 shall 19 annually prepare and distribute a listing of entry level non-professional and professional positions that are most 20 21 utilized by State agencies under the jurisdiction of the 22 Governor. The position listings shall identify the entry level positions, localities of usage, description of position duties 23

- 1 and responsibilities, salary ranges, eligibility requirements
- 2 and test scheduling instructions. The position listings shall
- 3 further identify special linguistic skills that may be required
- 4 for any of the positions.
- 5 (c) Each application to fill a State employment vacancy
- 6 shall include a checkbox for applicants having prior work
- 7 <u>experience in the field for which they are applying for</u>
- 8 <u>employment with the State. Following examinations to test the</u>
- 9 relative fitness of applicants for the respective positions in
- 10 State service, applicants having prior work experience in the
- 11 relevant employment field shall be given priority among all
- 12 successful candidates listed as eligible for appointment or
- promotion. Any applicant found to have falsely claimed prior
- work experience in the field for which he or she is applying
- for employment with the State shall not be eligible for State
- employment for 24 months.
