A BILL FOR

1 AN ACT concerning appropriations.

2 **Be it enacted by the People of the State of Illinois, represented**  
3 **in the General Assembly:**

4 ARTICLE 1

5 Section 5. The following named amounts, or so much thereof  
6 as may be necessary, respectively, for the objects and purposes  
7 hereinafter named, are appropriated to meet the ordinary and  
8 contingent expenses of the Illinois Criminal Justice  
9 Information Authority:

3 Section 10. The following named amounts, or so much thereof  
 4 as may be necessary, are appropriated to the Illinois Criminal  
 5 Justice Information Authority for administrative costs, awards  
 6 and grants for Adult Redeploy and Diversion Programs:

7 Payable from the General Revenue Fund .....8,271,000  
 8 Payable from the ICJIA Violence Prevention  
 9 Special Projects Fund .....1,747,000  
 10 Total \$10,018,000

11 Section 15. The amount of \$130,000,000, or so much thereof  
 12 as may be necessary, is appropriated from the Criminal Justice  
 13 Trust Fund to the Illinois Criminal Justice Information  
 14 Authority for awards and grants to local units of government,  
 15 state agencies and non-profit organizations.

16 Section 20. The following named amounts, or so much thereof  
 17 as may be necessary, are appropriated to the Illinois Criminal  
 18 Justice Information Authority for activities undertaken in  
 19 support of federal assistance programs administered by units  
 20 of state and local government and non-profit organizations:

21 Payable from the Criminal Justice  
 22 Trust Fund .....8,000,000

1 Section 25. The following named amounts, or so much thereof  
 2 as may be necessary, are appropriated to the Illinois Criminal  
 3 Justice Information Authority for awards and grants and other  
 4 monies received from federal agencies, from other units of  
 5 government, and from private/not-for-profit organizations for  
 6 activities undertaken in support of investigating issues in  
 7 criminal justice and for undertaking other criminal justice  
 8 information projects:

10	Trust Fund .....	1,700,000
11	Payable from the Criminal Justice	
12	Information Projects Fund .....	<u>1,000,000</u>

14 Section 30. The amount of \$2,500,000, or so much thereof  
 15 as may be necessary, is appropriated from the Criminal Justice  
 16 Information Projects Fund to the Illinois Criminal Justice  
 17 Information Authority for distribution of revenue pursuant to  
 18 Section 507HHH of the Illinois Income Tax Act and Section 21.10  
 19 of the Illinois Lottery Law.

20 Section 35. The amount of \$500,000, or so much thereof as  
 21 may be necessary, is appropriated from the Criminal Justice  
 22 Information Projects Fund to the Illinois Criminal Justice

1 Information Authority for distribution to fund Department of  
 2 State Police drug task forces and Metropolitan Enforcement  
 3 Groups.

4 Section 40. The amount of \$7,800, or so much thereof as  
 5 may be necessary, is appropriated from the Illinois State Crime  
 6 Stoppers Association Fund to the Illinois Criminal Justice  
 7 Information Authority for grants to enhance and develop Crime  
 8 Stoppers programs in Illinois.

9 Section 45. The following named amounts, or so much thereof  
 10 as may be necessary, respectively, for the objects and purposes  
 11 hereinafter named, are appropriated to the Illinois Criminal  
 12 Justice Information Authority for the training of law  
 13 enforcement personnel and services for families of victims of  
 14 homicide or murder:

15 Payable from the Death Penalty Abolition Fund:

1 Total \$5,805,000

2 Section 50. The amount of \$150,000, or so much thereof as  
3 may be necessary, is appropriated from the Prescription Pill  
4 and Drug Disposal Fund to the Illinois Criminal Justice  
5 Information Authority for the purpose of collection,  
6 transportation, and incineration of pharmaceuticals by local  
7 law enforcement agencies.

8 Section 55. The following amounts, or so much thereof as  
9 may be necessary, respectively, are appropriated for the  
10 objects and purposes named, to meet the ordinary and contingent  
11 expenses of the Illinois Criminal Justice Information  
12 Authority:

13 Payable from the ICJIA Violence Prevention Fund:

5 Section 60. The amount of \$1,200,000, or so much thereof  
6 as may be necessary, is appropriated from the General Revenue  
7 Fund to the Illinois Criminal Justice Information Authority for  
8 the purpose of awarding grants, contracts, administrative  
9 expenses and all related costs for the Safe From the Start  
10 Program.

11 Section 65. The amount of \$525,000, or so much thereof as  
12 may be necessary, is appropriated from the General Revenue Fund  
13 to the Illinois Criminal Justice Information Authority for the  
14 Illinois Family Violence Coordinating Council Program.

15 Section 70. The amount of \$9,541,300, or so much thereof  
16 as may be necessary, is appropriated from the General Revenue  
17 Fund to the Illinois Criminal Justice Information Authority for  
18 administrative costs, awards and grants for Community-Based  
19 Violence Prevention Programs.

20 Section 75. The amount of \$443,000, or so much thereof as  
21 may be necessary, is appropriated from the General Revenue Fund

1 to the Illinois Criminal Justice Information Authority for all  
2 costs associated with Bullying Prevention.

3 Section 80. The amount of \$6,094,300, or so much thereof  
4 as may be necessary, is appropriated from the General Revenue  
5 Fund to the Illinois Criminal Justice Information Authority for  
6 grants and administrative expenses related to Metropolitan  
7 Family Services' support of street intervention programming.

8 Section 85. The amount of \$500,000, or so much thereof as  
9 may be necessary, is appropriated from the General Revenue Fund  
10 to the Illinois Criminal Justice Information Authority for a  
11 grant to the Safer Foundation for violence prevention services.

12 Section 99. Effective Date. This Act takes effect July 1,  
13 2019.
