The sum of \$4,000,000, or so much thereof as 2 may be necessary, is appropriated from the State Asset 3 Forfeiture Fund to the Illinois State Police for payment of 4 their expenditures as outlined in the Drug Asset Forfeiture 5 Procedure Act, the Cannabis Control Act, and the Illinois 6 Controlled Substances Act.

Section 15. The sum of \$2,500,000, or so much thereof as may be necessary, is appropriated from the Federal Asset Forfeiture Fund to the Illinois State Police for payment of their expenditures in accordance with the Federal Equitable Sharing Guidelines.

Section 20. The sum of \$2,000,000, or so much thereof as may be necessary, is appropriated to the Illinois State Police, Division of Justice Services, from the Money Laundering Asset Recovery Fund for the ordinary and contingent expenses incurred by the Illinois State Police.

Section 25. The sum of \$1,000,000, or so much thereof as may be necessary, is appropriated from the LEADS Maintenance Fund to the Illinois State Police, Division of Justice Services, for expenses related to the LEADS System.

Section 45. The sum of \$45,000,000, or so much thereof as may be necessary, is appropriated from the State Police Operations Assistance Fund to the Illinois State Police for the ordinary and contingent expenses incurred by the Illinois State Police.

The sum of \$13,000,000, or so much thereof as 19 may be necessary, is appropriated from the State Police Law 20 Enforcement Administration Fund to the Illinois State Police, 21 Division of Operations, for all costs associated with a cadet 22 program for the Illinois State Police. -6- OMB103 00205 JPT 45205 b

1 Section 55. The sum of \$2,000,000, or so much thereof as 2 may be necessary, is appropriated from the Scott's Law Fund to 3 the Illinois State Police for the ordinary and contingent 4 expenses incurred by the Illinois State Police.

5 Section 60. The sum of \$40,000,000, or so much thereof as 6 may be necessary, is appropriated from the Illinois State 7 Police Federal Projects Fund to the Illinois State Police for 8 costs related to federal awards and grants, including prior 9 years' costs.

Section 65. The sum of \$6,000,000, or so much thereof as may be necessary, is appropriated from the State Police Training and Academy Fund to the Illinois State Police for expenses related to State Police Training.

The sum of \$29,500,000, or so much thereof as 23 may be necessary, is appropriated to the Illinois State Police HB5693 -8- OMB103 00205 JPT 45205 b 1 from the State Police Firearm Services Fund for expenses as 2 outlined in the Firearm Concealed Carry Act and the Firearm 3 Owners Identification Card Act.

Section 85. The sum of \$230,000,000, or so much thereof
as may be necessary, is appropriated from the Statewide 9-1-1
Fund to the Illinois State Police, Division of Justice
Services, for costs pursuant to the Emergency Telephone System
Act.

9 Section 90. The sum of \$2,000,000, or so much thereof as 10 may be necessary, is appropriated from the State Police 11 Revocation Enforcement Fund to the Illinois State Police, for 12 grants to law enforcement agency task forces for participating 13 in programs to help reduce crime.

14 Section 95. The sum of \$1,300,000, or so much thereof as 15 may be necessary, is appropriated from the General Revenue Fund 16 to the Illinois State Police, for the ordinary and contingent 17 expenses of the Safe2Help Program.

Section 99. Effective date. This Act takes effect July 1, 2024.
