- 6 the Lummis Funeral Home in Pittsfield in 1993, the Coonrod
- 7 Funeral Home in Winchester in 1994, and the Sager Funeral Home
- 8 in Beardstown in 2007; and
- 9 WHEREAS, While Jess Hires retired in 1992, Airsman-Hires
- 10 Funeral Homes remains family-owned and operated today under
- 11 the guidance of Terry and Mary Beth Airsman and their daughter
- 12 and son-in-law, Elizabeth and Greg May, with Denton Coonrod
- and Wyatt and Trisha Sager still providing funeral service in
- 14 their respective communities; therefore, be it
