- 15 <u>message signs on roads and highways in the vicinity of a</u>
- 16 <u>child abduction to immediately provide critical information</u>
- to the public.
- 18 <u>(b) The Department of State Police shall establish an</u>

- 10 <u>Coordinator shall have the qualifications and experience that</u>
- 11 the Department shall require by rule. The Child Safety
- 12 <u>Coordinator shall receive no compensation but shall be</u>

- 29 Section 15. The Illinois Emergency Management Agency Act
- 30 is amended by changing Section 5 as follows:

- 2 Sec. 5. Illinois Emergency Management Agency.
- 3 (a) There is created within the executive branch of the
- 4 State Government an Illinois Emergency Management Agency and
- 5 a Director of the Illinois Emergency Management Agency,
- 6 herein called the "Director" who shall be the head thereof.
- 7 The Director shall be appointed by the Governor, with the
- 8 advice and consent of the Senate, and shall serve for a term

- (2.5) Cooperate with the Department of Nuclear Safety in development of the comprehensive emergency preparedness and response plan for any nuclear accident in accordance with Section 2005-65 of the Department of Nuclear Safety Law of the Civil Administrative Code of Illinois and in development of the Illinois Nuclear Safety Preparedness program in accordance with Section 8 of the Illinois Nuclear Safety Preparedness Act.
- (3) Prepare, for issuance by the Governor, executive orders, proclamations, and regulations as necessary or appropriate in coping with disasters.
- (4) Promulgate rules and requirements for political subdivision emergency operations plans that are not inconsistent with and are at least as stringent as applicable federal laws and regulations.
- (5) Review and approve, in accordance with Illinois Emergency Management Agency rules, emergency operations plans for those political subdivisions required to have an emergency services and disaster agency pursuant to this Act.
- (5.5) Promulgate rules and requirements for the political subdivision emergency management exercises, including, but not limited to, exercises of the emergency operations plans.
- (5.10) Review, evaluate, and approve, in accordance with Illinois Emergency Management Agency rules, political subdivision emergency management exercises for those political subdivisions required to have an emergency services and disaster agency pursuant to this

- (6) Determine requirements of the State and its political subdivisions for food, clothing, and other 3 4 necessities in event of a disaster.
 - (7) Establish a register of persons with types of emergency management training and skills in mitigation, preparedness, response, and recovery.
 - Establish a register of government and private response resources available for use in a disaster.
 - (9) Expand the Earthquake Awareness Program and its efforts to distribute earthquake preparedness materials to schools, political subdivisions, community groups, civic organizations, and the media. Emphasis will be placed on those areas of the State most at risk from an Maintain the list of all school districts, earthquake. hospitals, airports, power plants, including nuclear power plants, lakes, dams, emergency response facilities of all types, and all other major public or private structures which are at the greatest risk of damage from earthquakes under circumstances where the damage would cause subsequent harm to the surrounding communities and residents.
 - (10) Disseminate all information, completely and without delay, on water levels for rivers and streams and any other data pertaining to potential flooding supplied by the Division of Water Resources within the Department of Natural Resources to all political subdivisions to the maximum extent possible.
 - (11) Develop agreements, if feasible, with medical supply and equipment firms to supply resources as are necessary to respond to an earthquake or any other disaster as defined in this Act. These resources will be made available upon notifying the vendor of the disaster. Payment for the resources will be in accordance with

Section 7 of this Act. The Illinois Department of Public
Health shall determine which resources will be required
and requested.

- (11.5) In coordination with the Department of State

 Police, develop and implement a community outreach

 program to promote awareness among the State's parents

 and children of child abduction prevention and response.
- 8 (12) Out of funds appropriated for these purposes, 9 award capital and non-capital grants to hospitals or health care facilities located outside of a 10 11 city with a population in excess of 1,000,000 to be used 12 for purposes that include, but are not limited to, 13 preparing to respond to mass casualties and disasters, maintaining and improving patient safety and quality of 14 care, and protecting the confidentiality of patient 15 16 information.
