AN ACT in relation to executive agency reorganization.

2 Be it enacted by the People of the State of Illinois, 3 represented in the General Assembly:

4 Section 5. If and only if Executive Order No. 2004-6 5 becomes effective in accordance with Section 11 of Article V of 6 the Illinois Constitution, then the Civil Administrative Code 7 of Illinois is amended by adding Section 5-710 as follows:

Sec. 5-710. Executive Order provision superseded.

10 <u>(a) Executive Order No. 2004-6 creates the Department of</u> 11 <u>Financial and Professional Regulation and, in subdivision</u> 12 <u>I(B), provides in part: "The new agency shall have an officer</u> 13 <u>as its head known as the Secretary who shall be responsible for</u> 14 <u>all agency functions. Appointment to this office shall be made</u> 15 <u>by the Governor, by and with the advice and consent of the</u> 16 <u>Senate.".</u>

17 (b) Executive Order No. 2004-6, in subdivision I(C), 18 provides in part: "None of the four Directors, nor any such 19 assistants or deputies, shall be state officers subject to 20 Senate confirmation.".

(c) The sentence of subdivision I(C) of Executive Order 21 22 2004-6 that is quoted in subsection (b), to the extent that it exempts the appointments of the 4 Directors of the Department 23 of Financial and Professional Regulation from 24 Senate confirmation, is superseded by subsection (d) of this Section 25 26 and is of no force or effect as to the appointment of the 4 Directors of the Department of Financial and Professional 27 28 Regulation.

29 (d) In addition to appointments to the Office of Secretary 30 of Financial and Professional Regulation, appointments to the 4 31 Offices of Director of Financial and Professional Regulation 32 must each be made by the Governor, by and with the advice and HB0966 Enrolled - 2 - LRB093 05744 RCE 05837 b
