- 2 Be it enacted by the People of the State of Illinois,
- 3 represented in the General Assembly:
- 4 Section 5. The Public Utilities Act is amended by
- 5 changing Section 5-109 as follows:
- 6 (220 ILCS 5/5-109) (from Ch. 111 2/3, par. 5-109)
- 7 Sec. 5-109. Each public utility in the State, other than
- 8 <u>a commercial mobile radio service provider</u>, shall each year

- When any report is erroneous or defective or appears to
- 30 the Commission to be erroneous or defective, the Commission

- 3 employees, and books, records, accounts, vouchers, plant,
- 4 equipment and property of such public utility, and correct
