AN ACT concerning municipalities.

Be it enacted by the People of the State of Illinois,represented in the General Assembly:

Section 5. The Illinois Municipal Code is amended by
changing Section 2-3-5 as follows:

6 (65 ILCS 5/2-3-5) (from Ch. 24, par. 2-3-5)

Sec. 2-3-5. Whenever in any county of less than 150,000 7 8 population as determined by the last preceding federal census, any area of contiguous territory, not exceeding 2 9 square miles, not already included within the corporate 10 limits of any municipality, has residing thereon at least 200 11 inhabitants living in dwellings other than those designed to 12 13 be mobile, and is owned by at least 30 different owners, it may be incorporated as a village as follows: 14

15 35 electors residing within the area may file with the 16 circuit clerk of the county in which such area is situated a 17 petition addressed to the circuit court for that county.

The petition shall set forth (1) a definite description of the lands intended to be embraced in the proposed village, (2) the number of inhabitants residing therein, (3) the name of the proposed village, and (4) a prayer that a question be submitted to the electors residing within the limits of the proposed village whether they will incorporate as a village under this Code.

If the area contains fewer than 7,500 residents and lies within 1 1/2 miles of the boundary line of any existing municipality, the consent of the existing municipality must be obtained before the area may be incorporated. No area in a county with a population of 150,000 or more that is incorporating under the provisions of this Section shall need to obtain the consent of any existing municipality before the 1 area may be incorporated.

2 In addition, any contiguous territory in a county of 150,000 or more population which otherwise meets 3 the 4 requirements of this Section may be incorporated as a village 5 pursuant to the provisions of this Section if (1) any part of 6 such territory is situated within 10 miles of a county with a 7 population less than 150,000 and a petition is filed pursuant to this Section before January 1, 1991 or (2) any part of the 8 9 territory is situated within 25 miles of the Illinois state line in a county having a population, according to the 1990 10 11 federal decennial census, of at least 150,000 but less than 185,000 and a petition is filed pursuant to this Section 12 before January 1, 1998. 13

In addition, contiguous territory not exceeding 2 square 14 15 miles in a county with a population of not less than 300,000 16 and not more than 350,000 that otherwise meets the requirements of this Section may be incorporated as a village 17 pursuant to the provisions of this Section if (1) any part of 18 19 the territory is situated within 2 miles of a county with a population of less than 150,000 and (2) a petition is filed 20 21 in the manner provided in this Section before July 1, 2004 22 2001. The requirements of Section 2-3-18 concerning 23 compatibility with the official plan for development of the county shall not apply to any territory seeking incorporation 24 25 under this paragraph.
