- 3 represented in the General Assembly:
- 4 Section 5. The Title Insurance Act is amended by
- 5 changing Section 15 as follows:
- 6 (215 ILCS 155/15) (from Ch. 73, par. 1415)
- 7 Sec. 15. <u>Transacting business in other jurisdcitions.</u>
- 8 (a) Whenever the existing or future laws of any state or 9 country shall require of title insurance companies incorporated or organized under the laws of this State, as 10 condition precedent to their transacting in such other state 11 or country the business of guaranteeing or insuring titles to 12 13 real estate, compliance with laws, rules, regulations or prohibitions more onerous or burdensome than those imposed 14 15 under this Act by this State on foreign title insurance 16 companies transacting such business in this State, or shall require any deposit of securities or other obligations in 17 18 such state or country for the protection of policyholders, or otherwise, in excess of the amounts required of foreign title 19 20 insurance companies by this Act, or shall require of Illinois title insurance companies doing such business in such state 21 22 or country, the payment of penalties, fees, charges or taxes greater than the aggregate for like purposes imposed by the 23 this State upon such foreign title 24 laws of insurance companies, then such rules, regulations, and 25 laws, 26 prohibitions of said other state or country shall apply to 27 title insurance companies incorporated or organized under the laws of such state or country doing business in this State, 28 29 and all such companies, doing business in this State, shall be required to make deposits with the Department, and to pay 30 31 to the Department penalties, fees, charges, and taxes at

- least in amounts equal to those required in the aggregate for
- 2 like purpose of Illinois companies doing such business in
- 3 such state or country.
- 4 (b) The terms "penalties", "fees", "charges", and
- 5 <u>"taxes" in subsection (a) of this Section shall include: the</u>
- 6 penalties, fees, charges, and taxes collected under State law
- 7 and referenced within this Act; the Illinois corporate income
- 8 taxes imposed under subsections (a) through (d) of Section
- 9 <u>201 of the Illinois Income Tax Act; income or personal</u>
- 10 property taxes imposed by other states or countries;
- 11 penalties, fees, charges, and taxes of other states or
- 12 <u>countries imposed for purposes like those of the penalties,</u>
- 13 fees, charges, and taxes specified in this Act; and any
- 14 penalties, fees, charges, and taxes required as a franchise,
- 15 privilege, or licensing tax for conducting the business of
- insurance whether calculated as a percentage of income, gross
- 17 <u>receipts, premium, or otherwise.</u>
