The Southern Illinois University Management 4 Act is amended by changing Section 4 as follows: 5 (110 ILCS 520/4) (from Ch. 144, par. 654) 6 7 Sec. 4. Members of the Board shall serve without compensation but shall be entitled to reasonable amounts for 8 expenses necessarily incurred in the performance of their 9 duties. Such expenses incurred by any non-voting student member 10 may, at the discretion of the Chairman of the Board, be 11 provided for by advance payment to such member, who shall 12 account therefor to the Board immediately after each meeting. 13 14 No member of the Board shall hold or be employed in or appointed to any office or place under the authority of the 15 16 Board, nor shall any member of the Board be directly or 17 indirectly interested in any contract made by the Board, nor 18 shall he be an employee of the State or Federal Government. This section does not prohibit the student members of the Board 19

from maintaining normal and official status as enrolled

Section 15. The Chicago State University Law is amended by changing Section 5-20 as follows:

### 3 (110 ILCS 660/5-20)

Sec. 5-20. Reimbursement; employment limitations. Members of the Board shall serve without compensation but shall be entitled to reasonable amounts for expenses necessarily incurred in the performance of their duties. Such expenses incurred by the student member may, at the discretion of the Chairman of the Board, be provided for by advance payment to the student member, who shall account therefor to the Board immediately after each meeting.

No member of the Board shall hold or be employed in or appointed to any office or place under the authority of the Board, nor shall any member of the Board be directly or indirectly interested in any contract made by the Board, nor shall he be an employee of the State or Federal Government; provided that nothing in this Section shall be deemed to prohibit the student member of the Board from maintaining normal and official status as an enrolled student or normal student employment at Chicago State University.

Sec. 10-20. Reimbursement; employment limitations. Such expenses incurred by the student member may, at the discretion of the Chairman of the Board, be provided for by advance payment to the student member, who shall account therefor to the Board

immediately after each meeting.

No member of the Board shall hold or be employed in or appointed to any office or place under the authority of the Board, nor shall any member of the Board be directly or indirectly interested in any contract made by the Board, nor shall he be an employee of the State or Federal Government; provided that nothing in this Section shall be deemed to prohibit the student member of the Board from maintaining normal and official status as an enrolled student or normal student employment at Eastern Illinois University.
