The Illinois Insurance Code is amended by 5 adding Section 356z.6 as follows: (215 ILCS 5/356z.6 new) 6 7 Sec. 356z.6. Vision therapy. (a) An individual or group policy of accident and health 8 insurance or managed care plan amended, delivered, issued, or 9 renewed in this State after the effective date of this 10 amendatory Act of the 93rd General Assembly, must include 11 coverage for vision therapy, therapeutic lenses, prisms, 12 filters, occlusions, and specialized equipment used in the 13 vision therapy treatment process. 14 (b) For the purposes of this Section, "vision therapy" 15 16 means a treatment process used to improve vision function. Vision therapy includes a broad range of developmental and 17 18 rehabilitative treatment programs individually prescribed to remediate specific sensory, motor, or visual perception 19 20 dysfunctions. Section 10. The Health Maintenance Organization Act is 21 amended by changing Section 4-6.5 as follows: 22
