Be it enacted by the People of the State of Illinois,represented in the General Assembly:

- Section 5. The State Finance Act is amended by adding

12 (a) The Secretary, upon receipt of all applicable fees
13 and applications made in the form prescribed by the
14 Secretary, may issue special registration plates designated
15 as American Cancer Society license plates.

16 The special plates issued under this Section shall be 17 affixed only to passenger vehicles of the first division or 18 motor vehicles of the second division weighing not more than 19 <u>8,000 pounds.</u>

20 <u>Plates issued under this Section shall expire according</u> 21 <u>to the multi-year procedure established by Section 3-414.1 of</u> 22 <u>this Code.</u>

(b) The design and color of the special plates shall be
 wholly within the discretion of the Secretary. Appropriate
 documentation, as determined by the Secretary, shall
 accompany each application.

5 For each registration renewal period, a \$27 fee, in 6 addition to the appropriate registration fee, shall be 7 charged. Of this fee, \$25 shall be deposited into the 8 Illinois American Cancer Society Fund and \$2 shall be 9 deposited into the Secretary of State Special License Plate 10 Fund.

11 (d) The Illinois American Cancer Society Fund is created 12 as a special fund in the State treasury. All moneys in the 13 Illinois American Cancer Society Fund shall be paid, subject 14 to appropriation by the General Assembly and approval by the 15 Secretary, as grants to the American Cancer Society for use 16 in its programs and services.

Section 99. Effective date. This Act takes effect uponbecoming law.
