- 20 "Taxing district" has the same meaning provided in

- 22 For the 1991 through 1994 levy years only, "taxing district"
- 23 includes only each non-home rule taxing district having the
- 24 majority of its 1990 equalized assessed value within any
- county or counties contiguous to a county with 3,000,000 or
- 26 more inhabitants. Beginning with the 1995 levy year, "taxing
- 27 district" includes only each non-home rule taxing district
- 28 subject to this Law before the 1995 levy year and each

"Aggregate extension" for taxing districts to which this 5 б Law applied before the 1995 levy year means the annual 7 corporate extension for the taxing district and those special 8 purpose extensions that are made annually for the taxing 9 district, excluding special purpose extensions: (a) made for the taxing district to pay interest or principal on general 10 11 obligation bonds that were approved by referendum; (b) made for any taxing district to pay interest or principal on 12 general obligation bonds issued before October 1, 1991; (c) 13 made for any taxing district to pay interest or principal 14 15 bonds issued to refund or continue to refund those bonds 16 issued before October 1, 1991; (d) made for any taxing district to pay interest or principal on bonds issued to 17 refund or continue to refund bonds issued after October 1, 18 19 1991 that were approved by referendum; (e) made for any taxing district to pay interest or principal on revenue bonds 20 issued before October 1, 1991 for payment of which a property 21 tax levy or the full faith and credit of the unit of local 22 23 government is pledged; however, a tax for the payment of interest or principal on those bonds shall be made only after 24 25 the governing body of the unit of local government finds that all other sources for payment are insufficient to make those 26 payments; (f) made for payments under a building commission 27 lease when the lease payments are for the retirement of bonds 28 29 issued by the commission before October 1, 1991, to pay 30 the building project; (g) made for payments due under installment contracts entered into before October 1, 1991; 31 (h) made for payments of principal and interest on bonds 32 issued under the Metropolitan Water Reclamation District Act 33 34 to finance construction projects initiated before October 1,

1 1991; (i) made for payments of principal and interest on 2 limited bonds, as defined in Section 3 of the Government Debt Reform Act, in an amount not to exceed the 3 4 debt service extension base less the amount in items (c), (e), and (h) of this definition for non-referendum 5 б obligations, except obligations initially issued pursuant to 7 referendum; (j) made for payments of principal and interest on bonds issued under Section 15 of the Local Government Debt 8 9 Reform Act; and (k) made by a school district participates in the Special Education District of Lake 10 11 County, created by special education joint agreement under Section 10-22.31 of the School Code, for payment of the 12 school district's share of the amounts required to 13 contributed by the Special Education District of Lake County 14 15 to the Illinois Municipal Retirement Fund under Article 7 of 16 the Illinois Pension Code; the amount of any extension under this item (k) shall be certified by the school district to 17 the county clerk. 18 19

"Aggregate extension" for the taxing districts to which this Law did not apply before the 1995 levy year (except taxing districts subject to this Law in accordance with Section 18-213) means the annual corporate extension for the taxing district and those special purpose extensions that are made annually for the taxing district, excluding special purpose extensions: (a) made for the taxing district to pay interest or principal on general obligation bonds that were approved by referendum; (b) made for any taxing district pay interest or principal on general obligation bonds issued before March 1, 1995; (c) made for any taxing district to pay interest or principal on bonds issued to refund or continue to refund those bonds issued before March 1, 1995; (d) made for any taxing district to pay interest or principal on bonds issued to refund or continue to refund bonds issued after March 1, 1995 that were approved by referendum; (e) made for

any taxing district to pay interest or principal on revenue

2 bonds issued before March 1, 1995 for payment of which a property tax levy or the full faith and credit of the unit of 3 4 local government is pledged; however, a tax for the payment of interest or principal on those bonds shall be made only 5 after the governing body of the unit of local government 6 7 finds that all other sources for payment are insufficient to make those payments; (f) made for payments under a building 8 9 commission lease when the lease payments are retirement of bonds issued by the commission before March 1, 10 11 1995 to pay for the building project; (g) made for payments due under installment contracts entered into before March 1, 12 13 1995; (h) made for payments of principal and interest on bonds issued under the Metropolitan 14 Water Reclamation 15 District Act to finance construction projects initiated 16 before October 1, 1991; (i) made for payments of principal and interest on limited bonds, as defined in Section 3 of the 17 Local Government Debt Reform Act, in an amount not to exceed 18 19 the debt service extension base less the amount in items (b), this definition for non-referendum 20 (c), and (e) of 21 obligations, except obligations initially issued pursuant to 22 referendum and bonds described in subsection (h) of this 23 definition; (j) made for payments of principal and interest on bonds issued under Section 15 of the Local Government Debt 24 25 Reform Act; (k) made for payments of principal and interest on bonds authorized by Public Act 88-503 and issued under 26 Section 20a of the Chicago Park District Act for aquarium or 27 museum projects; (1) made for payments of principal and 28 interest on bonds authorized by Public Act 87-1191 and issued 29 30 under Section 42 of the Cook County Forest Preserve District Act for zoological park projects; and (m) made pursuant to 31 32 Section 34-53.5 of the School Code, whether levied annually 33 or not. "Aggregate extension" for all taxing districts to which 34

1 applies in accordance with Section 18-213, except 2 for those taxing districts subject to paragraph (2) of subsection (e) of Section 18-213, means the annual corporate 3 4 extension for the taxing district and those special purpose 5 extensions that are made annually for the taxing district, б excluding special purpose extensions: (a) made for the taxing 7 district to pay interest or principal on general obligation 8 bonds that were approved by referendum; (b) made for any 9 taxing district to pay interest or principal on general obligation bonds issued before the date on which the 10 11 referendum making this Law applicable to the taxing district 12 is held; (c) made for any taxing district to pay interest or principal on bonds issued to refund or continue to refund 13 those bonds issued before the date on which the referendum 14 making this Law applicable to the taxing district is held; 15 16 (d) made for any taxing district to pay interest or principal on bonds issued to refund or continue to refund bonds issued 17 after the date on which the referendum making this Law 18 applicable to the taxing district is held if the bonds were 19 approved by referendum after the date on which the referendum 20 21 making this Law applicable to the taxing district is held; (e) made for any taxing district to pay interest or principal 22 23 on revenue bonds issued before the date on which referendum making this Law applicable to the taxing district 24 25 is held for payment of which a property tax levy or the full faith and credit of the unit of local government is pledged; 26 however, a tax for the payment of interest 27 or principal those bonds shall be made only after the governing body of 28 the unit of local government finds that all other sources for 29 30 payment are insufficient to make those payments; (f) made for payments under a building commission lease when the lease 31 32 payments are for the retirement of bonds issued by the commission before the date on which the referendum making 33 34 this Law applicable to the taxing district is held to pay for

"Aggregate extension" for all taxing districts to which this Law applies in accordance with paragraph (2) subsection (e) of Section 18-213 means the annual corporate extension for the taxing district and those special purpose extensions that are made annually for the taxing district, excluding special purpose extensions: (a) made for the taxing district to pay interest or principal on general obligation bonds that were approved by referendum; (b) made for any taxing district to pay interest or principal on general obligation bonds issued before the effective date of this amendatory Act of 1997; (c) made for any taxing district to pay interest or principal on bonds issued to refund or continue to refund those bonds issued before the effective date of this amendatory Act of 1997; (d) made for any taxing district to pay interest or principal on bonds issued to refund or continue to refund bonds issued after the effective

1 this amendatory Act of 1997 if the bonds were 2 approved by referendum after the effective date of this amendatory Act of 1997; (e) made for any taxing district to 3 4 pay interest or principal on revenue bonds issued before the 5 effective date of this amendatory Act of 1997 for payment of which a property tax levy or the full faith and credit of the 6 7 unit of local government is pledged; however, a tax for the 8 payment of interest or principal on those bonds shall be made 9 only after the governing body of the unit of local government finds that all other sources for payment are insufficient to 10 11 make those payments; (f) made for payments under a building lease when the lease payments are 12 commission for the retirement of bonds issued by the commission before 13 the effective date of this amendatory Act of 1997 to pay for the 14 building project; (g) made for payments due under installment 15 16 contracts entered into before the effective date of this amendatory Act of 1997; (h) made for payments of principal 17 and interest on limited bonds, as defined in Section 3 of the 18 19 Local Government Debt Reform Act, in an amount not to exceed the debt service extension base less the amount in items (b), 20 this definition for non-referendum 21 (c), and (e) of 22 obligations, except obligations initially issued pursuant to 23 (i) made for payments of principal and interest on bonds issued under Section 15 of the Local Government Debt 24 25 Reform Act; and (j) made for a qualified airport authority to pay interest or principal on general obligation bonds issued 26 for the purpose of paying obligations due under, or financing 27 airport facilities required to be acquired, constructed, 28 29 installed or equipped pursuant to, contracts entered into 30 before March 1, 1996 (but not including any amendments to such a contract taking effect on or after that date). 31

"Debt service extension base" means an amount equal to that portion of the extension for a taxing district for the levy year, or for those taxing districts subject to this

1 Law in accordance with Section 18-213, except for those 2 subject to paragraph (2) of subsection (e) of Section 18-213, for the levy year in which the referendum making this Law 3 4 applicable to the taxing district is held, or for those 5 taxing districts subject to this Law in accordance with paragraph (2) of subsection (e) of Section 18-213 for the 6 7 1996 levy year, constituting an extension for payment of principal and interest on bonds issued by the taxing district 8 9 without referendum, but not including (i) bonds authorized by Public Act 88-503 and issued under Section 20a of the Chicago 10 11 Park District Act for aquarium and museum projects; (ii) bonds issued under Section 15 of the Local Government Debt 12 Reform Act; or (iii) refunding obligations issued to refund 13 to continue to refund obligations initially issued 14 pursuant to referendum. contributions to pension plans, and extensions made pursuant to Section 6-601 of the Illinois Highway Code for a road district's permanent road fund whether levied annually or not. The extension for a special service area is not included in the aggregate extension.

25 "Aggregate extension base" means the taxing district's 26 last preceding aggregate extension as adjusted under Sections 27 18-215 through 18-230.

28 "Levy year" has the same meaning as "year" under Section 29 1-155.

"New property" means (i) the assessed value, after final board of review or board of appeals action, of new improvements or additions to existing improvements on any parcel of real property that increase the assessed value of that real property during the levy year multiplied by the

1 equalization factor issued by the Department under Section 2 17-30, and (ii) the assessed value, after final board of review or board of appeals action, of real property not 3 4 exempt from real estate taxation, which real property was 5 exempt from real estate taxation for any portion of the б immediately preceding levy year, multiplied by the 7 equalization factor issued by the Department under Section 8 17-30, and (iii) in counties that classify in accordance with 9 Section 4 of Article IX of the Illinois Constitution, an 10 incentive property's additional assessed value resulting from 11 a scheduled increase in the level of assessment as applied to the first year final board of review market value. 12 county clerk in a county containing a 13 addition, the population of 3,000,000 or more shall include in the 1997 14 15 recovered tax increment value for any school district, any 16 recovered tax increment value that was applicable to the 1995 tax year calculations. 17 "Qualified airport authority" means an airport authority 18 19 organized under the Airport Authorities Act and located in a county bordering on the State of Wisconsin and having a 20 population in excess of 200,000 and not greater than 500,000. 21 22 "Recovered tax increment value" means, except as 23 otherwise provided in this paragraph, the amount of the current year's equalized assessed value, in the first year 24 25 after a municipality terminates the designation of an area as a redevelopment project area previously established under the 26 Tax Increment Allocation Development Act in the 27 Illinois Municipal Code, previously established under the Industrial 28 29 Jobs Recovery Law in the Illinois Municipal Code, 30 previously established under the Economic Development Area Tax Increment Allocation Act, of each taxable lot, block, 31 32 tract, or parcel of real property in the redevelopment project area over and above the initial equalized assessed 33

value of each property in the redevelopment project area. For

1 the taxes which are extended for the 1997 levy year, the 2 recovered tax increment value for a non-home rule taxing district that first became subject to this Law for the 1995 3 4 levy year because a majority of its 1994 equalized assessed 5 value was in an affected county or counties shall be 6 increased if a municipality terminated the designation of an 7 area in 1993 as a redevelopment project area previously 8 established under the Tax Increment Allocation Development 9 Act in the Illinois Municipal Code, previously established under the Industrial Jobs Recovery Law in the Illinois 10 11 Municipal Code, or previously established under the Economic Development Area Tax Increment Allocation Act, by an amount 12 equal to the 1994 equalized assessed value of each taxable 13 block, tract, or parcel of real property in 14 15 redevelopment project area over and above the initial 16 equalized assessed value of each property redevelopment project area.
