- 4 Section 5. The State Finance Act is amended by adding
- 5 Section 5.595 as follows:
- 6 (30 ILCS 105/5.595 new)
- 7 Sec. 5.595. The Illinois Professional Golfers
- 8 <u>Association Foundation Junior Golf Fund.</u>
- 9 Section 10. The Illinois Vehicle Code is amended by
- 10 adding Section 3-663 as follows:
- 11 (625 ILCS 5/3-663 new)
- 12 <u>Sec. 3-663. Illinois Professional Golfers Association</u>
- 13 <u>Foundation Junior Golf license plates.</u>
- 14 <u>(a) The Secretary, upon receipt of all applicable fees</u>
- 15 and applications made in the form prescribed by the
- 16 <u>Secretary, may issue special registration plates designated</u>
- 17 <u>as Illinois Professional Golfers Association Foundation</u>
- 18 <u>Junior Golf license plates.</u>
- 19 The special plates issued under this Section shall be
- 20 <u>affixed only to passenger vehicles of the first division or</u>
- 21 <u>motor vehicles of the second division weighing not more than</u>
- 8,000 pounds.
- 23 <u>Plates issued under this Section shall expire according</u>
- 24 <u>to the multi-year procedure established by Section 3-414.1 of</u>
- this Code.
- 26 (b) The design and color of the special plates shall be
- 27 <u>wholly within the discretion of the Secretary. Appropriate</u>

- 1 (c) An applicant for the special plate shall be charged
