- 1 AN ACT in relation to criminal law.
- 2 Be it enacted by the People of the State of Illinois,
- 3 represented in the General Assembly:
- 4 Section 5. The Criminal Code of 1961 is amended by
- 5 adding Section 24-1.7 as follows:
- 6 (720 ILCS 5/24-1.7 new)
- 7 <u>Sec. 24-1.7. Manufacture, possession and delivery of</u>
- 8 large capacity ammunition feeding devices.
- 9 <u>(a) As used in this Section:</u>
- 10 <u>"Large capacity ammunition feeding device" means:</u>
- 11 (1) a magazine, belt, drum, feed strip, or similar
- 12 <u>device that has a capacity of, or that can be readily</u>
- 13 restored or converted to accept, more than 10 rounds of
- 14 <u>ammunition; or</u>
- 15 (2) any combination of parts from which a device
- described in paragraph (1) can be assembled.
- 17 <u>"Large capacity ammunition feeding device" does not</u>
- 18 <u>include an attached tubular device designed to accept, and</u>
- 19 <u>capable of operating only with, .22 caliber rimfire</u>
- 20 <u>ammunition or any device that has been made permanently</u>
- 21 <u>inoperable</u>.
- (b) Except as provided in subsection (c), it is unlawful
- for any person within this State, beginning 90 days after the
- 24 <u>effective date of this amendatory Act of the 93rd General</u>
- 25 Assembly, to knowingly manufacture, deliver, or possess or
- 26 <u>cause to be manufactured, delivered, or possessed, a large</u>
- 27 <u>capacity ammunition feeding device.</u>
- (c) Any person who knowingly possesses a large capacity
- 29 <u>ammunition feeding device on the effective date of this</u>
- 30 <u>amendatory Act of the 93rd General Assembly must</u>, within 90
- 31 days after the effective date of this amendatory Act of the

- 1 93rd General Assembly, destroy the device, render it
- 2 permanently inoperable, relinquish it to a law enforcement
- 3 <u>agency</u>, or remove it from this State.
- 4 (d) A person has an affirmative defense to an alleged
- 5 <u>violation of subsection (c) of this Section if he or she</u>
- 6 <u>lawfully possessed or delivered the large capacity ammunition</u>
- 7 <u>feeding device while in the performance of his or her</u>
- 8 <u>official duties as a peace officer, correctional institution</u>
- 9 <u>employee or official, or member of the Armed Services or</u>
- 10 Reserve Forces of the United States or of the Illinois
- 11 National Guard.
- (e) Sentence. A person who possesses or delivers in
- violation of this Section a large capacity ammunition feeding
- 14 <u>device capable of holding more than 17 rounds of ammunition</u>
- 15 <u>commits a Class 3 felony for a first violation and a Class 2</u>
- 16 <u>felony for a second or subsequent violation or for possession</u>
- or delivery of 2 or more of these devices at the same time.
- 18 A person who possesses or delivers in violation of this
- 19 <u>Section a large capacity ammunition feeding device capable of</u>
- 20 <u>holding more than 10 rounds but not more than 17 rounds of</u>
- 21 <u>ammunition commits a Class 4 felony for a first violation and</u>
- 22 <u>a Class 3 felony for a second or subsequent violation or for</u>
- 23 <u>possession or delivery of more than one of these devices at</u>
- 24 the same time.
