Be it enacted by the People of the State of Illinois, represented in the General Assembly:

ARTICLE 1

Section 5. Section 15. The sum of \$1,000,000, or so much thereof as may be necessary, is appropriated from the General Revenue Fund to the Illinois Arts Council for the purpose of funding administrative and grant expenses associated with humanities programs and related activities.

Section 20. The amount of \$380,000, or so much thereof as may be necessary, is appropriated from the General Revenue Fund to the Illinois Arts Council for grants to certain public radio and television stations for operating costs.

23 Section 25. The amount of \$4,904,200, or so much thereof as may be necessary is appropriated from the General Revenue 24 Fund to the Illinois Arts Council for grants to certain 25 public radio and television stations and 26 related administrative expenses, pursuant to the Public Radio and 27 28 Television Grant Act.

Section 99. Effective date. This Act takes effect on July 1,2004.
