14 Sec. 3. (a) Except as provided in subsection (b), the The 15 purchaser shall agree that the land described in Section 1 16 shall be used for public educational and recreational purposes, 17 but may convey any part of that land to the board of a public 18 junior college district which includes any part of Kane County 19 in its territory at a purchase price computed on the basis of a price per acre which does not exceed that authorized by this 20 21 Act for the conveyance to the City of Elgin. Such an agreement does not prevent the City of Elgin from selling or leasing, 22 under the conditions and in the manner provided in Division 76 23 of Article 11 of the Illinois Municipal Code, any part of that 24

1 land not so conveyed.
