1 AMENDMENT TO HOUSE BILL 870

2 AMENDMENT NO. \_\_\_\_\_. Amend House Bill 870 by replacing  
3 everything after the enacting clause with the following:

4 "Section 5. The Code of Civil Procedure is amended by  
5 adding Sections 7-103.113 and 7-103.114 as follows:

6 (735 ILCS 5/7-103.113 new)

7 Sec. 7-103.113. Quick-take; Dewitt County. Quick-take  
8 proceedings under Section 7-103 may be used for a period of 12  
9 months after the effective date of this amendatory Act of the  
10 94th General Assembly for road improvement purposes for the  
11 acquisition of the following described real property:

12 PARCEL 1

13 A part of the Southeast Quarter of Section 35, Township 19  
14 North, Range 3 East of the Third Principal Meridian,  
15 described as follows:
