AN ACT concerning housing.

2 Be it enacted by the People of the State of Illinois, 3 represented in the General Assembly:

Section 5. The Affordable Housing Planning and Appeal Act
is amended by changing Section 20 as follows:

Sec. 20. Determination of exempt local governments.

(a) Beginning October 1, 2004, the the Illinois Housing 8 Development Authority shall determine which local governments 9 are exempt and not exempt from the operation of this Act based 10 on an identification of the total number of year-round housing 11 units in the most recent decennial census for each local 12 government within the State and by an inventory of for-sale and 13 14 rental affordable housing units, as defined in this Act, for 15 each local government from the decennial census and other relevant sources. 16

17 (b) The Illinois Housing Development Authority shall make18 this determination by:

(i) totaling the number of for-sale housing units in each local government that are affordable to households with a gross household income that is less than 80% of the median household income within the county or primary metropolitan statistical area;

(ii) totaling the number of rental units in each local
government that are affordable to households with a gross
household income that is less than 60% of the median
household income within the county or primary metropolitan
statistical area;

(iii) adding the number of for-sale and rental units
for each local government from items (i) and (ii); and

(iv) dividing the sum of (iii) above by the total
 number of year-round housing units in the local government

1 as contained in the latest decennial census and multiplying 2 the result by 100 to determine the percentage of affordable 3 housing units within the jurisdiction of the local 4 government.

2004, the Illinois Housing 5 (c) Beginning October 1, 6 Development Authority shall publish on an annual basis a list 7 of exempt and non-exempt local governments and the data that it 8 used to calculate its determination. The data shall be shown 9 for each local government in the State and for the State as a 10 whole. Upon publishing a list of exempt and non-exempt local 11 governments, the Illinois Housing Development Authority shall 12 notify a local government that it is not exempt from the operation of this Act and provide to it the data used to 13 calculate its determination. 14

(d) A local government or developer of affordable housing may appeal the determination of the Illinois Housing Development Authority as to whether the local government is exempt or non-exempt under this Act in connection with an appeal under Section 30 of this Act.
