2 **Be it enacted by the People of the State of Illinois, represented**
3 **in the General Assembly:**

1 Section 30. The sum of \$52,000, or so much thereof as
2 may be necessary, is appropriated to the Supreme Court for
3 the contingent expenses of the Illinois Courts Commission.

4 Section 35. The sum of \$12,792,000, or so much thereof
5 as may be necessary, is appropriated from the Mandatory
6 Arbitration Fund to the Supreme Court for Mandatory
7 Arbitration Programs.

8 Section 40. The sum of \$116,800, or so much thereof as
9 may be necessary, is appropriated from the Foreign Language
10 Interpreter Fund to the Supreme Court for the Foreign
11 Language Interpreter Program.

12 Section 45. The sum of \$728,000, or so much thereof as
13 may be necessary, is appropriated from the Lawyers'
14 Assistance Program Fund to the Supreme Court for lawyers'
15 assistance programs.

16 Section 50. The sum of \$500,000, or so much thereof as
17 may be necessary, is appropriated from the Reviewing Court
18 Alternative Dispute Resolution Fund to the Supreme Court for
19 alternative dispute resolution programs within the reviewing
20 courts.

21 Section 99. Effective date. This Act takes effect July 1,
22 2005.
