- WHEREAS, The members of the House of Representatives of the 2 3 State of Illinois learned with sadness of the death of William 4 J. Curley of Hazel Crest, formerly of Riverdale, on Monday, February 14, 2005; and
- WHEREAS, He was born on February 24, 1908, in Chicago; he 6 7 was the fifth of eight children born to Michael and Margaret

(nee Salmon) Curley, both of whom were immigrants from Ireland;

- WHEREAS, Mr. Curley was a good citizen, a hard working family man who was able to achieve the American dream through honesty, persistence, and determination; a teenager during the Great Depression, he left school and went to work after the death of his father in order to help support his mother and younger siblings; in 1939 he took a job with the Internal Revenue Service after passing the federal government's civil service entrance exam; and
 - WHEREAS, Though he only had two years of formal high school education, Mr. Curley never gave up on continuing his education; while working full time at the IRS, he completed law school and achieved his goal of becoming a CPA (Certified Public Accountant); he retired from the Internal Revenue Service in 1970, after 31 years of service, with the title Appellate Conferee; and
- WHEREAS, Mr. Curley and his wife, Alice Lillian, raised seven children; education and religion were priorities in their home; devout Roman Catholics, Mr. and Mrs. Curley managed to give their children a parochial school education; all seven graduated from high school, and three went on to graduate from college; a devoted grandfather, Mr. Curley did his best to acknowledge every birthday of his 18 grandchildren and 13

- 2 family lunch attended by his children, and open to any extended
- 3 family member that could make it; and
- WHEREAS, He was a man of unquestionable integrity, a kind, benevolent, loving man who for all of his almost 97 years was an example of selfless devotion to his children and grandchildren; he lived his life by being true to the things he
- 8 valued most: his faith, his family, and his work; and
