1 AMENDMENT TO HOUSE BILL 4149

2 AMENDMENT NO. \_\_\_\_\_. Amend House Bill 4149, on page 1, below  
3 line 12, by inserting the following:

4 "Section 20. In addition to all other amounts  
5 appropriated for this purpose, the amount of \$7,172,100, or  
6 so much thereof as maybe necessary, is appropriated from the  
7 General Revenue Fund to the Department of Corrections for  
8 expenses related to Personal Services for frontline staff.

9 Section 25. In addition to all other amounts  
10 appropriated for this purpose, the amount of \$1,302,200, or  
11 so much thereof as may be necessary, is appropriated from the  
12 General Revenue Fund to the Department of Corrections for  
13 expenses related to the cost of Retirement Contributions for  
14 frontline staff.

1           Section 30. In addition to all other amounts appropriated  
2           for this purpose, the amount of \$548,100, or so much thereof  
3           as may be necessary, is appropriated from the General Revenue  
4           Fund to the Department of Corrections for expenses related to  
5           the cost of Social Security Contributions for frontline  
6           staff.

7           Section 35. In addition to all other amounts  
8           appropriated for this purpose, the amount of \$1,793,300, or  
9           so much thereof as may be necessary, is appropriated from the  
10          General Revenue Fund to the Department of Human Services for  
11          expenses related to Personal Services in the Division of  
12          Human Capital Development for frontline staff.

13          Section 40. In addition to all other amounts  
14          appropriated for this purpose, the amount of \$297,700, or so  
15          much thereof as may be necessary, is appropriated from the  
16          General Revenue Fund to the Department of Human Services for  
17          expenses related to the cost of Retirement Contributions in  
18          the Division of Human Capital Development for frontline  
19          staff.

20          Section 45. In addition to all other amounts  
21          appropriated for this purpose, the amount of \$137,200, or so

1 much thereof as may be necessary, is appropriated from the  
2 General Revenue Fund to the Department of Human Services for  
3 expenses related to Social Security Contributions in the  
4 Division of Human Capital Development for frontline staff.

5 Section 50. In addition to all other amounts  
6 appropriated for this purpose, the amount of \$4,360,600, or  
7 so much thereof as may be necessary, is appropriated from the  
8 General Revenue Fund to the Department of Human Services for  
9 expenses related to Personal Services in state operated  
10 facilities for frontline staff.

11 Section 55. In addition to all other amounts  
12 appropriated for this purpose, the amount of \$724,200, or so  
13 much thereof as may be necessary, is appropriated from the  
14 General Revenue Fund to the Department of Human Services for  
15 expenses related to the cost of Retirement Contributions in  
16 state operated facilities for frontline staff.

17 Section 60. In addition to all other amounts  
18 appropriated for this purpose, the amount of \$333,700, or so  
19 much thereof as may be necessary, is appropriated from the  
20 General Revenue Fund to the Department of Human Services for  
21 expenses related to Social Security Contribution in state  
22 operated facilities for frontline staff.

1           Section 65.       In addition to all other amounts  
2       appropriated for this purpose, the amount of \$1,769,900, or  
3       so much thereof as maybe necessary, is appropriated from the  
4       General Revenue Fund to the Department of Juvenile Justice  
5       for expenses related to Personal Services for frontline  
6       staff.

7           Section 70.       In addition to all other amounts  
8       appropriated for this purpose, the amount of \$323,300, or so  
9       much thereof as may be necessary, is appropriated from the  
10      General Revenue Fund to the Department of Juvenile Justice  
11      for expenses related to the cost of Retirement Contributions  
12      for frontline staff.

13          Section 75. In addition to all other amounts appropriated  
14      for this purpose, the amount of \$135,400, or so much thereof  
15      as may be necessary, is appropriated from the General Revenue  
16      Fund to the Department of Juvenile Justice for expenses  
17      related to the cost of Social Security Contributions for  
18      frontline staff.

19          Section 99. This Act takes effect upon becoming law."
